This service agreement originates on **Thursday, June 8, 2023** between **MID-AMERICA TECHNOLOGY CENTER**, location specified above, and Hayes 405 Refreshments who distribute beverages, coffee, confections, fresh foods, ice cream, pastries, snacks, and other food items referred to as products.

Hayes 405 Refreshments desires to obtain the right to distribute said products when scheduled and the right to enter **MID-AMERICA TECHNOLOGY CENTER'S** premises to install equipment and perform service.

THEREFORE, the parties agree as follows:

SERVICE

Hayes 405 Refreshments will provide neatly uniformed personnel to install, maintain, clean service equipment containing said products upon **MID-AMERICA TECHNOLOGY CENTER'S** premises while complying with all federal, state, county and city laws and regulations pertaining to installation and the sanitary handling of equipment and products. Hayes 405 Refreshments will perform in a commercially reasonable manner and maintain an accurate record of all products, collections, sales, and inventories necessary in connection with the operation.

EQUIPMENT

The equipment installed will be placed only in locations subject to the mutual agreement of parties and always remain the property of Hayes 405 Refreshments. **MID-AMERICA TECHNOLOGY CENTER** will furnish the necessary space for the proper servicing of units and required utilities, connections, or network requirements for equipment operation. **MID-AMERICA TECHNOLOGY CENTER** will notify in a timely manner Hayes 405 Refreshments to resolve any issue with products, service, or equipment malfunctions.

FINANCIAL TERM

Hayes 405 Refreshments and **MID-AMERICA TECHNOLOGY CENTER** understand that the scope of service, equipment, and other terms provided in this agreement are based on employment part-time and full-time, at the **MID-AMERICA TECHNOLOGY CENTER'S** facility and will continue at approximately current levels. Hayes 405 Refreshments may renegotiate or terminate the agreement if the operations hereunder become unprofitable, due to product cost increases, increases, or licenses levied or assessed in the sale or purchase of products. The commission schedule or prices will adjust to reflect such changes without otherwise affecting this agreement. Hayes 405 Refreshments will pay all license fees, sales tax and other taxes required.

INSURANCE

Hayes 405 Refreshments will carry Workers' Compensation insurance in compliance with Oklahoma state laws, public liability, property damage and product liability insurance. Hayes 405 Refreshments agrees to provide a certificate of insurance if requested.

TERM

This agreement is for a one-year period from the date of execution.

CANCELLATION


*RESOLUTION CLAUSE: Hayes 405 Refreshments will have thirty days to resolve any operational issues with products, service, or equipment upon receipt of written notice by **MID-AMERICA TECHNOLOGY CENTER** to fulfill terms in this agreement.*

MID-AMERICA TECHNOLOGY CENTER may terminate this agreement if Hayes 405 Refreshments fails to provide quality said products or service in keeping with the industry standards for a period of sixty days after receipt of written notice by **MID-AMERICA TECHNOLOGY CENTER** to comply with any term or condition of this agreement. Upon termination of this agreement, Hayes 405 Refreshments shall have the right to enter **MID-AMERICA TECHNOLOGY CENTER'S** premises to remove all equipment and products.


