Annual Renewal - Existing Contract, SPED Federal Funds

1) Angela Brand, Thera-Brand Physical Therapy, LLC Physical Therapy Services Agreement
Andrea Hutchings is an Occupational Therapist with ARH Therapy who provides Occupational Therapy for special education students across the district as mandated by the students' IEPs. These services include evaluations, consultations, meeting attendance, report writing, and supervision of COTAs. Cost is \$105,000.00. This contract is valid from July 1, 2026, through June 30, 2027.

Annual Renewal - Existing Contract, SPED Federal Funds

2) ARH Therapy Inc. Occupational Therapy Services Agreement
Andrea Hutchings is an Occupational Therapist with ARH Therapy who provides Occupational Therapy for special education students across the district as mandated by the students' IEPs. These services

include evaluations, consultations, meeting attendance, report writing, and supervision of COTAs. Cost is \$120,000.00. Contract is valid from July 1, 2026, through June 30, 2027.

Annual Renewal - Existing Contract, General Fund 018

3) Danielle Torres Psychology Services Agreement

Danielle Torres provides psychological evaluations, reports, and other related services for the purpose of special education services. Said services will be provided at the agreed-upon rate. Cost is \$110,000.00. This contract is valid from July 1, 2026, through June 30, 2027.

Annual Renewal - Existing Contract, General Fund

4) Evaluation Works, LLC Psychology Services Agreement

Evaluation Works, LLC provides psychological evaluations, reports, and other related services for the purpose of special education services. Said services will be provided at the agreed-upon rate. Cost is 90,000.00. This contract is valid from July 1, 2026, through June 30, 2027.

Annual Renewal - Existing Contract, General and SPED Federal Funds

5) Oklahoma State University Communications Sciences Speech Language Services Agreement

OSU Communications Department will provide speech-language services for the academic school year in accordance with the University calendar. They will provide eligibility and re-evaluation as needed, therapy service, and prepare special education paperwork. Cost is 50,000.00. This contract is valid from July 1, 2026, through June 30, 2027.

Annual Renewal - Existing Contract, SPED Federal Funds

6) Shannan Frohock Deaf and Hard of Hearing Services Agreement

Shannan Frohock is a certified teacher for the Deaf and Hard of Hearing. She develops and implements IEPs for all students in the district who have been identified as having Hearing Impairment or Deafness. She also manages audio equipment placed in classrooms across the district. Cost is \$50,400.00. This contract is valid from July 1, 2026, through June 30, 2027.

Annual Renewal - Existing Contract, SPED Federal Funds

7) Shannan Frohock Interpreting Services for Staff Agreement

Shannan Frohock is a certified teacher for the Deaf and Hard of Hearing. She develops and implements IEPs for all students in the district who have been identified as having Hearing Impairment or Deafness. She also manages audio equipment placed in classrooms across the district. Cost is 30,000.00. This contract is valid from July 1, 2026, through June 30, 2027.
