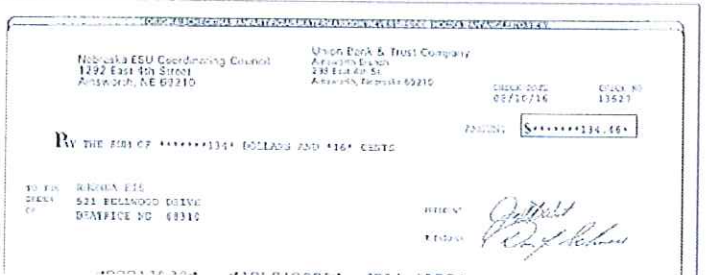

*Cyber extortion coverage* pays for the cost of an investigator your client retains relative to an extortion threat against the insured's computer systems or data and it covers amounts your client pays in response to the cyber threat within the limit of insurance.

*Data compromise liability coverage* pays on behalf of your client the expenses that result from legal action against your client for claims brought by affected individuals or governmental entities on their behalf, and regulatory actions including:

- investigation, defense and appeal expenses
- damages, judgments or settlements for which the insured is held responsible
- legal expenses for which the insured is held responsible
- prejudgment and post-judgment interest for which the insured is held responsible

*Network security liability coverage* protects your client's business from third-party liability and pays on behalf of your client if weakness in your client's computer system security is exploited by a cyberattack and leads to:

- breach of third-party data
- unplanned forwarding or replication of malware
- unintentional support of a denial of service attack
- prevention of access to your client's computer system by an authorized third-party user

*Electronic media liability coverage* provides coverage for and pays on behalf of your client defense and settlement costs if a third party sues claiming that your client's electronic communications resulted in:

- defamation
- violation of a person's right of privacy
- interference with a person's right of publicity
- infringement of copyright or trademark

Most classes are eligible, except for adult entertainment businesses and gambling or gaming businesses.

Cyber Defense policies are priced based on base rates by annual revenue and are further modified by account limit, deductible, industry hazard class and characteristics of the individual risk. Cyber Defense coverage comes with the same access to the online cyber risk management portal described in the Data Defender section.
