### **BACKGROUND INFORMATION**

On February 14, 2022, the Board of Trustees called for a General Election to be held on Saturday, May 7, 2022, for the purpose of electing trustees from Single Member Districts 2, 3 and 7 to serve a term of four years.

### **ADMINISTRATIVE CONSIDERATION**

On May 7, 2022, a General Election was held for Single Member Districts 2, 3 and 7. Texas Election Code Section 67.003 requires that the governing body canvass the election results not later than the 11th day after election day. The canvass must be conducted in accordance with the applicable procedures set forth in Chapter 67 of the Election Code.



### ACTION ITEM

#### **BACKGROUND INFORMATION**

After the governing body completes the canvass process, the presiding officer shall prepare a Certificate of Election for each candidate who is elected to an office for which the official result is determined by that authority's canvass. [Texas Election Code, Sec. 67.016]

Before an elected officer may assume the duties of the office, the officer must first file a Statement of Officer with the official records of the governing body. [Tex. Const. Art. XVI, Sec. 1]

All elected officers shall take the Oath of Office after the Statement has been signed and before they begin their duties. [Tex. Const. Art. XVI, Sec. 1]

#### **ADMINISTRATIVE CONSIDERATION**

The Oath of Office must be administered by someone authorized to administer an oath under Texas Law. [Texas Government Code, Chapter 602]

#### **BUDGETARY CONSIDERATION**

None

#### **ADMINISTRATIVE RECOMMENDATION**

It is recommended that the Board of Trustee qualify newly elected trustees for office through the Certificate of Election, Statement of Officer, and the Oath of Office.
