TOPIC: Pandemic stipend for all Chickasha Public Schools employees.

ADMINISTRATIVE RECOMMENDATION:

To approve a pandemic stipend for all CPS employees who qualify, as set forth below.

RATIONALE FOR RECOMMENDATION:

In recognition of the hard work and challenging times experienced due to the COVID-19 Pandemic, Chickasha Public Schools is providing a stipend to all employees as set forth below. CPS is using one-time federal funding to provide these funds to all employees.

CPS will pay a stipend to all employees, including temporary contracted teachers, permanent long-term substitutes, and the Superintendent. (Short-term) Substitutes, lay coaches, and persons who took a leave of absence during the 2020-2021 school year do not qualify for the stipend.

CPS will pay the stipend on May 31, 2021, subject to all required taxes, withholdings, and contributions.

\$1500- for any certified teacher, certified administrator, permanent long-term substitute, and support staff who meets the following qualifications:

- 1) Employed full time (1.0) or part time (0.5-0.9) on or before October 1, 2020;
- 2) Actually performed services for CPS during the 2020-2021 school year;
- 3) Remained continuously employed until May 24, 2021 (Support) and May 25, 2021(Certified); and
- 4) Completed the COVID-19 Workplace Guidelines GCN Training by May 24, 2021 (Support) and May 25, 2021 (Certified).

\$750- for any certified teacher, certified administrator, permanent long-term substitute, and support staff who meets the following qualifications:

- 1) Employed full time (1.0) or part time (0.5-0.9) after October 1, 2020 and on or before January 11, 2021;
- 2) Actually performed services for CPS during the 2020-2021 school year;
- 3) Remained continuously employed until May 24, 2021 (Support) and May 25, 2021(Certified); and
- 4) Completed the COVID-19 Workplace Guidelines GCN Training by May 24, 2021 (Support) and May 25, 2021 (Certified).

OPTIONS:

- 1) Approve stipend to be paid as set forth above.
- 2) Do not approve the stipend as set forth above.
