Notice of the schedule of regular meetings of the School District for the calendar year 2023 was given in writing, to the County Clerk of Craig County, Oklahoma at 10:19 o'clock a.m. on the 18th day of November, 2022, and public notice of this meeting, setting forth the date, time, place and agenda was posted at the front door of the Delbert Lovelace High School, Welch, Oklahoma, in prominent view and open to the public twenty-four (24) hours each day, seven (7) days each week at 5:30 o'clock p.m. on the 7th day of April, 2023, being twenty-four (24) hours or more prior to this meeting, excluding Saturdays, Sundays and State designated legal holidays, all in compliance with the Oklahoma Open Meeting Act (as attached hereto).

RESOLUTION

A RESOLUTION FIXING THE AMOUNT OF BONDS TO MATURE EACH YEAR, FIXING THE TIME AND PLACE THE BONDS ARE TO BE SOLD AND AUTHORIZING THE CLERK TO GIVE NOTICE OF SAID SALE AS REQUIRED BY LAW; AND DESIGNATING BOND COUNSEL FOR THIS ISSUANCE OF BONDS.

WHEREAS, the issuance of \$3,545,000 of Building Bonds by Independent School District Number 17 of Craig County, Oklahoma, has been duly authorized at an election held for that purpose and certified by the County Election Board of Craig County, Oklahoma on the 25th day of April, 2019; and

WHEREAS, the Board of Education of Independent School District No. 17 of Craig County, Oklahoma, having determined at the time that the election was called to authorize the \$3,545,000 Building Bonds would be issued in separate series, the first series in the amount of \$15,000 Building Bonds, dated July 1, 2019; and the second series in the amount of \$165,000 Building Bonds to be issued immediately; and

WHEREAS, the Board of Education of Independent School District No. 17 of Craig County, Oklahoma, desires to employ Terry L. Hawkins of Phillips Murrah P.C., as Bond Counsel for this issuance of bonds.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRICT NUMBER 17 OF CRAIG COUNTY, OKLAHOMA:

SECTION 1. That the \$165,000 of Building Bonds of Independent School District Number 17 of Craig County, Oklahoma, voted on the 5th day of March, 2019, shall be offered for sale at the Board Room/Multipurpose Room, Delbert Lovelace High School, 707 South Curtis, Welch, Oklahoma, on the 19th day of May, 2023, at 12:00 o'clock p.m., said Bonds to become due \$165,000 in two (2) years from their date until paid.

SECTION 2. That the Clerk of the Board of Education is hereby ordered and directed to cause notice of the sale of said Bonds to be given as required by law.

SECTION 3. The Board of Education of Independent School District No. 17 of Craig County, Oklahoma, hereby employs Terry L. Hawkins of Phillips Murrah P.C., as Bond Counsel for this issuance of bonds.
