Jeremy Ramsey, Superintendent of Schools, reported on the OSDE Varsity Tutoring program for online tutoring which is totally separate from the school and paid for by the State Department of Education which is separate from the community tutoring program introduced by OSDE; email sent to Superintendents from the Moms for Liberty regarding business with Scholastic Books and has directed Mrs. Anderson to research other vendors; budget information for the district and his projected carryover for FY25; football playoffs hosted by the District last week; the upcoming Sooter Basketball tournament; space heaters in the restrooms at the Ag barn will be replaced and the propane tank has been replaced free of charge from Bartlett Co-Op; 4-H will be sponsoring several events during the next few weeks in the Show Barn; Enrichment Foundation donated \$15,000.00 toward the cost of a digital sign for the district; and the upcoming Thanksgiving break.
