Facility planning update from architect BVH

BVH architect, Cleve Reeves, reviewed information collected from the Patron Committee Meeting including pros and cons of the four potential scenarios for facility improvement. These four alternatives are not the only alternatives nor do any of these stand on their own, they are just starting points for consideration. Mr. Reeves also reviewed the facility planning timeline going forward.

Administrative Reports

Submitted by Scott Shepard, Jr-Sr High School Principal

Relationships - Since July 1, I have been able to meet the board, several staff members and spent some great time with the administrative team at the NCSA Administrators' Days in Kearney. We had our open house this week, where I was able to meet and greet many of the students and parents as they came to finish the registration process and receive their chromebooks.

Student Engagement - We are planning a first day of school to welcome the students into the RC Family that will include some required trainings (school safety, bus evacuations, dating violence) and some logistical items (guidance/counseling, student handbook) and I will also have time with each of the grade levels as we discuss what it means to be part of the RC Family! Fall sport practices also begin on Monday, August 8. Our initial staff development will focus on relationships and student engagement in the block schedule. We believe this will increase student learning over the course of the year.

Beginning of the School Year - New staff start next week with mentors joining them on Tuesday. We are excited to work with the team to create positive experiences for our students. The handbooks are complete, but Tony and I do want to work with the staff early on and we may make a few recommendations for changes as we understand the culture and routines of Raymond Central. Lynn and I will hopefully have a recommendation for a 6th grade teacher at the board meeting on Wednesday following the late resignation.

Celebrations - Last week, several of our students and their livestock performed well at the Saunders County Fair. I was fortunate to be able to watch some of them show their calves on Friday. What a great experience for our kids and also want to thank our Ag teacher Katie Donahue for the support she gives our students and families.

Jared and his team have the facility just about ready for staff and students to return. Everything looks great!

Tony Kobza has done a great job with filling coaching positions, raising funds for the scoreboards in the gym and preparing for the start of the fall seasons.

I want to thank Lynn for the support over the past few months during the transition. She has handled most of the hiring and we have worked together on the handbooks to create some consistency across the district. It is refreshing to work with a positive team focused on doing what is best for kids.

Fall Sports are in full swing. We currently have 171 athletes competing in grades 7-12 for the fall season. Weight Room upgrades have been completed and added max capacity to the weight room by 50%. We are adding a new Hudl Focus camera to the New Gym to allow us to livestream any competitions that are held within that gym.

Band, Cheer and Dance have been adding to a great game day atmosphere for Volleyball and Football games. We are moving forward with the ScoreVision Boards as we have the funds necessary for installation committed for us to have the boards installed in early November. Businesses and families have provided all of the funding necessary to cover the costs of the boards. We are currently over \$127,000 committed to this project.

Beginning of School - we have many new teachers and assignments that are being worked out (Ceresco 1st, 3rd, and 5th grade; Valparaiso Kindergarten; Counselor to both buildings). We also have three new paras.

School Year Focus - Science of Reading. This will begin during pre service with all elementary teachers and will continue throughout the year in various sessions to train teachers in the research based best practices for teaching reading. This will also culminate in the evaluation and adoption for our new curricular resources for the 2022-2023 school year.

MTSS

- Developing the use of the process with our team through services provided by NeMTSS Kayla Peyton.
- Defining work of High Leverage Practices and adopting High Level materials.
- Creating a list of verified interventions, defining the process of prescribing those to students and training those involved.
- Will develop and implement the use of student problem solving teams.
- These teams will be in place to be an early identification of students who need extra support to work towards keeping them from needing more formalized services with larger gaps.

CPI (Crisis Prevention Intervention). Staff were trained using practical skills and strategies to safely manage disruptive or difficult student behaviors. CPI certification training supports PBIS strategies. We have 30 staff recertified in CPI and 10 new staff certified in CPI.

Current SpEd List - During the summer months, we had two special education students transfer to a different school district and we had three students enroll that are on an IEP. Current Special Education numbers: Ceresco - 26; Valparaiso - 11; MS/HS - 71 = 108 verified students.

TIP (Targeted Improvement Plan). Each school district has to review their student data and establish a targeted improvement plan. Each TIP is required to have: A focus for improvement; A measurable goal with annual targets; A student-centered, evidence-based strategy to affect the outcome for students with disabilities; An implementation plan; Criteria to measure fidelity of the student-centered, evidence-based strategies selected. The TIP must be aligned to the overall general education improvement activities being implemented at the district.

Raymond Central's [TIP](#) was submitted in May and we just received our review summary back. We have met the criteria in all areas! [RC Tip Review Summary](#) I want to thank Caitlin Roussan (school psychologist) and Jenifer Highstreet (HS SpEd teacher) for helping with this process and agreeing to be a member of the TIP team. They dedicated their time and expertise to make this possible. They spent many hours dissecting data, collaborating, and creating a plan that will benefit the students at Raymond Central. Their hard work definitely paid off!

Student Board Report - Madison Parham

Good evening Raymond Central Board members, my name is Madison Parham. I am the Student Body

President for the 2022-2023 school year. I am involved in various activities including Volleyball, Basketball, Cheerleading, Student Council, and National Honor Society.

On top of that, our cheerleaders are at the volleyball game as well, which is a change from the past years, and have been great advocates for keeping our student section loud and cheerful. Our student sections have had an outstanding impact on our different athletic teams, and I, as a volleyball player, am always happy to see a large crowd of students spending their weekday evenings to support our team.

In regards to the academic lives of students, classes seem to have begun on a great start. Almost 83% of the budget is in personnel costs. The 2022-23 budget would generate a tax asking of \$9,187,579.00 which is an increase of \$456,066 and a slightly reduced levy of \$1.128779 (down from \$1.131183).

The 2022-2023 budget would generate a tax asking of \$9,187,579.00 which is an increase of \$456,066 but a slightly reduced levy of \$1.128779 due to increased property valuations (down from \$1.131183). Reasons for the increased budget: 1) General Fund increased cost of staffing, health benefits, and special education costs; 2) 84% of our budget is human resources and we need to stay competitive to attract and retain the highest quality teaching and support staff for our students; 3) Maintaining four months of operating expenses in our general fund cash reserves; 4) Maintaining bond fund balance equivalent to one year of bond payments.

Motion by Gould, second by Blanchard to approve the 2022-2023 Budget as follows: General Fund - \$11,963,042; Depreciation Fund - \$1,936,086; Employee Benefit Fund - \$121,088; Activities Fund - \$937,208; School Nutrition Fund - \$772,825; HS Bond Fund - \$1,352,104; Special Building Fund - \$3,330,874; QCPUF Fund - \$10,490; Student Fee Fund - \$52,949; Total Budget of Disbursements - \$20,476,666. RCV 5-0. Motion carried.

Discuss, Consider and Take Necessary Action to Set System-Wide 2022-23 Property Tax Request for General Fund, Building Fund, and High School Bond Fund

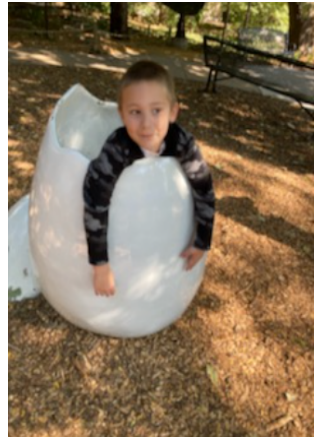
Nebraska Part B Parent Survey Results (2021-2022):

- The results from Improving Learning for Children with Disabilities (ILCD) parent survey have been released. This survey allowed parents to provide information on parent opportunities to participate in program/school improvement activities that result in improved outcomes for students with disabilities. The Office of Special Education requires parent involvement information as part of their State Performance Plan to measure aspects of Nebraska's Special Education programs. Each year the state must provide information on an Annual Performance Report, indicating the state's progress toward meeting the targets for each of the indicators. The Nebraska Department of Education must gather information on each school district's efforts in meeting the rigorous targets and report those results publicly.

- From the results of the survey, the following are areas of concern that the school district will work on to improve:
 - Before my child was referred for special education services, the teachers and school tried different ways to help my child in the general education classroom - 68.1% agreed.
 - The school helped my child with transitions (i.e., Preschool to Kindergarten; Elementary to Middle School/Junior High; and Middle School/Junior High to High School) - 76.0% agreed.
- The following are areas of celebration:
 - I have received information about special education for my child in a language I understand - 100%.
 - I have opportunities to be involved in school activities - 98.0% agree.
 - I have received information from my school or school district about my Parent Rights - 96.6% agree.
 - As a member of the Individualized Education Program (IEP) team, I have input in decisions about the special education and related services that my child receives - 96.6% agree.

Sensory Safari:

- On October 5th, 12 special education students, ranging from Kindergarten to Seniors, had the opportunity to participate in a Sensory Safari at the Lincoln Children's Zoo. Students had the opportunity to touch, feel, hear, and smell at interpretive stations located throughout the Zoo. Nature experts and Nebraska Game and Parks engaged visitors at each station. Some of the highlights included:
 - Petting animals such as horses, goats, birds, rabbits, turtles, snakes and fish. They also had the opportunity to feel an elephant's hide.
 - Listening to devices that made frog and bird sounds. They also had the chance to do their own turkey call.
 - There was a sand pit to dig through.
 - Smell different animals and insects such as bees.

- Students then had a picnic at the Zoo after the event. A special thank you to our amazing cooks for packing a sack lunch for our students.  - During these last sessions we are starting to develop the understanding of what we need to implement to bolster instruction in the areas of Word Recognition that will lead to the advancement of Reading Comprehension. We are in the process of evaluating materials that will be used to replace the outdated and non-instructionally sound Wonders Reading Program that we have used for the last several years.
 - Caryn from the ESU is aiding in the evaluation and selection of these materials with her knowledge of what we need and what other schools in this process have already chosen. We hope to have the curricular materials decided on by the first of the year.
 - School News
 - Life Skills / Special Education Students attending the Sensory Safari at the Lincoln Children's Zoo -- They had a great experience getting to touch and interact with the animals
 - Teachers are beginning to meet with Student Problem Solving Teams (SPS) on a regular basis to discuss reaching students early with targeted interventions. The purpose of these meetings is to identify students who need additional support
 - Testing
 - NSCAS Growth - Fall testing has been completed and data is currently being analyzed. We have been given the Spring data to unpack. We have lower scores in regards to proficiency levels across all grades. Plans are in place to address these issues as we move forward. It will not be a quick fix, but we are looking to

see immediate improvement in Active Participation per our Professional Development Plan which will directly impact student performance.

- NWEA MAP - Being administered to 2nd Grade - the window is being finalized and we will begin looking at the district data shortly. Individual data is already being utilized to make determinations for support of students.

I found some different online resources that provide recommendations for adequate custodial staffing. In 2009 the Minnesota Department of Health released a study titled "Cleaning Indoor Environmental quality and Health: A Review of the Scientific Literature" recommends that schools have at minimum one custodian per 25,000 square feet of space. That is viewed as the 'lower end for minimally adequate cleaning' and does not take into account the types of rooms and floor coverings.

The amount of cleaning should take into consideration: the type of flooring, the number of hours it is used, the number of students, the amount of dust collecting furnishings, materials, clutter, presence of plants, animals, etc.

Professional cleaning associations recommend between 10,000 and 25,000 square feet per full-time custodian.

It is my understanding that we used to have 7 full time persons in the maintenance/custodial department and that was prior to the new square feet added to the Jr/Sr Building which includes additional locker rooms, multiple restrooms, and high traffic areas. The Jr/Sr high school also has to clean up after events hosting large number of people.
