Professional Development/Learning: The Professional Learning Team will meet on February 13 to prepare for the professional learning day with the staff in March. Our focus continues to be the tenets associated with our 6 Phase Model being led by Deb Kruse and the learning team. Last session was dedicated to learning targets. We now will focus our energies on where the rubber really hits the road with student learning; success criteria. In its simplest version, success criteria are things students will say, do, create, or write to demonstrate they are beginning to understand/master learning goals.

Learning Targets: Classroom teachers have been working very hard about and within the process of using student friendly learning targets. Our last professional learning day was dedicated to this cause. Early evidence is that we are starting to see consistent use of the targets in the classrooms regardless of the content area which is the district expectation. A student friendly learning target would be posted using I can or I will statements to personalize learning intentions for students. We invite you to visit a classroom and see for yourselves.

Achievement Scores and Testing: The high school data team is beginning to flesh out our spring assessment calendar. We hope to correspond our schedule with that of the elementary to mirror the schedules as closely as we can. Testing season truly never ends, it just gets busier this time of year with state testing on the horizon.

Long-term Substitute: Taryn Miller (Long-Term Sub) will be taking over for Katie Donahue starting February 10. Taryn is an excellent resource for us in lieu of Katie. They have spent several days together and the direction Mrs. Donahue hopes the classes and her program to go is dialed in. Welcome to Raymond Central Taryn.

Decision-Making Matrix: Another item vetted through the decision making matrix is the conversation that will be shared with the board for consideration in the near future. It is the 10 point grading scale proposal. We have used this decision making process with success several times already this year. The system is working as intended.

Counseling/ACT/Senior Experience/Scholarships (Tasha): Graduation is 3 months away and time is flying! Senior Scholarship season has kicked into full gear, there are two Scholarship Saturdays coming up for seniors to come and get help on scholarships. Open dates are hard to find so anyone who can't make it, can schedule time for help. Students in grades 9-11 have looked at their personal learning plans for next year and will be receiving updated course catalogs within a couple of weeks. ACT is coming up in April with events to be announced for every grade level. We will have two more college/career/military fairs left for the year (February 10 and March 12). We are always looking for local businesses to set up a booth and share opportunities within our community.

Evaluation Update: Evaluations continue to be completed. We are in the process of completing T3 and English Language Arts educators this semester. This does not include the normal rotation and non-tenured staff as required. Their evaluations are continuing as planned. The conversations have been excellent and very productive. There are some great things happening in our classrooms.

Staffing: We interviewed for the counseling position and assistant principal positions last week. The candidate pools were excellent. We believe we have been able to secure quality personnel to help lead our school. I would like to thank all of the staff and administration involved in the selection process and for being part of the committees again. They made some very hard decisions on behalf of our school. Their efforts are very much appreciated and often go unnoticed when we fill such positions.

Student Council: We have fully implemented our new program for student donors to have the opportunity to receive honor cords for donating blood! We are calling them Lifesaver Cords! Students for this school year only need to donate 2 times to receive an honor cord for graduation. For each school year following, every student will need to donate a minimum of 4 times to qualify. **Our next blood drive is Friday, March 7, 2025 | 10am-2:30pm.**

The Student Council will pack backpacks with Jim Marsh on March 18th.

JH Student Council: The Junior High Student Council held a dance for 7th and 8th grade students on January 24. We had great attendance and everyone had a great time!! Part of the profit from the dance will be donated to Nebraska Make-A-Wish.

We recently held a fundraiser for Nebraska Make-A-Wish from January 24-February 1. The elementary buildings beat the JH/HS building by a landslide! Elementary winners will receive a treat the week of February 10. We met our goal of \$1,000 through the various events!! Superintendent's Report

Grade-Alike Updates: Elementary students will be released two days prior to the Jr-Sr High School for the summer to provide elementary teachers with two full days to pack up their classrooms. The move will occur the week of July 7 provided maintenance and carpet installation is complete. Teachers will be granted two paid days before the official start of their contract to set up their classrooms.

We do not plan to adjust school start times, but we will offer supervision for students starting at 7:45 AM and extending to 3:30 PM after school. This schedule will align with normal bus routes and provide flexibility for parents who wish to drive their children to school. Classrooms will be organized in pods by grade level at each school. Students will be assigned to classrooms based on educational factors and district goals. Parents will not have the option to request specific teachers.

A transition day will be planned in the spring, allowing students to visit their new school. More details will be provided soon.

Lease Purchase Facts

- \$1.5 million MAX with matching committed sponsorships
- Not to exceed a 7 year lease purchase
- Can be taken in smaller increments as sections of Phase 1 can be completed and funds are committed
- School Board approves ALL lease purchase agreements with review of committed contracts with sponsors
- No agreement has been made with any financial institutions, only getting potential partners at this time
- Working with Firstland Financial as our Lease Purchase Broker

Lease Purchase Facts Continued

- RC Community Foundation must be able to prove through contracted commitments we can make payments on lease purchase
- RC Community Foundation is responsible for payment of interest accrued on lease purchase
- Local Banks will have first opportunity to bid lease purchase interest rate
- Funds will not be drawn until committed sponsor payments can be aligned and next steps can be completed. No reason to draw extra funds and pay interest until able to effectively use funds.
- Risk: If contracted business sponsor no longer exists or loses ability to pay, school would be responsible for that amount unless Foundation is able to replace funding with new sponsorship/donation/grant funds

RC Community Transparency

- 501c3 Non-Profit VOLUNTEER group
- Foundation has provided ALL dirt work that has been completed, including second entrance to the campus for a safer, more efficient traffic flow
- Currently raised over \$650k in donations, sponsorships, in-kind donations, committed funds
- Dirt work for bond issue in 2023 = \$6 million, dirt work for this project = \$345k
- Meetings are not private, however, they are not required to be promoted or advertised as a 501c3

RC Community Transparency

- Volunteers all have jobs so communication is shared as information is needed to be shared
- Some businesses have asked for privacy with quotes and donations as they may be giving us a discount that they do not want advertised. We are going to respect those businesses wishes
- No financial information will be shared outside of the desires of the foundation UNLESS it directly relates to approved funding from a lease purchase with the RC School Board
- RC Community Foundation abides by all legal requirements for local, state and federal law, however, we do not have the same rules as a School Board when it comes to open meetings laws
- RC Community Foundation has a triple signature requirement for any funds to be spent to ensure fraud, theft or abuse is not happening

Financial Information

- \$.14 levy that was shared on Facebook is referencing the levy that is already being levied for the RC Building Fund (This is not a new levy for a lease purchase)
- Sample Payment Structure on Lease Purchase
 - \$300k lease purchase with 7 year term = approximately \$53,000 per year based on estimated interest rate given by financial institution

8. Reports

8.1. Administrative Reports

Board Report JH/HS: March 2025

Professional Development/Learning: The staff met on Friday, March 7. Our focus continues to be the tenets associated with our 6 Phase Model being led by Deb Kruse and the learning team. This session extended the growing understanding of the learning targets by focusing on Success Criteria. This is truly where we start seeing how students demonstrate that they are beginning to understand or even master learning goals. Once known, teachers can then adjust instruction to address the four questions:

1. What do we want our students to know and be able to do?
2. How do we know they have mastered what we want them to know?
3. How do we respond when they struggle to learn it?
4. How do we respond when they already know it?

This truly is a roadmap to meeting our students where they are at academically and a process in working to help see them grow.

Success Criteria: We will begin looking for evidence that students can explain or demonstrate how they know the concepts alluded to in the learning targets. This will be information we collect formally and informally while we observe student-teacher/teacher-student interactions in the classrooms. As we continue to work with our instructional model, this process will continue to grow in practice. We are excited to see the results once it has taken root and embedded practice begins to come to fruition.

Achievement Scores and Testing: No further updates as we build a schedule for assessment. Testing season is quickly approaching.

Decision-Making Matrix: The Structures subcommittee vetted an additional item through the process last Friday. The decision making matrix continues to work as designed and intended. IF they choose to truly participate, staff have a voice and a vehicle to be heard. This system, designed to be anchored with a "Will of the Group" mentality, is helping to support collaborative efforts we hope to foster and grow in our school/district. It is the job of the administration to protect the process as we continue to work with the structure and potentially tweak the design to further fit our needs.

Counseling/ACT/Senior Experience/Scholarships (Tasha):

Scheduling season has started. All grade levels will be turning in their personal learning plans on March 18th or 19th. The final Scholarship Saturday has ended. We had 14 students for the first and 6 for the second. I was pleased with these numbers because the end of Feb and early March are very busy times of the year. We had another successful Dual Credit Night with reps from Bryan College of Health Sciences, UNL including someone from high ability and honors programs, Doane University, and Mr. S from SCC who comes out almost weekly to check on our dual enrollment students. These representatives are incredibly knowledgeable and help lead this event which included about 70 students and parents. ACT day is getting rolling. This year

we are changing it up a bit, 6th and 7th will be visiting SAC Museum, 8th is going on a college visit to UNL, 9th grade is heading to Fremont to visit Metro CC and Midland, 10th grade will take the PreACT then travel to Concordia University, 11th grade will take the ACT, and seniors have the opportunity to schedule any remaining college visits, job shadows, or get ready for graduation.

Evaluation Update: We are on-track and nearing completion of the evaluations at the JH/High School. We have completed evaluations on all but six of the certified staff at the high school regardless of the three year rotation. Only teachers on the T-1 (year one of the cycle) and T-2 (year two of the cycle) tracks have not been evaluated. T-3 (year three of the cycle) track staff and non-tenured staff have been evaluated. We also chose to evaluate an entire content area as well regardless of the tenure track. It is my estimation that the staff we have evaluated have received high quality and timely feedback. The process has been meaningful. It is a further estimation that we have both validated the work they are doing and have offered reflective thoughts, sentiments, and ideas for consideration. The administration thanks the staff for the productive conversations. These were candid, open, and professional discussions.

Staffing: We will begin the process of interviewing for a social studies position at the HS next week. We have a great pool of teaching candidates to choose from. It is always exciting when you have so many quality people that want to be part of your school and educational family. We will enjoy the conversations and anticipate a productive outcome to filling our social studies opening.

Student Council: Reminders from last month: We have fully implemented our new program for student donors to have the opportunity to receive honor cords for donating blood! We are calling them Lifesaver Chords! Students for this 2024-2025 school year only need to donate 2 times to receive an honor cord for graduation. For each school year following, every student will need to donate a minimum of 4 times to qualify. It's a very simple process to apply. The student will visit our school programs page [HERE](#) and select the Lifesaver Cord section for more information and to fill out the simple application. All it will ask for is:

JH Student Council: The Junior High world has slowed down quite a bit. This month students put together a basket for the Open House Fundraiser for the Hudson Family. They decided on a Family Game Night theme and provided a variety of card games, board games, and snacks.

Agricultural Education/FFA: Last Friday was the FFA Fish Fry at the High School. Thank you to all who have helped or are helping in the future! District CDE's were postponed from 3/4 to 3/11, so we went to Columbus yesterday to compete in welding, vet science, and meat evaluation. At the end of February, we celebrated FFA week by having dress up days, a petting zoo, and "drive your tractor to school" day. We have our Labor and Article Auction this Friday March 14th starting at 6. We have qualified many teams for State FFA so far this year, which will be held April 2-4.

School Improvement: On-going work with the instructional model is systemic and fits into our goals. As we develop the system further, we will be able to compare where we are to where we are intending to go. This will show up in classroom practice and in achievement scores.

FBLA: FBLA is gearing up for an exciting and busy spring. On March 29, we will host our annual FBLA Craft Fair from 10:30 AM to 3:00 PM, providing an opportunity for local vendors to showcase their products while supporting our chapter. This year, we are excited to have five student-run booths as part of the event, giving our members hands-on experience in entrepreneurship and business operations.

Our members are preparing for the Nebraska FBLA State Leadership Conference, which will take place April 10-12 in Kearney. This year, we are taking eight high school members and five middle school members to compete in a variety of events, including objective tests, presentations, role-plays, and skill-based competitions. Students will also have the opportunity to attend leadership workshops, network with peers from across the state, and engage in activities that enhance their business and leadership skills. We are excited for our students to showcase their hard work and represent Raymond Central at the state level.

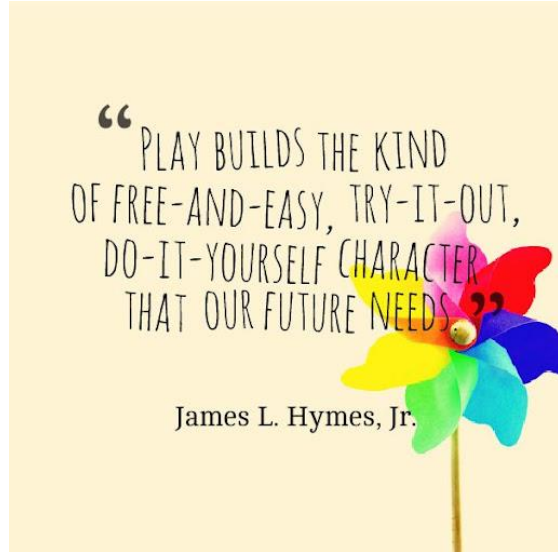

Topics

- Math Adoption
 - Over the past several weeks, teachers have piloted iReady and Reveal Math materials. Teachers have gained a comprehensive understanding of their instructional methodologies.
 - On Friday, March 7th, the Educational Service Unit facilitated a session to guide us through the decision making process for adopting new math materials. This session was instrumental in helping us evaluate the strengths and weaknesses of each curriculum.
 - After a decision has been made, we will initiate discussions with vendors to finalize pricing, order materials, and arrange training sessions for the new program.
- Professional Learning
 - On Friday, March 7th, teachers participated in another professional learning session on the instructional model. In the last session, learning targets were emphasized and teachers had the opportunity to create them with peer support. In this session, teachers gained an understanding of the importance of success criteria and how it relates to the learning target. The learning target tells students what they should know and be able to do by the end of class and the success criteria tells students how they will demonstrate mastery. During this session, teachers had the opportunity to practice writing success criteria for an upcoming lesson with the support of peers and administrators.
- School Improvement
 - Teachers recently participated in a data dig looking at 4 data sets: student learning, perceptions, demographics, and school processes and systems. For each set of data, teachers found strengths, challenges and brainstormed implications. We compiled this analysis to create a school profile.
 - The elementary teachers were to meet on the next steps in our School Improvement Process on Wednesday, March 5th. This meeting will be rescheduled due to the snow day.
 - Next Steps:
 - Create school wide reading goal
 - Analyze grade level reading data
 - Look across data sets and ask questions
 - Cause Analysis
 - Grade level reading goals that will feed into school wide goal
 - Additionally, we will be adopting a Social Emotional Learning (SEL) goal. This goal will be informed by our school climate and culture surveys, as well as our district-wide expectations. By integrating SEL into our improvement process, we aim to foster a supportive and inclusive environment that promotes the well-being and academic success of all students.

- The teacher leadership team, which also serves as our school improvement team, will evaluate which processes and programs are currently effective, which need to be adapted or discontinued, and which new initiatives should be implemented to help us reach our goal. The team will periodically review data and the strategies in the plan to see if we are making progress.
- Next steps for new adoption of new Elementary Report Card
 - Teachers on the Report Card Committee will pilot the new report card for the 4th quarter.
 - Engage students and parents in feedback
 - PD for teachers and communication to parents in the Fall of 2025 for use during the 2025-2026 school year.

Legislative Conference:

On February 27th and 28th, Andrea Hicks, Caitlin Roussan, Clair Turman and myself attended the NASES Legislative Conference in Lincoln. Before the conference, we had the opportunity to tour the Project Search program, guided by one of our students currently enrolled in it. It was a great experience to see firsthand the rotations she is working through and the valuable skills she is gaining from this transition program.

During the conference, we learned about various legislative bills to monitor, including those related to option enrollment, cell phones and accommodations, special education transportation, the withholding of state funding, etc. We then participated in roundtable discussions on key topics such as homebound placements, new early childhood documents, high-quality MDTs, programs at Munroe-Meyer Institute, dyslexia reporting, and the Nebraska Youth Leadership Council - where one of our students is actively participating.

On Friday, NDE presented on the NE Literacy Project and the Reading Improvement Act. They discussed how students need to receive reading instruction from their classroom teachers as they are the experts. Special education teachers support the students and their learning. NDE shared data on how 4th grade students are performing on the NSCAS reading assessment. There is an increase of students proficiency rate in every disability category; however, Specific Learning Disabled students are the lowest performing group and we need to find out why.

Indicator 13 Training:

On Friday, March 7th the middle school and high school special education teachers participated in the Indicator 13 Corrective Action Plan Training. The objectives of the training were:

- What Indicator 13 is and how it connects to student IEPs in the area of transition planning
- Understand the components of creating a meaningful transition plan with students with IEPs that are age 14 or older.
- How to complete the Indicator 13 checklist to make sure that we are in compliance with transition plan requirements.
- How to tie annual IEP goal(s) to the student's postsecondary goal.
- Make sure that transition services and/or activities are linked within the transition plan.

We had great discussions during our time together, leading to a deeper understanding of the indicator compliance areas.

- Collaborating as a team to determine and promote initiatives that benefit the entire Raymond Central School District.

Grade-Alike Updates

- Classroom maps are available, with each school organizing classrooms in pods by grade level.
- Ceresco and Valparaiso will release students two days prior to secondary schools for the summer. This will provide elementary teachers with two full days to pack up their classrooms.
- Packing supplies will be provided during the final week with students.
- Instructions regarding items to be disposed of and those that need to go through the surplus will be distributed by March 1.
- Furniture options have been selected, and the necessary items will be ordered following the March Board of Education meeting. This timeline will allow ample time for delivery.
- Roll-off dumpsters will be available at each school as needed for the disposal of consumable items that will not be moved.
- Classrooms of the teachers who will be moving will be packed and relocated to the gym. Boxes will be labeled with the school name, teacher name, and grade level.
- Maintenance work in classrooms will be completed by July 1.
- The move will occur the week of July 7, depending on carpet installation.
- Teachers will be granted two paid days before the official start of their contract to set up their classrooms.
- We do not plan to adjust school start times, but we will offer supervision for students starting at 7:45 AM and extending to 3:30 PM after school. This schedule will align with normal bus routes and provide flexibility for parents who wish to drive their children to school.
- Students will be assigned to classrooms based on educational factors and district goals. Parents will not have the option to request specific teachers.
- A transition day will be planned in the spring, allowing students to visit their new school. More details will be provided soon.
- The last day for elementary students will be Friday, May 16th. This will be a full day.

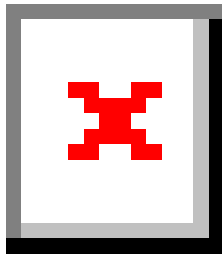

You are receiving this notice on behalf of Bryon Hanson (the "named individual") from PowerSchool. As you may know, PowerSchool provides software and services to your current or former school or the current or former school of a person to whom you are a parent or guardian. In compliance with State laws, we are writing to share with you some important information regarding a recent cybersecurity incident involving personal information belonging to the named individual.

What Happened?

On December 28, 2024, PowerSchool became aware of a cybersecurity incident involving unauthorized exfiltration of certain personal information from PowerSchool Student

Information System (SIS) environments through one of our community-focused customer support portals, PowerSource.

What Information Was Involved?

Due to differences in customer requirements, the types of information involved in this incident included one or more of the following, which varied by person: name, contact information, date of birth, Social Security Number, limited medical alert information, and other related information. At this time, we do not have evidence that the named individual's Social Security Number was involved. At this time, we do not have evidence that limited medical alert information for the named individual was involved.

What Are We Doing?

PowerSchool is offering two years of complimentary identity protection services to students and educators whose information was involved. For adult students and educators whose information was involved, this offer will also include two years of complimentary credit monitoring services.

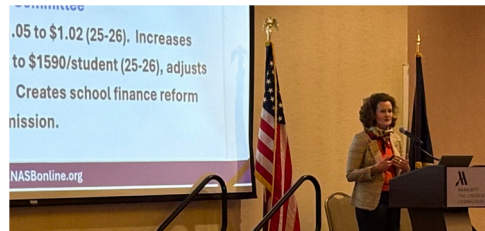

We provide information to facilitate the discussion – we never make recommendations ourselves since that decision should always be the responsibility of the Board. ENERGY PURCHASING ...

For those districts and ESUs who are not yet members of our NJUMP or CJUMP natural gas purchasing programs, we have Board Resolution forms to get you enrolled and ready for the official sign up period in late March or early April depending on the pipeline. NASB's natural gas programs on the two major natural gas pipelines in Nebraska were created to fulfill two needs that many local districts had in dealing with utility costs – obtaining competitive prices and budget certainty. NASB has over 110 school districts and ESUs across Nebraska participating in our CJUMP and NJUMP purchasing consortiums to leverage their purchasing power and achieve lower, more predictable utility bills.

FOUNDATION ...

The NPLF is awarding two, \$1,000 scholarships to high school seniors who are pursuing higher education to become a teacher in a Nebraska public school system. Students with plans to attend college or university in Nebraska, have a minimum GPA of 3.0, and whose school district is a member of NASB qualify to apply. We will have several leadership positions that will need to be filled for the 2025-26 school year.

From Governor Pillen's website:

Governor Jim Pillen is providing state senators with the newly published 2024 School Property Tax Collection Report, aimed at providing historical context for funding of the state's school districts, the impact of recent legislation in reigning in property tax increases and a request to state senators to consider legislation that will finally address inconsistencies in state aid to schools. The report, compiled by the Governor's Policy and Research Office (GPRO), compares data across each of the state's 244 school districts, accounting for the impact of state aid and property tax increases to taxpayers in those districts.

"We have newly elected state senators who may not have a complete understanding of how the state's funding formula has worked historically, nor the impact of recent legislative initiatives when it comes to setting caps and also providing state funding to those districts," said Gov. Pillen. "This document helps illustrate the impact of those changes and hopefully, inform discussions as we embark on the next legislative session and resume efforts to provide additional property tax relief to Nebraskans."

There are three key findings from the report:

Caps are working to slow the growth of school property taxes. It is estimated that in 2024 growth will be 2.7%, the smallest percentage increase since 2018.

Cuts in state aid are negatively impacting property tax relief delivery, especially for certain districts.

State revenues can eliminate property tax increases enacted by school districts, through the creation of a stable school aid formula.

"The majority of a taxpayer's property tax bill is tied to their local school district – an average of 60 percent," said GPRO Director Kenny Zoeller. "One hundred and eleven school districts have had a reduction in state aid in the current year. Some have increased property taxes to help meet that decrease and others have far exceeded it. We need to find a way to better help districts budget for the aid they do get, thereby creating some predictability and hopefully, further reduce what Nebraskans end up paying in property taxes year over year."

The analysis calls for Nebraska lawmakers to provide greater funding certainty through the Tax Equity and Equalization opportunities Support Act (TEEOSA). That formula has undergone multiple adjustments since its creation in 1990, which has also made it more confusing and has created disparities among districts in how they manage predicting budget shortfalls that are subsequently made up through property tax increases.

"The formula is inconsistent and hits taxpayers hard. It is not fair to them or the schools. Providing certainty to school districts will allow Nebraska to have sustained property tax reductions for the first time in history," concludes the report.

One of the more outstanding student academic activities that I've had the pleasure of working with is Academic Decathlon. The nation-wide program provides a prescribed course of study each year. Teams are made up of students of different academic abilities. Students with an "A" average compete against other students with an "A" average, students with a "B" average compete against other students with a "B" average, and students with a "C" average compete against other students with a "C" average. Schools can choose how they prepare for competitions. Some teams meet after school or in the evenings, while some schools offer a class.

There is a regional competition in January, with the State Championships being held in February. Students compete for medals at both events. Scholarships are awarded to members of teams who are successful in the competitions. Three of my four children competed in Academic Decathlon and between them were awarded thousands of dollars in scholarships.

This year, two NRCSA-member schools qualified for the State Championship: Amherst and Johnson County Central.

The NRCSA Executive Committee has made a positive move to assist non-traditional educators move toward full teaching certification. As a result of this move, new scholarship opportunities were created for paras who are in a “para to teacher program” and for transitional educators. NRCSA will provide three \$1,000 scholarships for the fall semester and three \$1,000 scholarships for the spring semester for the 2024-25 school year. Applicants for the scholarships must be current employees of a NRCSA-member district or ESU. Applicants must be enrolled for that semester in one of two types of programs: (1) in a recognized “para to teacher” program such as is offered by the three State Colleges (Chadron State, Peru State, or Wayne State), or (2) a transition to teaching program in which a person with a minimum of a bachelor’s degree who is employed to teach in a member school while working through a transitional program, such as offered by the University of Nebraska-Kearney. The applicant could currently be teaching under a transitional certificate. Application materials for Spring scholarships were distributed to member Superintendents and ESU Administrators, who were then asked to share with potential candidates in their buildings. Applications were due on Monday, Dec. 2. The NRCSA Scholarship and Recognitions Committee selected the three Spring semester scholarship winners.

We urge you to consider participation in the NRCSA Partner OneCard program as a tool for you in managing school expenditures, both large and small. Certainly, the card can help reduce/eliminate any issues relative to unverified cash expenditures. You decide who uses it, can get cards for each of those users, keep all cards wherever you wish, determine the amount to load on each individual card, and how long the time frame of use is. It is a terrific management tool and clearly identifies each expenditure/name/date/amount. Whether small purchases or very large purchases, the card is a terrific tool. NRCSA owns the state contract, so liability for misuse falls to NRCSA, not the district user. We have only had three circumstances of fraud and all three have been the theft of the card number information, not any district employee misuse. For 2023-24, 98 districts/ESUs participated in the program. We currently have 107 entities using the program. Great job by all participating districts in protecting the card and program! Don't forget, the NRCSA rebate from the transaction fee paid by businesses that choose to accept plastic is used for scholarship, awards, and special needs. For 2023-24, the rebate was over \$30,000 to NRCSA, showing that use is increasing, and large purchases are being included. WIN, WIN, WIN! Developing business & Industry, organizational, and postsecondary partnerships with school districts can play a pivotal role in enriching the educational experience, supporting student achievement, and strengthening connections between schools and their communities. By leveraging external resources, expertise, and support, schools can create a more inclusive, engaging, and supportive learning environment for all students. While partnerships within school districts can bring numerous benefits, there are also challenges that may be encountered. These can be overcome by fostering a culture of collaboration, prioritizing communication and relationship-building, seeking creative funding solutions, and promoting equity and inclusivity in partnership efforts. Additionally, leveraging support from district leadership, community stakeholders, and external resources can help schools overcome obstacles and maximize the benefits of collaborative partnerships.

We in the Institute of Agriculture and Natural Resources (IANR), specifically the College of Agricultural Sciences & Natural Resources (CASNR) and Nebraska Extension 4-H, believe this strategy for K-12 partnerships will result in a strong learning innovation network of support for every learner and every educator in the state of Nebraska. The world of higher education is evolving, driven by changes in technology, demographics, workforce demands, and societal expectations. To meet the needs of today's learners in the 21st century and prepare them for the challenges of tomorrow, we are embracing innovation, collaboration, and a student-centered approach.

The American Heart Association is committed to partnering with schools in rural Nebraska to improve the health of their communities. A few of these opportunities include:

Tobacco Free Schools. Unfortunately, recent data reveals the ongoing challenges of youth tobacco use. The 2021 National Youth Tobacco Survey showed that: Approximately 2 million MS/HS students reported using e-cigarettes during the pandemic; nearly 85% of them used flavored tobacco products. More than 4 in 10 HS students and nearly 2 in 10 MS students who used e-cigarettes did so 2 out of 3 days and youth showed a strong brand preference.

Many schools have struggled to keep up with the continued innovation of the tobacco industry. To help address that, the American Heart Association created our Tobacco Free Schools Toolkit. The toolkit is designed to help schools update their policies so that now – and in the future – they will cover all products, people, and places while providing mechanisms that support students who are battling tobacco addiction. Improving Cardiac Response in Schools. Did you know that the odds of surviving a cardiac arrest in rural areas is only about half of that in an urban area? In the aftermath of a cardiac emergency - minutes matter. The Chain of Survival starts with those who are present and requires everyone to do their part. The American Heart Association is committed to building a Nation of Lifesavers to and to helping school districts and other entities develop [Cardiac Emergency Response Plans](#). These plans consider: access to functioning AED's, a strong base of CPR knowledge and training, as well as the identification of a response team and the annual practice of a cardiac emergency. A note from Mr. Nikolai:

*For those I have not met previously, I am the **American Heart Association's** lead for rural health in the Midwest Region, inclusive of your states. My role allows me to work collaboratively with all manner of organizations that are in a position to impact health in their communities – and schools are certainly near the top of that list.*

There are many ways our organization has worked to collaborate with schools – supporting access to nutritious, affordable food, helping to address the ongoing challenges of vaping/tobacco use, and more. Today, though I'm focusing primarily on our resources to assist with cardiac readiness / cardiac emergency response planning.

*Much of the country was watching – or has followed since – the **collapse of Buffalo Bills’ safety, Damar Hamlin, on Monday Night Football**. Fortunately, Damar’s story had a happy ending. Our goal is to maximize the opportunity for everyone to have a similar outcome should they experience a Sudden Cardiac Arrest. Most organizations will not have the resources that the NFL does to ensure player safety, but there is much that can be done, especially with proper planning.*

*Some data suggests that **nearly 1% of schools will be the site for an out of hospital cardiac arrest annually**. For a variety of reasons, rural areas are disproportionately impacted by both rates of cardiac arrest and poor outcomes. We know that prepared and equipped schools mean better outcomes for staff, students, visitors, and the communities that so often gather in school spaces.*

We have recently built out/updated a variety of tools to assist schools – and other organizations – with their cardiac readiness. These include:

- *Sample Cardiac Emergency Response Guidelines and Plans.*
- *A toolkit to maximize the impact of AED placement and implementation.*
- *Training and awareness tools to help with Hands-Only CPR knowledge for staff and students.*
- *A revamped, training site search feature, for coaches, nurses, and others who need CPR certification.*
- *In some cases, we may have – or be able to help secure – financial resources to help schools with purchasing/maintaining AEDs, CPR mannequins, etc. Hearing the scope of that need can help us secure additional resources, so please let us know!*

Farm to School Network Takes Root in Nebraska

The Nebraska Department of Education, Center for Rural Affairs, Nebraska Extension, Buy Fresh Buy Local, and No More Empty Pots are pleased to announce the establishment of the Farm to School Network in Nebraska. The network aims to increase access to fresh and nutritious foods in Nebraska schools and strengthen connections between local farmers, educators, and communities.

To build this network, a Network Development Committee and Advisory Committee will lead the process and guide stakeholders to create a strategic, collective action plan that will move farm to school forward in Nebraska. The Network Committees are made up of representatives from key organizations and institutions across the state and are focused on breaking down barriers standing in the way of implementing farm to school initiatives.

The Network Committees will begin the network building process with mapping community assets, phase one

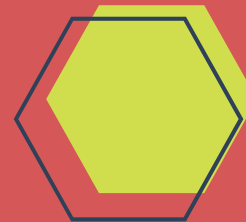

Official Association Endorsements – as of September 1



The National Rural Education Association’s Legislative Committee (of which NRCSA is a member) continues to represent rural education on the Federal level. NRCSA Executive Director Jack Moles and NRCSA Legislative Committee Co-Chair Bryce Jorgenson (Supt. at Southern Valley) attended the NREA Federal Legislative Summit in Washington DC on April 28-30.

Bryce and Jack met with the offices of each of Nebraska’s contingency in Congress. They specifically shared three points of emphasis with them:

- Copies of NREA’s publication, “Why Rural Matters” was presented to each of the offices.
- Full funding of IDEA was stressed. This would bring about \$171 million more to Nebraska public schools in support of Special Education services.
- Passage of the Secure Rural Schools Reauthorization Act of 2023. This would bring about \$180,000 to school districts surrounded by tax-exempt public lands.

A brief description of the six NREAC legislative priorities are as follows:

1) EDUCATION FUNDING: NREA seeks preservation of critical federal funding for rural schools.

2) REAP FUNDING: NREA urges Congress to increase funding to Title V, Part B of ESSA, the Rural Education Achievement Program, with a specific increase to the Rural Low-Income School Program.

3) INFRASTRUCTURE: NREA supports efforts to ensure any infrastructure proposal in Congress must include funding for modernizing or maintaining rural school facilities.

4) FOOD AND NUTRITION: NREA supports any effort to streamline processes and reduce the administrative burdens related to school meal programs.

5) SCHOOL SAFETY: NREA supports flexible federal formula funding streams that channel resources to rural school districts for school safety that recognizes the geographic and economic challenges in rural communities.

6) BROADBAND AND CONNECTIVITY: NREA believes access to high-speed internet is critical for providing equitable access to learning for students in rural schools. As such, NREAC strongly supports maintaining E-Rate as an element of the Universal Service Fund in its current funding structure.

The Committee for Education Funding (CEF) is a group that the NREA Legislative Committee works with. Sarah Abernathy, CEF’s Executive Director, provided an update following in November’s elections. She does provide a decent overview of what the national landscape might look like moving forward. (Please note that all of CEF’s views do not necessarily reflect all of the views of NREA or NRCSA.)

FROM SARAH:

I. The election and CEF’s mission to support investments in education

Dear CEF Members:

As we digest the results of yesterday’s election and wait to find out which party will lead the House in the 119th Congress, I imagine many of you are focused on what this means for governing in general and for education funding and policy in particular. We will certainly be facing a more challenging environment for investing in education and for ensuring that the

federal government supports and protects students, educators, and education institutions as the country continues to educate students of all ages. CEF's mission to increase the federal investment in education will not change, but we'll have to focus more on defense against funding cuts. We will continue to point out the results of education investments – for students immediately and for economic growth in the long term. We will need to communicate well, broaden our community of advocates, and target our efforts so they are as effective as possible.

Things to keep in mind – I generally hope for the best but try to prepare for the worst. I wasn't prepared for last night, but just made a list of some things I expect from a Trump Administration's education agenda, and how likely they are to happen. Key things to keep in mind:

Congress did not enact past Trump budgets that cut education funding – In fact, Congress ignored the Trump Administration's requested steep cuts and increased education funding. I don't expect education funding increases now but do know that Members of Congress do not want to vote for bills that will cost jobs in their district or harm their constituents. One of our jobs will be to continue to highlight why investments in education are so important to those who need to be convinced.

It is hard to make big changes in government quickly – Some Republicans want to eliminate the Department of Education, while continuing many programs at lower funding but in either the Department of Labor or in Health and Human Services. This type of change is hard to enact. There do appear to be some executive actions that would eliminate civil servant positions, and it's easy to shrink a government agency by not hiring behind staff who leave. If Republicans keep control of the House next Congress, they could use the budget reconciliation process to fast-track passage of tax cuts and cuts to entitlements, since reconciliation bills need only a majority in the Senate, not the customary 60-vote margin to pass.

Administrative/regulatory agendas change with each Administration – Since recent presidents have not been able to enact much of their agendas because they often split power with Congress, each successive administration has made changes with executive action, which are then reversed by the next administration. A Trump administration is likely to reverse Biden Administration student loan debt relief executive actions and impose new ones that support

their agenda, such as limiting Diversity, Equity, and Inclusion requirements, limiting transgender student participation in sports or protections at the school level, and changes in interpretation of student civil rights protections.

Possible Republican policy agenda focused on the private sector (except for IHEs) – Conservative theory tends to support the private sector as a more efficient than the public sector for accomplishing goals, and I'd expect to see a renewed focus on support for private school vouchers that families could use toward private school education, more tax policy supporting private school tuition, and "local control" for public schools. At the higher education level, Republicans are likely to sharpen their attention to college admission policies, protections for freedom of speech, policies regarding civil rights, and taxation of endowments. This can occur through appropriations and tax policy (forbidding federal funding if a recipient does a certain thing or requiring a certain action to receive federal funding), and through oversight hearings and federal administrative actions, among other actions.

What's next?

Changes in House and Senate party and committee leadership – We'll know more after all House races are called. The Washington Post has a handy list of the current Republican and Democratic seats most likely to change party, and ACG Advocacy is updating its own list of seats still to call, which I'll share. Meanwhile, I've attached a document that ACG prepared on Friday showing who is in line to head each Senate and House committee for each party depending upon who is in the majority, and who is in line for party leadership positions. Republicans plan to hold leadership elections next week, although the House could push its schedule back depending on what is known about all the remaining elections still to be called.

FY 2025 appropriations likely not finalized in December – The government is operating on an extension of fiscal year (FY) 2024 funding that expires on December 20. I think it is now likely that Congress will not finalize FY 2025 appropriations bills by then and will instead extend funding into next Spring (this is what House Speaker Mike Johnson (R-LA) supported when the current 3-month extension was enacted in September), giving the new Republican Administration and Senate more say in the outcome. That outcome does not bode well for investments in education; the current bipartisan appropriations bill approved by the Senate Appropriations Committee includes \$12 billion more for the Department of Education programs than the

Republican bill approved by the House Appropriations Committee.

Two years ago, NRCSA began a Principal Search Service.

This service is patterned after our successful Superintendent Search Service. Two options are available. Both options will involve NRCSA consultants recruiting candidates for the position. One option will involve the NRCSA consultant making background calls, while the reduced version of the service will place that role with the Superintendent. UNL Tuition Discount & GOLD Grant

We have a new tuition discount program aimed at better serving folks from rural districts who are seeking school leadership degrees (MEd – principalship, EdD – superintendency)– or endorsements. The program provides a 15% tuition discount for educators who serve in NRCSA member districts or are in an area classified by NCEES as rural or town. Led by the UNL Department of Educational Administration, the *Growth-Oriented Leadership Development (GOLD) Project* is a collaboration across NCSA, NRCSA, ESUCC, and NDE. Goals include:

- Developing current and future leaders in a grow-your-own model
- Strengthening School Leadership
- Improving Principal and Teacher Retention

GOLD Highlights:

- A focus on local, building/district level context, not a top-down, one-size-fits-all approach

Chadron State College Special Education Para-to-Teacher Program Initiative.

Purpose: This “Grow Your Own” Special Education Teacher program is designed to provide school districts with the opportunity to cultivate and participate in the training of their para-professionals who wish to continue their education to become special education teachers.

Who: Any individual who holds a minimum of an Associate’s Degree (or equivalent credit hours) from an accredited higher education institution, and who is employed as a para-professional within a school district. What: Chadron State will provide required course work and enrichment activities via online, face-to-face (via Zoom), and on the job experiential learning, leading to a Bachelor’s in Education Degree, and a Nebraska Teaching Certificate with an endorsement in Special Education (grades PK-12). With administrator input, program course work will be tailored to best fit your district practices and expectations. Each course will be offered in an 8-week format, with 12-13 credit hours to be completed each 16 week semester.

How: Program participants will be advised, monitored, and supported by CSC faculty/staff, and a CSC Education Program liaison is specifically assigned to facilitate their progress. District para-professionals may enter the program at any time in the academic year.

When: once participants reach their senior academic year they will embark on completing their capstone course work, via online and Zoom class sessions. This

course work has been pared down considerably with the understanding and assumption that these student teachers will be learning “on-the-job”. For example, one section covers classroom management practices. Clearly, one can argue and attest that these student teacher interns are learning more about managing a classroom from being mentored by veteran teachers within your school, and observing them in action. This is the belief and learning approach embraced during this senior year. However, to ensure and assess concept learning, Chadron State faculty will be meeting with your student teacher cohort twice per week for 1.5 hours, via Zoom conferencing technology.

Graduation: At the completion of this program students/candidates graduate from Chadron State College, and apply for teaching licensure resulting in a valid initial teaching certificate with and endorsement in PK-12 Special Education. Chadron State’s education program is nationally and State accredited. As such, interstate certification reciprocity is not a problem.

Things for your consideration:

- 1) To qualify for this program participants must hold at least an Associate’s Degree or the equivalent in college credit hours. (*CSC will work with those applicants to provide them with the needed coursework leading up to program entry*).
- 2) Districts must agree to maintain para-professional employment throughout the course of the program—including during the student teaching experience.

The UNL Department of Educational Psychology has received a grant from the Swanson Foundation which allows them to offer mental health services to rural schools.

From Dr. Michael Scheel, Chair of the UNL Department of Educational Psychology:

The UNL Department of Educational Psychology would like to offer counseling and psychological services, as well as consultation services to the schools and communities of Southeast Nebraska. We run a mental health counseling and therapy clinic and we are offering counseling and consultation services to teachers, administrators, students, and community members of Southeast Nebraska. Services will be

provided through remote and confidential means (i.e., Zoom conferencing). We are hoping that schools, families, and individuals contact us to schedule an appointment for a telehealth counseling or consultation session.

We have recently learned that a donor will support our work with individuals living in rural Southeast NE by paying all fees for services. Thus, whoever seeks out our services will simply have to indicate they live in Southeast Nebraska, and any services we provide will be paid for through the UNL Foundation. Individual, couple, and family counseling will be provided without financial expense. Additionally, we can provide teachers, school administrators, school counselors, and school social workers consultation services for students of their schools without charge.

We are very excited to enter a partnership with schools and communities of SE Nebraska to promote mental health and well-being. We are aware of the mental health counseling disparities that exist in Nebraska rural areas, and our department, our College of Education and Human Sciences, and UNL are highly interested in offering our expertise and resources with the goal of enhancing the well-being of SE Nebraska individuals, schools, and communities. We are a group comprised of licensed psychologists and psychology graduate students who regularly provide services through our clinic to the Lincoln community. We are seeking to reach beyond Lincoln to connect more with surrounding rural areas. We also are acutely aware of the importance of addressing mental health concerns right now as we all are experiencing the stress of going through the COVID-19 pandemic.

The Counseling and School Psychology Clinic is a training clinic in which graduate students in counseling and school psychology work with clients under the supervision of licensed psychologists. Services are available to all on a sliding scale. For clients from SE Nebraska communities, services will be paid for through UNL Foundation funds supplied by a donor who cares deeply about the welfare of schools and communities in SE Nebraska. Counseling services are offered to improve well-being, improve academic and behavioral issues, stabilize mood, manage stress, and improve life-adjustment issues.

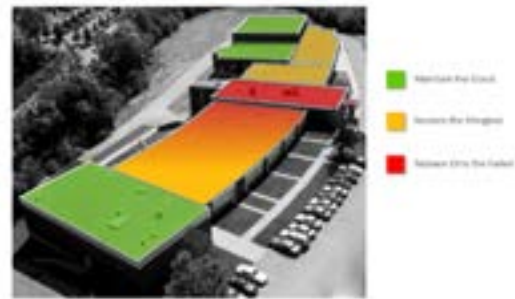

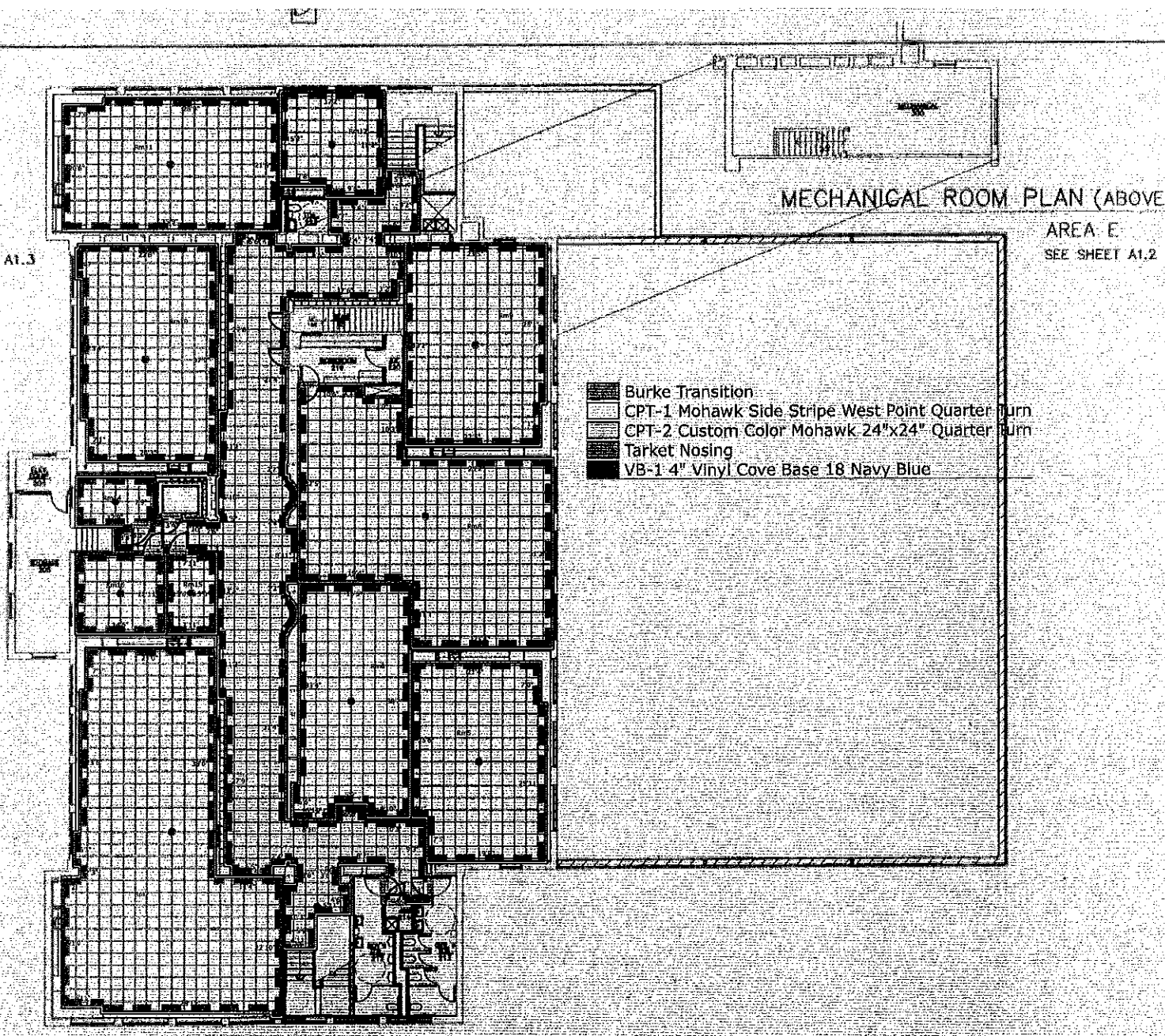

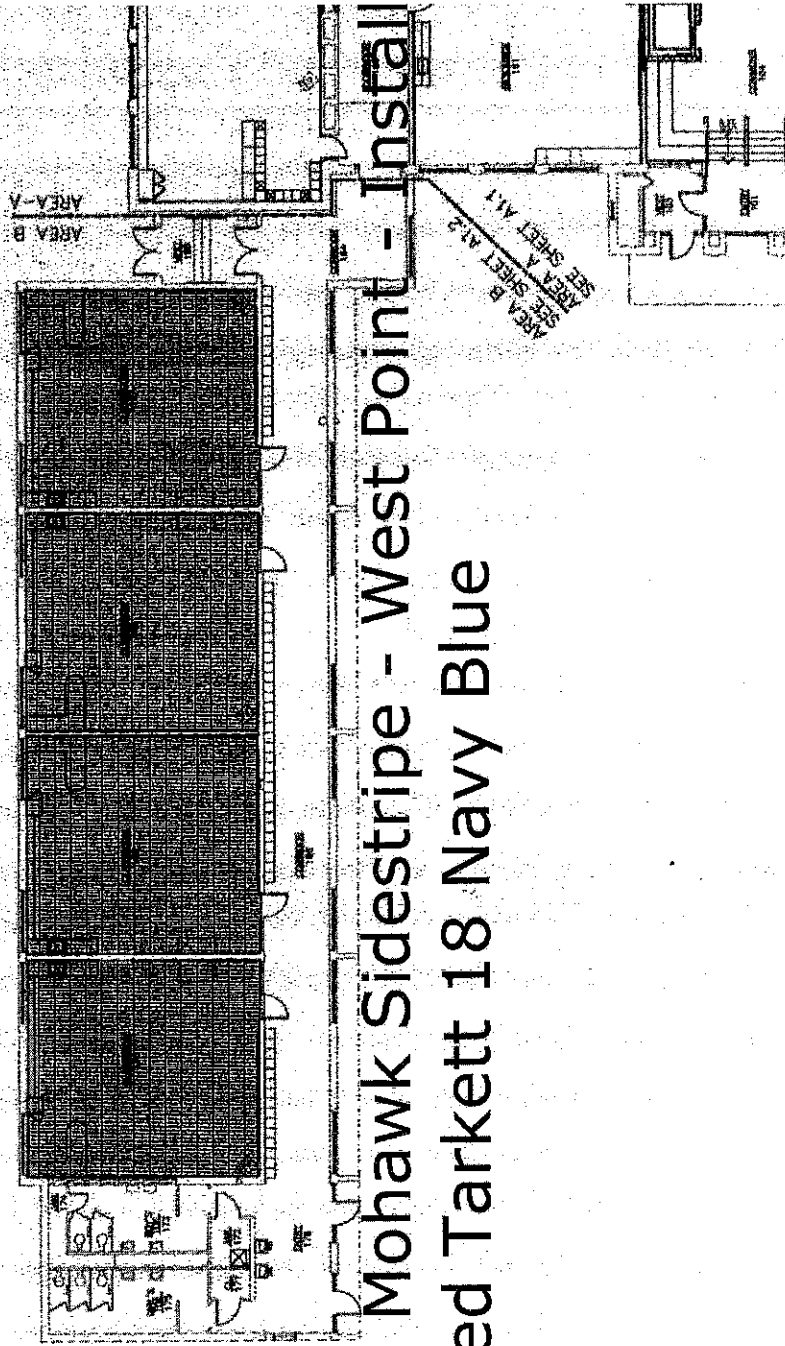
