**ADMINISTRATIVE RECOMMENDATION:** We recommend approval of the purchase of Furniture, Fixtures, and Equipment for seven (7) school sites: Shawnee High School, Shawnee Middle School, Horace Mann Elementary, Jefferson Elementary, Sequoyah Elementary, Will Rogers Elementary, and Shawnee Early Childhood Center. All purchases to be made through a state contract, TIPS or TOPS vendor.

**RATIONALE FOR RECOMMENDATION:** The allocations for FF&E purchases were established in the 23-24 school bond monies to allow the purchase of furniture, including but not limited to student desks, teacher desks, tables, etc., fixtures, including but not limited to blinds, trash receptacles, etc. and equipment, including but not limited to radios, charging carts, etc. All FF&E purchases will be made through a state contract, TIPS or TOPS vendor as approved by the state.

**FINANCIAL IMPACT AND FUNDING:** Project to be paid from Bond Funds in the following amount: \$1,275, 000 utilizing a state contract, TIPS, or TOPS vendor.
