B.1. Valuation Review

We have received the final valuation from the Sarpy County Assessor. General Fund valuation has risen about 9% since 2023 (8% in the Bond Fund). The proposed budget recommends a General Fund tax levy of \$1.037567, and a Bond Fund levy of \$0.12, For a total levy of \$1.157567. This is a decrease of \$0.012433 overall.

B.2. Hearing to Set Final Tax Request

Notice of the hearing was published in accordance with Nebraska statutes. The proposed property tax request and rate to be used for the 2024-25 school year were included in the hearing notice. A copy of the notice is attached.

Based on the 2024-25 proposed budget, the Bellevue School District is recommending \$1.037567 for the General Fund levy and \$0.12 for the Bond Fund. This would cause a decrease in the total levy for people living in the Bellevue Public School District to \$1.157567.
