**2.A. Recognition of Kearney High School Student Emma Heacock for Being Named a 2025 National Merit Scholarship Finalist**

Emma joins an elite group of students recognized for outstanding performance on the Preliminary SAT/National Merit Scholarship Qualifying Test (PSAT/NMSQT). Advancing to finalist status requires meeting rigorous academic standards, submitting a detailed scholarship application, and fulfilling multiple criteria set by the NMSC. She will continue in the competition for Merit Scholarships, with approximately half of the finalists expected to be named National Merit Scholars this spring.

- 2.B. Recognition of Sunrise Middle School Student Aaron Vitales, Who Has Been Selected as Artsonia's Artist of the Week, Grades 7-9, for February 2-8, 2025 - Artsonia, the world's largest online student art museum, recognizes young artists by featuring their work on its platform, helping to foster creativity and appreciation for the arts in schools nationwide. Aaron's artwork was chosen among entries from across the country, and during the contest received an impressive 1,507 votes from website visitors. The winning piece was featured on the Artsonia homepage. Aaron will also receive a special plaque and gift certificates from Blick Art Supplies.

**2. Recognitions**

**2.A. Recognition of Central Elementary School Being Named a National Elementary and Secondary Education Act (ESEA) Distinguished School By the State Education Agency in Nebraska**

- Mrs. Teresa Schnoor, Central Elementary School Principal, thanked the Board for recognizing their award from the ESEA. Mrs. Schnoor reported that they would be receiving this award in Austin, Texas, at the National ESEA Conference, February 19-21, 2025. Many Central Elementary School staff were in attendance, many of whom will be going to Austin to accept this award along with Mr. Mundorf and Mrs. Paider.
- Mrs. Schnoor mentioned that they are earning this award for exhibiting exceptional student performance and academic growth. Central Elementary School is one of two schools in Nebraska selected for this award.
- Mr. Icenogle congratulated Mrs. Schnoor and all teachers and staff at Central Elementary School. He added that only 69 schools were selected nationwide, which is proof of what an achievement this is.

#### 2.B. Recognition of Kearney High School Senior Drew Welch For Achieving a Perfect Score on the ACT

- Mr. Jeff Ganz, Kearney High School Principal, addressed the Board and said that he is extremely honored to be here to highlight one of the truest examples of excellence at Kearney High School. Drew Welch achieved a perfect score on the ACT and was awarded the Presidential Scholar's Award by Dr. Jeffrey P. Gold, M.D., president of the University of Nebraska System, at a formal recognition ceremony at Kearney High School on January 22, 2025.
- The Presidential Scholars program provides a full-ride academic scholarship, along with a \$5,000 annual stipend to every high school senior graduating from a Nebraska high school who earns a perfect 36 on the ACT and attends college at the University of Nebraska.
- Drew Welch addressed the Board, and when asked by Mr. Icenogle what his plans are for his field of study, he reported that he is going into pre-medicine and will hopefully go to medical school. Mrs. Smallcomb congratulated Drew and added that she admires his drive.

### 3. Presentations

#### 3.A. Presentation by Chance Waggoner, Park Elementary School Principal on Student Leadership

- Mr. Chance Waggoner, Park Elementary School Principal, presented information about their Student Leadership Program that begins in 5th grade. Research has shown that when schools provide these opportunities to students, they are more empowered, they take more ownership in their school and their community. They work on collaboration skills, and their academic growth is outstanding. The benefits are exponential.
- The process of becoming a student leader is quite extensive. Students are required to fill out an application and explain why they would make a great leader and provide examples of when they were kind, respectful and responsible. Their parents sign the application along with two different Park staff members. Once accepted, they need to work hard every day to maintain their leadership position, by getting good grades and no office referrals.

- Panther Packs are mixed grade level groups with the goal of fostering relationships and building a community at Park Elementary.
- Students addressed the Board and spoke about their favorite things to do as a Student Leader. Board members asked the students a few questions and congratulated them on being selected.

### 3.B. Construction Update

- Kent Cordes, with BD Construction, updated the Board on progress made at Horizon Middle School and Windy Hills Elementary School.
- The Horizon Middle School project is on budget, and all work is complete except for installing partitions in the showers, which will be completed when schools are closed on February 20-21, 2025. The Windy Hills Elementary project is on schedule to be mostly complete by the middle of June and is trending under budget.
- Jacob Sertich, Architect with Wilkins Architecture Design Planning, gave an update on the Kearney High School South Addition and Central Elementary School entrance. Close to 200 bids have been submitted between the two projects.

## 4. Legislative Update

- Mr. Mundorf reported that a total of 733 bills were introduced this year, with about 100 of those bills being education related.
  - LB 135 - restricts the ability of a school district or ESU to have a bond election outside the general election cycle every two years. This is problematic because when you have construction condensed into one work schedule there will be supply chain and work force challenges. We are in opposition of this bill.
  - LB 149 - would allow suspensions for students in kindergarten through second grade. We support this bill because there are times students kindergarten through second grade have a situation significant enough that would warrant an out of school suspension, at least for a period of time.
  - LB 624 - would appropriate funds from the state treasurer directly to educational scholarships and private school funding. We are opposed to any allocation of educational funding and public dollars going to private school funding.
  - LB 645 - the state would eliminate their 2% contribution to the Teacher Retirement System. We are in opposition of this bill.
- Mr. Blessing gave an update on a few additional bills.
  - LB 303 - would lower the local effort rate by 3 cents and increase state aid. This wouldn't impact us positively or negatively in a huge way.
  - LB 390 - would require schools to provide card catalog access and an opportunity to receive email notifications of checked-out books. KPS has a policy in place now, where parents can opt in to receive a phone call to give permission for their student to check out a particular book. Parents can decide if they do not want notifications or if they want a phone call. Mr. Blessing stated that he likes the option of an email letting the parent know what books were checked out.
  - LB 140 - would ban cell phones during the school day. This bill gives local school boards some discretion about how it's enacted, which is already the case.

The NASB opposes this bill due to local control issues and feels it does not need to be a state law.

- LB 161 - would increase the state aid factor for pre-kindergarten students from 0.6% to 1.0%.
- LB 500 - would re-establish a Finance Review Commission to interface with the legislature on school finance issues. This commission would be made up of school finance directors, superintendents and legislative representatives. The NASB would like to request that at least one board member be included on that commission also.
- LB 428 - relates to student surveys and would require school districts to notify parents before any non-anonymous survey is given to students specifically about risky behaviors, including smoking, drinking, sexual orientation, religion, and political affiliation. KPS already notifies parents before all surveys.

## Students

### Full-time and Part-time Enrollment

Students must be enrolled in Kearney Public Schools on a full-time basis. Full-time basis is defined as attending classes for the full instructional day within the public school system.

Exceptions are permitted only for:

1. Enrolled students attending another state accredited institution such as a vocational-technical school or a college or university for school credit;
2. Enrolled students taking the limited number of credits needed to graduate in the school year;
3. Enrolled students in need of modified school attendance as an accommodation for a disability or similar unique circumstance;
4. Enrolled students receiving special education services where the student's IEP requires a modified schedule, or non-enrolled students receiving special education services or other legally mandated services required to be provided to eligible resident children under state and federal laws and regulations;
5. Students from other school districts participating in programs offered by the District pursuant to an interlocal agreement or other arrangement approved by the School Board; and
6. Non-public school students in accordance with the policies and procedures set forth in this policy.

### Part-Time Enrollment of Non-Public School Students –

The School Board shall allow the part-time enrollment of students who are residents of the school district and who are also enrolled in a private, denominational, or parochial school or in a school which elects pursuant to section 79-1601 not to meet accreditation or approval requirements. Such students are referred to herein as "non-public school students."

The School Board establishes the following guiding principles for enrollment of non-public school students:

- (1) The primary school for a non-public school student is the student's private, denominational, parochial or home school.
- (2) Enrollment of a non-public school student in Kearney Public Schools is allowed for the purpose of providing enhanced educational opportunities not otherwise available to the non-public school student. It is not to supplant programming of the student's primary school.
- (3) Non-public school students are not to be given priority over full-time students.
- (4) Non-public school students are to be enrolled only in programs or courses that are educationally appropriate for the student.
- (5) Enrollment of non-public school students is not to negatively affect the educational services to be provided to full-time students.

The School Board establishes the following specific policies and procedures for enrollment of non-public school students. In the event the specific policies and procedures require interpretation or do not fully resolve an issue, the above established guiding principles are to be considered.

A. Non-Public School Student Enrollment Application Procedures -

1. Application. Parent or guardian must submit an Application of Non-Public School Student for Part-Time Enrollment to the principal of the school the student desires to attend.
2. Deadline for Applications. The application must be received by September 1st preceding the school year the student wishes to enroll.
  - a. Change of Residence Exception: The application deadline for a student who becomes a resident of the District after the school year has commenced is: 20 calendar days after the student becomes a resident of the District. The principal may delay enrollment until the next following quarter or semester starts, or at such other time as determined to be educationally appropriate.
  - b. High School Course Exception: The application deadline for a student who desires to enroll in a second semester high school course is December 15th.
3. Action on Applications. The principal will review the application and will notify the parent of the approval or denial of the application within 2 weeks of receipt of the application or 2 weeks prior to the start of school or 2 weeks prior to the start of the next semester, whichever is later.
4. Appeals. The parent or guardian may appeal the principal's action to deny their application. Any such appeal must be submitted to the Superintendent within 14 calendar days from the date of the principal's action. The appeal shall be in writing and shall be decided on the basis of the written submission. The Superintendent may request the parent or guardian to provide further explanation or information and the appeal may be denied in the event the parent or guardian fails to fully respond on a timely basis. The Superintendent shall decide the appeal within 10 calendar days of the submission of the appeal. The Superintendent may make a decision later than the 10 days in the event a good reason for delay exists. Good reason includes but is not limited to the Superintendent being unable to gather the information the Superintendent determines necessary to make the decision within the decision period.
5. Annual Applications. Part-time enrollment is determined annually. Application must be made each school year. There will be no guarantee that enrollment will continue from one year to the next.

B. Non-Public School Student Admission -

1. Admission Requirements. Students must meet the normal admission requirements. This includes the requirements that the student: be a resident of the District, be of school attendance age and not have graduated or have received a GED.
2. Admission Process. Students must complete the normal enrollment - process and forms required by the District and/or the building for enrollment of all children. This includes the requirements relating to: birth certificates, immunizations, physical examinations, and visual evaluations.

### C. Non-Public School Student Enrollment Standards –

1. **Maximum Enrollment.** Students may not enroll in more than 2 middle school classes during any one semester. Students may not enroll in more than 24 credit hours in high school per semester. Elementary students may not enroll in programming of greater than 90 minutes of instruction each day.
2. **Capacity Limits.** Enrollment will ordinarily be subject to capacity limits. Any grade level, program, or course which has been determined to be at capacity for option enrollment purposes will not ordinarily not be available for non-public school students.
3. **Integrated Courses.** Students must meet prerequisite requirements to be enrolled in a course by appropriate credits earned through an accredited program. The principal may on a discretionary basis allow prerequisite requirements to be satisfied where the student provides reasonable indications that the academic criteria have been met, such as results from achievement tests or other indications of adequate preparation.
4. **Educationally Appropriate Programs and Courses.** Students will not be allowed to enroll in programs or courses which the school administration determines to not be educationally appropriate for the student. Determination of whether a program or course is educationally appropriate will be made based on the standards the District uses for making academic placement decisions.
5. **Selection of Courses.** Subject to Paragraphs 1 through 4 of this Paragraph C, and all other applicable provisions of this Policy, non-public school students may select their courses.

### Non-Public School Student Policies –

1. **General Standard.** Non-public school students who are enrolled part-time are to be subject to the same standards as full-time enrolled students except where appropriate to reflect their part-time status.
2. **Building assignment.** Students must enroll in the attendance center that serves the student's residence, provided that the administration reserves the authority to make a different attendance center assignment. A student may request assignment to an attendance center other than that of the student's residence under the intra-district transfer procedures.
3. **No Partial Part-Time Enrollment.** Students must apply for enrollment and attend the entire school year for which enrollment is made or, for high school courses, for the full length of the course. Once enrolled, part-time students will be required to participate in all activities, programs, and tests related to the program or course for which the student is enrolled, including as applicable state or district-wide assessments, as full-time students.
4. **Student Conduct Policies.** Students enrolled on a part-time basis shall be required to follow all school policies that apply to other students at any time the part-time student is present on school grounds or at a school-sponsored activity or athletic event. This includes the District's student conduct policies. Students enrolled on a part-time basis shall be subject to discipline, including suspension or expulsion, for violation of student conduct rules.
5. **Attendance.** Students enrolled on a part-time basis are not exempt from the compulsory attendance laws or from the District's attendance policies. Students who engage in excessive absenteeism as defined in Board policy are to be reported under the truancy laws.

6. Presence on School Grounds. Students enrolled on a part-time basis are to be present on school grounds during the school day only at the times required for their attendance in the program or course in which they are enrolled. Exceptions may be made in the discretion of the principal or the principal's designee. Students must sign in and out of the school by following the building level procedure. Students are responsible for being aware of any changes in the school schedule during inclement weather or for other reasons.
7. Transportation. Students enrolled on a part-time basis are not entitled to transportation or transportation reimbursement, unless otherwise required by law. Full-time students will be given first consideration for parking on the high school campus.
8. Academic Honors. Students enrolled on a part-time basis will not be eligible to graduate or receive a diploma from the District or receive academic honors (for example, class rank and honor roll) except to the extent the student meets all requirements of the District's policies for such, including attainment of minimum credits and semesters of attendance.
9. Extracurricular Activities. Any student who is a resident of the District and who is enrolled in a school which elects pursuant to section 79-1601 not to meet accreditation or approval requirements may participate in any of the District's extracurricular activity programs to the same extent and subject to the same requirements, conditions, and procedures as a full-time student in the District. The District's Activities Director will coordinate with the student's parent or guardian to secure assurances of compliance with these expectations. Any student covered by this subsection must enroll in five (5) credit hours through the District in any semester.

There shall be no preference given to any student participating in any extracurricular activity based off their status as a full-time or part-time student. Part-time students will be expected to comply with the same or similar expectations as full-time students to participate in any activity, including team rules.

Participation in activities that are subject to the bylaws of the Nebraska School Activities Association (NSAA) will be limited to those students who meet the NSAA bylaws.

### Grades/Assessment

Students transitioning from non-public schools shall receive report cards and transcripts; however, class ranking and grade point averages shall not be computed for part time students as comparison for class ranking. Non-public school students shall participate in all district assessments that are a part of the class/course in which the student is enrolled.

### Official School Transcripts

Credits may be acknowledged for documented non-public school curriculum satisfactorily completed by the student for purposes of placement and graduation. The transcript record of the non-public school curriculum may be written into the official transcript records of the Kearney Public Schools, noting that the courses were completed in a non-public school setting. Grades awarded to the student for completion and evaluation of the non-public school curriculum shall not be utilized in the calculation of the student's grade point average (GPA) or in determining class rank.

### Graduation Requirements

All students of the District shall meet the graduation requirements of the Kearney Public Schools including the course and credit requirements. Non-public school transcripts shall be analyzed and such courses or curriculum may be allowed as meeting program requirements. Courses completed in the non-public school setting shall be so marked. Acceptance of all courses credited may not be approved for all non-public school curriculum, depending on review by the school counselor considering comparative district coursework and requirements.

A non-public school student must be in attendance during the semester prior to graduation in order to receive a diploma from Kearney High School.

## Students

### Full-time and Part-time Enrollment

Students must be enrolled in Kearney Public Schools on a full-time basis. Full-time basis is defined as attending classes for the full instructional day within the public school system.

Exceptions are permitted only for:

1. Enrolled students attending another state accredited institution such as a vocational-technical school or a college or university for school credit;
2. Enrolled students taking the limited number of credits needed to graduate in the school year;
3. Enrolled students in need of modified school attendance as an accommodation for a disability or similar unique circumstance;
4. Enrolled students receiving special education services where the student's IEP requires a modified schedule, or non-enrolled students receiving special education services or other legally mandated services required to be provided to eligible resident children under state and federal laws and regulations;
5. Students from other school districts participating in programs offered by the District pursuant to an interlocal agreement or other arrangement approved by the School Board; and
6. Non-public school students in accordance with the policies and procedures set forth in this policy.

### Part-Time Enrollment of Non-Public School Students –

The School Board shall allow the part-time enrollment of students who are residents of the school district and who are also enrolled in a private, denominational, or parochial school or in a school which elects pursuant to section 79-1601 not to meet accreditation or approval requirements. Such students are referred to herein as "non-public school students."

The School Board establishes the following guiding principles for enrollment of non-public school students:

- (1) The primary school for a non-public school student is the student's private, denominational, parochial or home school.
- (2) Enrollment of a non-public school student in Kearney Public Schools is allowed for the purpose of providing enhanced educational opportunities not otherwise available to the non-public school student. It is not to supplant programming of the student's primary school.

Good reason includes but is not limited to the Superintendent being unable to gather the information the Superintendent determines necessary to make the decision within the decision period.
5. Annual Applications. Part-time enrollment is determined annually. Application must be made each school year. There will be no guarantee that enrollment will continue from one year to the next.

B. Non-Public School Student Admission -

2. **Capacity Limits.** Enrollment will ordinarily be subject to capacity limits. Any grade level, program, or course which has been determined to be at capacity for option enrollment purposes will not ordinarily not be available for non-public school students.
3. **Integrated Courses.** Students must meet prerequisite requirements to be enrolled in a course by appropriate credits earned through an accredited program. The principal may on a discretionary basis allow prerequisite requirements to be satisfied where the student provides reasonable indications that the academic criteria have been met, such as results from achievement tests or other indications of adequate preparation.
4. **Educationally Appropriate Programs and Courses.** Students will not be allowed to enroll in programs or courses which the school administration determines to not be educationally appropriate for the student. Determination of whether a program or course is educationally appropriate will be made based on the standards the District uses for making academic placement decisions.
5. **Selection of Courses.** Subject to Paragraphs 1 through 4 of this Paragraph C, and all other applicable provisions of this Policy, non-public school students may select their courses.

### Non-Public School Student Policies –

1. **General Standard.** Non-public school students who are enrolled part-time are to be subject to the same standards as full-time enrolled students except where appropriate to reflect their part-time status.
2. **Building assignment.** Students must enroll in the attendance center that serves the student's residence, provided that the administration reserves the authority to make a different attendance center assignment. The District's Activities Director will coordinate with the student's parent or guardian to secure assurances of compliance with these expectations. Any student covered by this subsection must enroll in five (5) credit hours through the District in any semester.

There shall be no preference given to any student participating in any extracurricular activity based off their status as a full-time or part-time student. Part-time students will be expected to comply with the same or similar expectations as full-time students to participate in any activity, including team rules.

Participation in activities that are subject to the bylaws of the Nebraska School Activities Association (NSAA) will be limited to those students who meet the NSAA bylaws.

### Grades/Assessment

Students transitioning from non-public schools shall receive report cards and transcripts; however, class ranking and grade point averages shall not be computed for part time students as comparison for class ranking. Non-public school students shall participate in all district assessments that are a part of the class/course in which the student is enrolled.

### Official School Transcripts

Credits may be acknowledged for documented non-public school curriculum satisfactorily completed by the student for purposes of placement and graduation. The transcript record of the non-public school curriculum may be written into the official transcript records of the Kearney Public Schools, noting that the courses were completed in a non-public school setting. Grades awarded to the student for completion and evaluation of the non-public school curriculum shall not be utilized in the calculation of the student's grade point average (GPA) or in determining class rank.

### Graduation Requirements

All students of the District shall meet the graduation requirements of the Kearney Public Schools including the course and credit requirements. Non-public school transcripts shall be analyzed and such courses or curriculum may be allowed as meeting program requirements. Courses completed in the non-public school setting shall be so marked. Acceptance of all courses credited may not be approved for all non-public school curriculum, depending on review by the school counselor considering comparative district coursework and requirements.

A non-public school student must be in attendance during the semester prior to graduation in order to receive a diploma from Kearney High School.
