City Administrator Tom Ourada reported that this is the city's nonprofit arm, registered with the state. This project is intended to create a revolving fund for workforce housing development. A corresponding grant application will be submitted to the Nebraska Department of Economic Development. Council Member Ryan Hinz asked how the city would maintain accountability, how the Council would access information that it is operating as it should, and what checks and balances will be implemented. Ourada stated that the board is governed by the bylaws, and while the council and mayor can't be on the board because they vote on matters this company may participate in, such as LB840 projects, City staff serving as board members would still be accountable to the mayor and council. Additionally, LB840 money and DED money can't be used for anything other than what its approved for. The corporation's accounts will be audited to ensure accountability; expenditures won't go to the council for approval, but reports will go to the council.

Please encourage your Senator(s) to support this important bill: 1) to modernize the way public bodies hold virtual meetings; and 2) to create the statutory framework for public bodies to hold virtual meetings during a declared emergency by the Governor, Mayor, Village Board Chair or County Board Chair pursuant to the Emergency Management Act to consider agenda items, other than those just limited to the emergency. **A complete report on the LB 83 hearing will be provided next week.**

## LBs 159, 162, 163, 25, 44 and 99: First day of hearings in Urban Affairs Committee

As a response to the COVID pandemic, the Legislature is holding standing committees public hearings in both the morning and the afternoon, instead of floor debate in the morning and public hearings in the afternoon. On Jan. 26, the Urban Affairs Committee held its first public hearing of the 2021 session.

In the morning, the Urban Affairs Committee heard three bills. **LB 159 (Urban Affairs Committee)** provides for printing or publishing city and village ordinances in electronic form. The **League** supported this bill because it gives various classes of municipalities an additional option when publishing ordinances. Municipalities are increasingly using technology and allowing them to publish ordinances in electronic form is a welcome addition. This bill advanced to General File.

**LB 162 (Urban Affairs Committee)** provides for a procedure for detachment of real property from the corporate limits of a city or village. Last year, the Urban Affairs Committee advanced, and the Legislature passed, LB 1003, which allowed cities of the second class and villages to annex noncontiguous lands for the purpose of relocating such city or village due to catastrophic flooding. The **League** was in strong support of that bill and appreciates the technical changes contained in LB 162 to clarify those provisions. In the past, the League also has been supportive of provisions to establish uniform procedures for the detachment of territory from the corporate limits of municipalities. This year, the cities of

**Lincoln** and **Omaha** were opposed to the bill, so the **League** submitted a letter in the neutral position.

Finally, the Urban Affairs Committee heard **LB 163 (Urban Affairs Committee)**, which is a clean-up bill for Chapter 18 governing all classes of municipalities. The bill clarifies provisions related to municipal initiatives and referenda; clarifies references to municipalities' corporate limits or extraterritorial zoning jurisdiction (ETJ); corrects references to city, village or metropolitan utilities district (MUD) officials; and eliminates run-on sentences. The bill was advanced to General File with a committee amendment that eliminates the outright repeal of the Municipal Infrastructure Redevelopment Fund (MIRF) Act. Sen. Tom Brandt has introduced LB 600, which uses the MIRF Act to support economic development and job creation projects in rural areas through broadband infrastructure, so the League appreciates the inclusion of this amendment. The **League** supported this bill.

In the afternoon, the committee heard **LB 25 (Wayne)**, which implements provisions of Amendment 2. LB 25 extends the maximum length of time for the repayment of indebtedness related to tax-increment financing (TIF) in certain cases. Under the bill, if more than one-half of the property in the project area is designated as extremely blighted, the maximum repayment period is extended from 15 years to 20 years. Along with the

**League**, the cities of **Lincoln** and **Omaha** supported the bill. This bill advanced to General File.

**LB 44 (M. Hansen)** clarifies that an affordable housing action plan required under the Municipal Density and Missing Middle Housing Act can be adopted either as part of a city's comprehensive plan or as a separate plan. The cities of **Lincoln** and **Omaha** testified in favor of the bill. The **League** submitted a letter of support. The bill advanced to General File.

**LB 99**, introduced by **Sen. Lynne Walz** of Fremont, is a League-supported bill that changes the provisions of the Community Development Act. LB 99 exempts areas declared to be extremely blighted from the percentage limitations on blighted areas. Fremont is a great example of a community that will benefit from the change in LB 99 because of the historic 2019 floods. **Fremont, Lincoln** and the **League** all supported this bill.

## LB 408: Bill to limit property tax growth to 3 percent a year opposed by League and others

**LB 408**, introduced by Albion Sen. Tom Briese, limits the annual increase in property taxes, excluding voter-approved bonds and real growth value, for all political subdivisions to 3 percent. The voters of the political subdivision could override the limit with a majority vote at an election. Real growth value is defined in the bill as “the increase in real property valuation due to (a) improvements to real property as a result of new construction and additions to existing buildings, (b) any other improvements to real property which increase the value of such property, and (c) annexation of property by political subdivision.”

Those testifying in favor of the bill included the Lincoln Independent Business Association, the National Federation of Independent Business and the Platte Institute. All the proponents expressed concern about

the increase of property taxes and spending by political subdivisions.

The opponents to LB 408, in addition to the League, included Lancaster County, community colleges, Banner County, Nebraska Association of School Boards, Omaha Public Schools, Open Sky, Greater Nebraska Schools Association, Greater Nebraska Cities and the Nebraska Association of County Officials.

Letters of opposition were submitted by the Holland Center, Gilmore and Bell law firm, Lincoln Public Schools, Millard Public Schools, and others. All of the entities who testified at the hearing expressed concern about the loss of local control, the impact it may have on bonding, and that inflation is often above 3 percent, which could be devastating for some political subdivisions. The opponents also raised

the issue that political subdivisions are already under levy limits and a lid on restricted funds.

The League will continue to keep its members posted on LB 408 and its companion **LR 22CA**.

## Legislative hot line offered during session

During the legislative session, the Clerk of the Legislature’s Office offers a hot line from 8 a.m. to 5 p.m.

Hot line staff will answer questions about the status of bills or requests for information. This service also is available to any person who is hearing impaired and/or speech impaired. Before 8 a.m., or after 5 p.m. during the week and on weekends and state holidays, callers will hear a recorded message of the next legislative day’s agenda. ### **LB 82: League opposes bill to change motor vehicle tax schedule**

On Jan. 26, the Legislature’s Transportation Committee heard testimony on **LB 82** introduced by Sen. Robert Hilke of Omaha. LB 82 would change the motor vehicle tax schedule so that newer vehicles were charged less taxes and older vehicles were charged more taxes. As written,

the bill would result in a \$829,833 revenue loss to the state. Some of this revenue loss would be passed on to municipalities through the highway allocation formula.

LB 82 was opposed by the League and other political subdivisions because it would result in a revenue loss.

## **LR 22CA: League and others oppose proposed constitutional amendment to limit total amount of property tax revenue to no more than 3% greater than raised in the prior fiscal year with limited exceptions**

On Jan. 27, the Revenue Committee held a hearing on LR 22CA, introduced by Omaha Sen. Lou Ann Linehan at the request of the Governor. [Click here](#) for a link to LR 22CA.

If there are 30 votes in the Legislature to place LR 22CA on the ballot at the General Election on Nov. 22, and if passed by the voters, LR 22CA would provide: ***“the total amount of property tax revenue raised by a political subdivision in any fiscal year shall not be more than three percent greater than the amount raised in the prior fiscal year, except as otherwise provided...”*** There are three exceptions: 1) the total amount of property tax revenue may exceed the limitation of 3 percent **if approved by a majority of legal voters** voting on the issue; 2) the 3 percent limitation also would not apply to the amount of property tax revenue needed to pay the **principal and interest on bonded indebtedness** that has been approved according to law; and 3) the 3 percent limitation also would not apply to the amount of property tax revenue raised by a political subdivision in any fiscal year on any real growth value within the political subdivision.

“Real growth value” is defined as *“the increase in real property valuation due to (i) improvements to real property as a result of new construction and additions to existing build-*

*ings, (ii) any other improvements to real property which increase the value of such property, and (iii) annexation of property by the political subdivision.”*

There were only four opponents testifying in person against LR 22CA due primarily to COVID-19 protocols and because the hearing on LB 408 was scheduled for the same day in the afternoon to accomplish the same purpose in state law (as opposed to the constitution). A **League** representative testified in opposition to LR 22CA with representatives of the **Holland Foundation, Lancaster County** and the **Greater Cities of Nebraska**. There were a number of statewide organizations and others who submitted letters of opposition to LR 22CA, which will be noted on the Committee Statement if LR 22CA advances from committee.

The League emphasized that placing this limit in the constitution would result in no flexibility to address unforeseen circumstances, especially unintended consequences. The League representative also testified the rate of inflation has been above 3 percent five times since fiscal year 2000, i.e., 25 percent of the time the rate of inflation has been above 3 percent in the last 25 years! In addition, the rate of inflation has been above 3 percent 43 times since 1914. The League and others stated that state law already

imposes a lid on “restricted funds” in addition to levy limits; LR 22CA would negatively affect the ability of municipalities to provide services! There was no neutral in-person testimony at the hearing on LR 22CA. The following organizations and individuals testified in person in support of LR 22CA following Sen. Linehan’s opening statement: Gov. Pete Ricketts; Tony Fulton, Nebraska Tax Commissioner; Nebraska Taxpayers for Freedom; Americans for Prosperity; the Lincoln Independent Business Association (LIBA); and President of the Nebraska Farm Bureau, who testified on behalf of the Nebraska Corn Growers Association, Nebraska Dairy Association, Nebraska Pork Producers, Nebraska Cattlemen and Nebraska Soybean Producers. Several farmers and ranchers also testified in support of LR 22CA.

**LBs 38, 456, 604, 520, 455, 398, 338, 600, 460, 656: Transportation and Telecommunications Committee to hear bills related to taking away municipal siting authority over telecommunications facilities and enhanced broadband access**

Public hearings have been scheduled for Monday, Feb. 8, on a number of bills related to broadband access, and stripping municipalities of regulatory authority over the placement of telecommunications equipment. Also, there are several similar bills that have not yet been scheduled for public hearing, but probably will get scheduled Feb. 9.

It is important that your municipality look at all of these measures as soon as possible.

These bills fit into several general categories:

**Bills designed to promote and encourage telecommunications companies to upgrade facilities to broadband speeds.**

**LB 38**, introduced by Henderson **Sen. Curt Friesen** at the request of the Governor is the "Broadband Bridge Act." This bill would allocate \$20 million to expand broadband access by creating a system within the Public Service Commission that would reward companies that will commit to build to 100 megabits per second for downloading and 20 megabits per second for uploading. Bill scheduled for hearing on Monday, Feb. 8, at 9:30 a.m.

**LB 456**, introduced by **Sen. Friesen** is the "Enhancing Broadband Access Act." This bill would allocate \$10 million in a fashion very similar to LB 388 except that the Nebraska Department of Economic Development would have a role in determining where the money was allocated. The bill is scheduled for hearing on Monday, Feb. 8, at 9:30 a.m.

**LB 604**, introduced by Lincoln **Sen. Suzanne Geist**, is the Nebraska Accelerated Broadband Deployment Grant Program Act. This measure would change a number of Public Service Commission processes to accomplish goals similar to LB 388 and LB 456. This bill is scheduled for hearing on Monday, Feb. 8, at 1:30 p.m.

**Bills designed to take away municipal authority over siting of telecommunications facilities.**

**LB 520**, introduced by **Sen. Friesen**, substantially strips a municipality of the ability to regulate the siting and appearance of telecommunications facilities by limiting their ability to use consultants, reducing shot clocks for municipal action and allowing telecommunications companies to add additional facilities to municipal structures that exceed current size limits etc. This bill is similar to the small cell bill that the League opposed a few years ago. This bill is scheduled for hearing on Monday, Feb. 8, at 1:30 p.m.

**LB 455**, introduced by **Sen. Friesen** takes away much of the ability of an electric utility to regulate access to electric poles and electric right of way by telecommunications carriers. Bill scheduled for hearing on Monday, Feb. 8, at 1:30 p.m.

**Bills designed to encourage development of dark fiber.**

**LB 398**, introduced by Brainard **Sen. Bruce Bostelman**, changes the speed standard that the Public Service Commission uses for fund-

ing from 25 megabits per second download and 3 megabits per second upload to 100 megabits per second download and 100 megabits per second upload. This would have the effect of making large portions of the state unserved and underserved and would thus allow public dark fiber installation and leasing without some of the financial barriers in current law. The hearing has not yet been scheduled, but could be scheduled for Feb. 9.

**LB 338**, introduced by **Sen. Bostelman**, allows the PSC to redirect funds to companies that are building higher speed fiber infrastructure. The hearing has not yet been scheduled, but could be scheduled for Feb. 9.

**LB 600**, introduced by Plymouth **Sen. Tom Brandt**, would allow for additional bonding authority for municipalities and power districts to develop fiber infrastructure. The hearing has not yet been scheduled, but could be scheduled for Feb. 9.

**LB 460**, introduced by **Sen. Brandt** would eliminate many of the barriers and impediments to public development of dark fiber infrastructure. The hearing is not yet scheduled, but could be scheduled for Feb. 9.

**LB 656**, introduced by Omaha **Sen. Justin Wayne** would allow a municipality to sell internet services at retail. Hearing not yet scheduled but could be scheduled for February 9<sup>th</sup>.

## LB 339: Proposal would require additional planning for construction projects

**LB 339**, introduced by Brainard **Sen. Bruce Bostelman**, was originally scheduled for hearing Jan. 26, but has been postponed. LB 339 would require that cities of the Metropolitan Class, cities of the Primary Class and cities of the First Class provide a utility coordination plan as part of a street project costing more than \$50,000. Also, the city would be required to compensate a contractor for any damages associated with a deviation from the plan. The bill requires that any contract exceeding \$50,000 for the construction, reconstruction, improvement, maintenance, or repair of a road, street, highway, bridge or other

related structure to which the Department of Transportation or any city of the metropolitan class, any city of the primary class, any city of the first class ... require a utility coordination plan. Such plan would need to identify **any utility operator, its facilities, and the location and elevation of such facilities within the project work area or which are otherwise affected by any construction, reconstruction, improvement, maintenance, or repair project conducted under such contract and the date or dates such facilities will be relocated or removed.** The bill goes on to require that a

contractor performing services under the contract may rely on such plan and **shall be compensated by the Department of Transportation or such city or county for any costs or damages associated with any deviation or failure by the department or such city or county to follow the plan.** **Letters of opposition to LB 339 should be addressed to:**

## Nebraska Legislature: Rules for submitting, presenting testimony to legislative committees

What follows are new rules for participating in legislative committee hearings.

Nebraska's unique Unicameral Legislature relies heavily on the "second house" – the citizens of the State of Nebraska. Ensuring that members of the public have the opportunity to have their voices heard is vital to the legislative process.

The COVID-19 pandemic has created unique health and safety concerns. The Legislature has considered and adopted expanded methods by which the public can provide input into the legislative process so that citizens who have safety concerns about in-person testifying have multiple opportunities to have their voice heard as part of the legislative and committee process.

The following options provide ways for citizens to share their views on a bill with the Legislature. Please read each option carefully, as each has a different outcome as to how your input is recorded.

### **In-Person Testimony**

As always, persons attending a public hearing in person will have an opportunity to present verbal testimony to the committee and be subject to questioning by the committee members. In-person testimony is generally limited to five minutes, although the chair of each committee has discretion to modify that time limit.

Persons verbally testifying will be listed as a testifier on the committee statement, as has been the practice,

and have their position included within the official committee hearing record.

### **Written Testimony In Lieu of In-Person Testimony for Public Hearings during the 2021 Session**

As part of the Nebraska Legislature's procedural modifications in response to the COVID-19 Pandemic, during the 2021 Session, the standing committees will be accepting submitted written testimony for public hearings on a bill or resolution when the following specific procedures outlined below are met.

The intent of this option is to create a substitute for those who are concerned about safety by testifying in person, but wish to have their testimony submitted, name recorded on the committee statement and included in the formal committee hearing record as if they had testified in person. The committee statement will note that the testimony was provided in writing with no opportunity for the committee members to question the testifier.

In order to take advantage of this option, the following six requirements must be met:

**Submission of written testimony only will be accepted between 8:30 a.m. and 9:30 a.m. in the respective hearing room where the bill will be heard later that day.**

Individuals must present their written testimony in person during this time frame and sign the submitted written testimony record at the time

of submission on the day of the hearing on the bill.

The testifier must submit 12 copies. Failure to submit the required number of copies will result in the treatment of the submission as a position letter and not written testimony.

The written testimony must be a written statement that is no longer than two single-spaced, typed pages or four double-spaced, typed pages in length.

Only the written testimony from the person delivering the testimony will be accepted. No handouts, testimony or letters from other individuals may be included outside of an individual's written testimony.

Written testimony will be handed out to each member of the committee during the hearing and made available as part of the hearing transcript when the transcript is made public.

Failure to meet all of these procedures for submitted written testimony will result in the person providing the testimony to not be listed on the committee statement as a written testifier, however, the testimony will be included in the official hearing record as an exhibit.

### **Position Letter**

If you are not testifying in person on a bill or resolution or submitting written testimony in person on a bill (Option 2), but would like to submit a position letter to be included in the official hearing record as an exhibit, you must deliver your letter

to the office of the committee chair or emailed to the committee's email account List of Committee Emails by 12 p.m. CST on the last work day prior to the public hearing.

Letters emailed (and not hand-delivered) will not be included as part of the public hearing record if sent to any email other than the committee's email account List of Committee Emails.

Your letter must identify the bill or resolution, include your name and address, state a position of for, against or neutral, on the bill in question and include a request for the letter to be included as part of the public hearing record.

Please note that mass communications also will not be included as part of the official hearing record

as an exhibit regardless of delivery time or requests to have the communication included.

### **Submission of Online Comments**

In order to facilitate public input on legislation, a new feature has been added to the Nebraska Legislature's website for submission of written statements on pending legislation on the Legislature's website at any stage of the process. (To access this feature, search for the bill you wish to submit a statement on and click the corresponding button near the top of the bill page.)

These submissions will not be considered testimony or part of the public hearing record, but the submitted statements will be available on the UniNet for access by Senators and staff throughout the

session. Please note, there should be no expectation of privacy regarding comments submitted in this format. If a citizen uses the database to submit his or her views prior to the public hearing on a bill or resolution, this option will allow input to the members of the committee prior to any committee votes.

## Questions about hearings, bill status

### **How do I find out when a bill is scheduled for a public hearing?**

The weekly schedule of committee hearings is prepared for publication each Friday during session. The schedule is not available until after the Legislature adjourns for the day. The schedule is available in the

Clerk of the Legislature's office and is published in the Sunday *Lincoln Journal Star*, the Sunday *Omaha World-Herald* and the *Unicameral Update*, the Legislature's weekly newsletter produced during session. The schedule also is included in the League's *Legislative Bulletin*.

### **How do I contact my Senator?**

To write your senator, you need

only to include on the envelope: Senator's name, District number, State Capitol, PO Box 94604, Lincoln, NE 68509-4614.
