- Councilmember Ryan Hinz announced that the open house for the new Cardinal Welcome Center is on November 28, 2021 from 1-3pm and everyone is welcome. Hinz also reported that last month's food bank was very successful, serving over 400 families.
- Public Works Director Brian Stork stated that he's been learning a lot and is excited to continue doing so.
- City Administrator Tom Ourada:
 - Reported a sales tax refund of \$11, 089.
 - Reported that the auditors were here and stated that things were ahead of schedule compared to last year.
 - Requested a cost from Gilmore & Associates to do the sanitary sewer study for the east side of Crete.
 - Reported one response to the Comprehensive Plan RFP Solicitation, which will be reviewed.
 - The police officer candidate we extended the offer to did not meet all the qualifications. A conditional offer was made to another candidate who is now going through the process.
 - Reported that the water and sewer boring on Arizona are done and both passed initial testing.
 - Reported looking into a software package with immense capabilities for multiple departments.
 - Linden Avenue from 19th to 20th has been demoed and will hopefully be ready for presentation next spring.
 - Mentioned 6 different paving projects for 2022 and will put them in the 1 & 6 Year Plan.
 - Reported looking into fire station extension and how to fund that.
 - Reported the Library Board voted to close the library the Saturday after Thanksgiving.
 - Reported holding off on Tuxedo Park planning due to council members being gone.
 - Updated the council on nuisance hearings that were held.

Tom presented a request from Elayne Woods to adjust the monthly rates of parking spaces in the city parking lot at 12th and Norman for smaller volume pricing. Elayne Woods, current owner of The 1206 and Artisan Mark Coffee + Goods, currently has 10 parking spaces priced at \$15 and would like to adjust that to 5 parking spaces at \$20. After much discussion, Dale made a motion to make a recommendation to the City Council to adjust the monthly rates of parking spaces in the city parking lot at 12th and Norman for smaller volume pricing. Dan seconded that motion.

Dan, yes. Dale, yes.

E. 2021 RFP:

Tom updated the Public Works Committee on the status of the 2021 RFP for Solar PV Installations. After review of proposals, MEAN staff has determined that Sandhills Energy, LLC has provided Purchase Power Agreement pricing that is competitive with current wholesale electric rates. The 2021 RFP will be discussed further at the MEAN conference later in the week. No action is needed at this time.

F. Gap Paving 2022:

Tom discussed possible gap paving projects for 2022. With the help of Street Supervisor, Trent Griffin, and PW Director, Brian Stork, six different projects on the North side have been reviewed and will be discussed more in depth when the time comes.

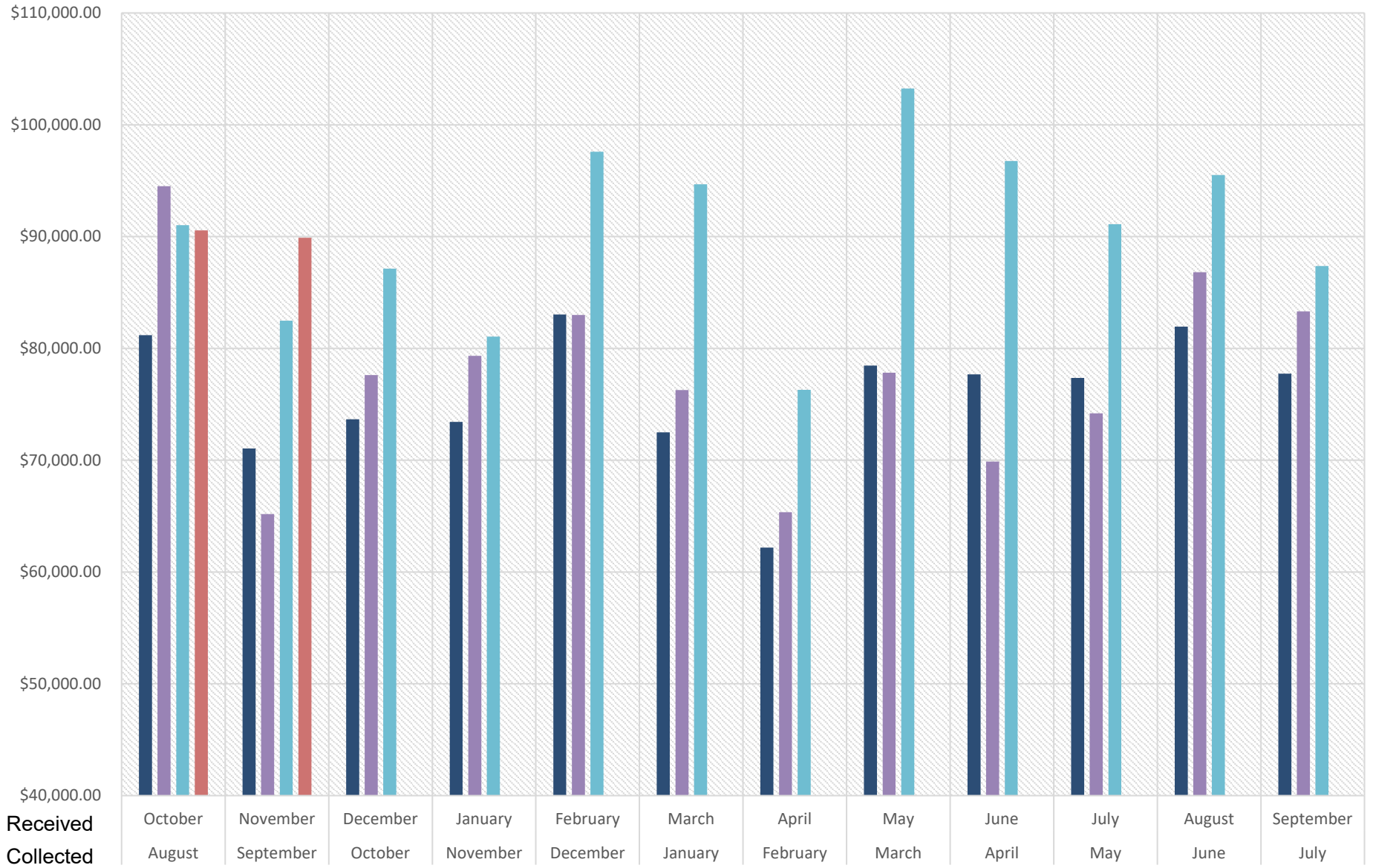



ORDINANCE NO. 2143

AN ORDINANCE OF THE CITY OF CRETE, NEBRASKA RELATING TO WAGES AND SALARIES; TO AMEND ORDINANCE NOS. 2138 AND 2142 TO ADJUST THE WAGES AND SALARIES OF CITY OFFICERS AND NON-BARGAINING UNIT EMPLOYEES OF THE CITY OF CRETE.

one Comprehensive Plan proposal received and it was not what we were looking for. He contacted another company who would be able to start a proposal in March or April, but there are some zoning issues that would need to be addressed prior to that. Ourada recommends waiting until then to make sure we get a plan that works better for Crete.

Reject the proposal from Marvin Planning Consultants. Carried with a motion by Jennifer Robison and a second by Drew Rische.

3.C. Discuss 1 and 6 Year Street Plans.

City Administrator Tom Ourada reported that a good portion of the 1 year Street Plan is done and a lot of the 6 Year Plan will carry over. There was discussion about different parts of town that could use some work and which projects would be financially feasible. Ourada will add the suggestions and bring the plans to next month's meeting to discuss further before the public hearing in January.

4. Officers' Reports

Citizen Ron Sack expressed concerns about the city's neighborhood design standards. He commented that the language is unclear and it needs updating to include new construction standards. Sack asked the Planning Commission to recommend to the Council that the design standards be suspended until they can be reviewed and changed. City Administrator Tom Ourada stated that the Planning Commission cannot take any action on this because it was not on the agenda. It will be put on a future agenda in order to allow action to be taken. As stated in the Comprehensive Plan discussion, some zoning issues need to be addressed prior to the Comprehensive Plan being completed. There was more discussion on specific language and standards issues.

5. Adjournment

1. Open Meeting

The Library has posted a copy of the Open Meetings Act, Laws of the State of Nebraska, in the back of the meeting room. Additional copies are available to read, if anyone wishes one during this meeting, please advise. As each agenda item is considered, if there are any questions concerning the agenda item please advise. The Board may consider items listed on the agenda in random order. This meeting was posted in three public places to-wit: City Hall - 1st Floor Post Office - Lobby City Bank and Trust - Front Entry.

2. Roll Call—Tom King, President called the meeting to order at 1:04pm. Other board members present were Fabiola Dimas, Jared List and Jan Sears. Also present was Joy Stevenson (Library Director), Tom Ourada (City Administrator), and Carrie Wilsman (President of the Friends of the Crete Public Library). Absent: Jim Crouse

3. Consent Agenda—Board will consider approval for the following items. Explanation may occur for each item and the council approves and/or amends the items listed.

A. Minutes of Previous Meeting. Members reviewed and approved the minutes of the October 12th, 2021 meeting; motion by Dimas to accept the minutes seconded by Sears, all in favor.

4. Reports—

A. Friends of the Library—

1. Carrie Wilsman shared that the Friends will have a meeting Thursday, Nov. 11 at 5:30pm at the library.
2. During Friends of the Library week, the Friends had some treats and balloons at the library to share with patrons to celebrate, and they had new members sign up.

B. City Administrator— Ourada discussed the following with the board:

1. Ourada informed the advisory board that the fire department has requested a new building, comparing their situation to that of the library. Ourada shared with the board that despite the comparison between the needs of the library and the fire department, the budget particularities of each entity have been different over the past years. This was shared with the advisory board in case members hear of the fire department's request.

C. Director— Stevenson discussed the following with the board:

1. The library will host a talk by Todd Sears, former president and publisher of *The Omaha World Herald*. The event will take place during the lunch hour, with the food sponsored by the Friends.
2. In December, the library plans to host a movie night for *The Searchers* in the community room. The newspaper will have an ad announcing a “save the date” for the movie night.
3. The *Crete Reads!* program will soon start considering books for next year.
4. Stevenson updated the advisory board regarding the American Rescue Plan grant. Of the \$6,000 grant, \$3,500 were spent on picnic tables for the Crouse Pavilion. There is approximately \$2,500 left to spend. Stevenson will talk to the picnic table vendor about options for umbrellas for the courtyard tables outside of the library. The funds must be used by March 2022.
5. Voluntary Income Tax Assistance (VITA): Doane has officially declined helping with the VITA program. Stevenson has reached out to UNL faculty/students to inquire about the possibility of continuing the VITA program through a partnership with UNL. She is awaiting a meeting with individuals from UNL.
6. Property Tax Relief Program for Seniors: Stevenson is exploring the possibility of helping elderly Nebraskan apply for property tax relief. The program will start in February, so this is still in the planning process.
7. Santa is coming to town. The library will hold drop off letters and Santa will sit in front of the fireplace. Santa will visit the library on Saturday, Dec. 20 to read the letters. It will be filmed then posted on Facebook.
8. Signage: The outdoor signage for Crete Library is in place. The library is still waiting for the remaining indoor signage to be installed.
9. The Friends of the Library budget will be voted upon during their Thursday (11/11) meeting. The Friends budget includes the two new initiatives: the Imagination Library and Hoopla.

D. President: — King discussed the following with the board:

1. King shared the library advisory board Municipal Code for all in attendance and encouraged members to review to better understand the role of the advisory board.
2. King met with Ron Sack to discuss Mac’s bequest to the Friends of the Library. From the conversation, King confirmed that it was a public donation to support the library without any particular earmarks, that she was interested in children programming and might appreciate her gift supporting children programming, and that she would not necessarily be interested in the donation as a means to confer naming rights. In other words, she was not interested in having a room named after her, but rather she was interested in children programming.

5. Special Order of Business—

- A. **Personnel:** Stevenson raised the concern that she will have staff issues for the library on the Saturday after Thanksgiving without having to compel staff to work that day. The library is

closed Thursday and Friday. Stevenson asked the advisory council what the best path forward would be. She provided data from other Nebraska libraries showing which libraries are open and which are closed on the Saturday after Thanksgiving. Out of the discussion, List made the following motion to close the library on the Saturday after Thanksgiving:

Jared List makes a motion to close the library on the Saturday after Thanksgiving and, at the same time, extend the hours on the Wednesday before Thanksgiving to 7pm.

Sears seconded the motion, and the motion passed unanimously by all board members present.

B. Building and Equipment concerns:

1. Discussions continue on citywide policies for keycard access for city buildings. The library has installed the keycard access to the front door and front vestibule doors. Library staff will receive training on how to override the lock/unlock schedule on holiday schedules.
2. Ourada shared that the city will move ahead and explore options for remedying the loose gravel around the library. The CPL advisory board and the city council will review the possible options.

C. Board Duties: None

6. Petitions-Communication- Citizen concern

1. Sears asked about how reserving the community room works. There are still some outstanding pieces before reservations can begin. LB 357 requires an advisory group to meet to set community room policies.

7. Adjournment—Meeting adjourned at 2:00pm motioned by Sears, seconded by Dimas and approved by all. The next meeting will be the second Tuesday of the month: Tuesday, December 14th, 2021, at 1pm.
