- Police Chief Gary Young reported PD being short-handed as they are still in the process of testing for the open sergeant position, as well as testing for two other officer positions.
- Human Resources Director Wendy Thomas introduced two new hires; Maria Acevedo as facilities janitor, and Juan Lopez in bookkeeping for the Utility Department.
- Fire Chief Tod Allen gave a report of the Fire Department's call numbers for 2022; 945 total calls averaging 72 calls a month, 2.5 calls a day. Allen also reported that the department held their officer election meeting and he was re-elected as Fire Chief.
- City Administrator Tom Ourada reported the following:
 - As of January 1, 2023, Gary Young is no longer 'Acting Chief'. He is officially the Police Chief.
 - Blue River Raceway (formerly Tuxedo Park Raceway) is being taken over by new owners, who have reached out to the City for help. We will be working with them to help however we can.
 - Sunday's electrical outage was due to a blown high side transformer fuse. City workers did a great job responding and working quickly to restore power.
 - Ourada is still in contact with the person we are trying to get on board for the Recreation Coordinator/Grant Writer recruitment.
 - Commented how good it was to see the Crete News present at the meeting tonight.
- Mayor Dave Bauer reported the following:
 - Bauer read a thank you note from the Crete Senior Citizens group stating their appreciation of the City for allowing them to use the Wanek Community Center. They are also thankful for the quick responses from city employees whenever they need something.
 - He is working with Saline County Aging Services to bring back a meals on wheels program, which will need volunteers to help deliver the meals when the time comes.
 - Commented on his excitement of the new year and getting some new things started for the community.

Lawmakers convene for 2023 session

Leadership positions shuffle, La Vista Sen. John Arch elected Speaker

Twenty-six members were sworn into office Jan. 4 as the 108th Nebraska Legislature convened for its 90-day first session. That number includes nine re-elected Senators, 16 newly elected Senators — including two members who have served in the Legislature previously — and one newly appointed Senator.

Lawmakers also elected a new speaker and chairpersons of the Legislature's 14 standing committees.

Senators chose La Vista **Sen. John Arch** to serve a two-year term as speaker of the Legislature. Arch, who was unopposed, replaces former speaker **Sen. Mike Hilgers** of Lincoln, who left the Legislature after being elected Attorney General in November. Among other duties, the speaker prepares the Legislature's daily agenda and serves as its presiding officer in the absence of the Lieutenant Governor.

Arch, former chairperson of the Health and Human Services Committee, said his experience in that capacity and as a hospital administrator demonstrates his ability to manage complex relationships and processes. He said Senators need

to emphasize their shared desire for positive outcomes for Nebraskans — including quality education, equal justice under the law and good stewardship of the state's tax dollars — rather than focus on their differences.

"We have a starting point for healthy relationships if we don't forget our agreement on the ultimate goals," Arch said.

Several other Senators also moved to new leadership positions as lawmakers elected new chairpersons to nearly all of the Legislature's standing committees.

Glenvil **Sen. Dave Murman** unseated incumbent **Sen. Lynne Walz** of Fremont to serve as Education Committee Chairperson.

Murman, elected on a 32-17 vote, said Nebraska educators need to

"hammer down on the basics" and that he would be the best choice to work with **Gov.-Elect Jim Pillen** to reform how schools are funded.

"Our state funding for education formula, TEEOSA, must be amended to support more students and more school districts than it is currently," Murman said, adding that only approximately 35.5 percent of all Nebraska schools currently receive state aid and equalization funding.

Sen. Suzanne Geist of Lincoln prevailed in a three-way contest to chair the Transportation and Telecommunications Committee. Geist garnered 29 votes to beat out Plymouth **Sen. Tom Brandt** and Columbus **Sen. Mike Moser** for the position.

Having served for six years on the committee, four as vice chairperson, Geist pointed to her

Clerk O'Donnell retires after 44 years; Metzler takes the reins

Clerk of the Legislature Patrick J. O'Donnell retired at the end of 2022 after serving in the position for 44 years. Prior to his retirement, O'Donnell was the longest-serving active clerk of a state legislature in the country.

O'Donnell was succeeded by Brandon Metzler, who was sworn into office Jan. 4 following his election by state Senators. Previously an assistant clerk, Metzler has worked in the clerk's office since 2017. The clerk must be elected to the position by the full membership of the Legislature every two years.

The clerk's office is responsible for ensuring that all constitutional, statutory and policy requirements are followed when the Legislature

experience working closely with the state Department of Transportation and other stakeholders on broadband issues, aeronautics and innovative funding options that sped up completion of Lincoln's South Beltway project.

"The committee handles a broad span of issues and I commit to be focused on each one of those [from] day one," she said. "I will also continue to encourage debate and out-of-the-box thinking."

Elected chairperson in uncontested races were: Elmwood **Sen. Robert Clements** to the Appropriations Committee; Dunbar **Sen. Julie Slama** to the Banking, Commerce and Insurance Committee; Ralston

Sen. Merv Riepe to the Business and Labor Committee; Albion **Sen. Tom Briese** to the Executive Board; Kearney **Sen. John Lowe** to the General Affairs Committee; Blair **Sen. Ben Hansen** to the Health and Human Services Committee; Omaha **Sen. Justin Wayne** to the Judiciary Committee; Omaha **Sen. Mike McDonnell** to the Nebraska Retirement Systems Committee; and Omaha **Sen. Terrell McKinney** to the Urban Affairs Committee.

The chairpersons of four committees remain the same as last year, with the following lawmakers re-elected in uncontested races: **Sen. Steve Halloran** of Hastings to the Agriculture Committee; **Sen. Tom Brewer** of Gordon to the Govern-

ment, Military and Veterans Affairs Committee; **Sen. Bruce Bostelman** of Brainard to the Natural Resources Committee; and **Sen. Lou Ann Linehan** of Elkhorn to the Revenue Committee.

Senators may introduce bills for the first 10 legislative days, or through Jan. 18.

The session is scheduled to last 90 legislative days, during which lawmakers will craft a two-year state budget and are expected to grapple with prison and tax reform, the state's school funding formula and possible further restrictions on abortion.

The 2023 session is tentatively scheduled to end June 9. ■

LB 33: Sen. Jacobson Introduces League Bill on Mayoral Voting

On the first day to introduce bills in the 108th Nebraska Legislature, **Sen. Mike Jacobson** of North Platte introduced **LB 33** to clarify when mayors can vote in cities of the first and second class. This bill was supported by the League’s Legislative Committees and the Executive Board.

Under the provisions of LB 33, a mayor in a city of the first class or a city of the second class can vote on any matter that requires either a majority of the city council or a majority vote of all the elected members of the city council if:

- (a) The mayor’s vote is required due to the city council being equally divided (in other words, when there is a tie)
- (b) A majority of the city council or majority of all the elected members cannot be reached due

to absence, vacancy, or abstention of one or more city council members.

The new language addresses three concerns that the League has heard about the current language: it allows the mayor to vote when there is a tie, it allows the mayor to vote when a majority of the quorum is needed, and it allows the mayor to vote when a majority of all members elected to the city council is needed.

It is important to note that the bill does not allow the mayor to vote when a super-majority vote of the city council is required.

Thanks to Sen. Jacobson for introducing this very important piece of legislation. The League will continue to update its members on when LB 33 is scheduled for its public hearing. ■

Rules Committee held hearing on 58 proposed changes to the Legislature's Rulebook

On Thursday, Jan. 12, Bayard **Sen. Steve Erdman**, Chair of the Rules Committee, gave opening remarks at the public hearing which started at 1:30 p.m. and ended about 10:35 p.m. The Rules Committee received testimony on 58 proposed changes to the Legislature's Rulebook. Some of the most concerning or controversial proposed amendments to the rules include: 1) ending the secret ballot vote for committee chairs which has been in effect since 1937; 2) limiting Senators to only introducing 12 bills in one year; 3) striking the opening prayer that is given every morning; and 4) eliminating party affiliations.

Although the Rules Committee did not take any action on the proposals Thursday evening, **Speaker John Arch** of La Vista announced on Jan. 13 the Rules Committee has scheduled an Executive Session for Jan. 17; it is anticipated the Rules Committee will file its report with the Clerk of the Legislature on Jan. 18 and provide all Senators a copy of the report. The Speaker also indicated debate on the motion to adopt permanent rules will be on the Legislature's agenda Jan. 19 and continue into the evening, if necessary, with a goal of adopting permanent rules before the Legislature adjourns on Jan. 20.

LB 346: Sen. Brandt introduces bill to redefine qualifying business under the Local Option Municipal Economic Development Act (LB 840)

On Jan. 12, **Sen. Tom Brandt** of Plymouth introduced **LB 346** on behalf of the League. This bill changes what qualifies as a qualifying business under an LB 840 program.

Under the Local Option Municipal Economic Development Act or LB840 as it's often called, municipalities can provide local funds to qualifying businesses to help with economic development. The Act outlines a specific list of what qualifies as a qualifying business. Under current law, if a municipality is under 2500 in population, the

definition of qualifying business is much broader to include a business that derives its principal source of income from activities other than those specifically listed in the Act.

LB 346 increases that number from 2500 or less inhabitants to 5000 or less inhabitants. The reason for this change is that the definition of a city of the second class is a municipality with a population of 5000 to 800 people and it provides consistency that this provision will apply to all cities of the second class.

The League Legislative Committees, as well as the League Execu-

LB 224: Sen. McKinney introduces bill to adopt Aid to Municipalities Act

LB 224, introduced by **Sen. Terrell McKinney** of Omaha, adopts the Aid to Municipalities Act.

Under the Act, municipalities will be eligible to apply for state aid in the form of grants which may be used to assist in funding a variety of municipal infrastructure projects, including: solid waste management facilities, wastewater, storm water, and water treatment works and systems, water distribution facilities, and water resources projects, including, but not limited to, pumping stations, transmission lines, and mains and their appurtenances; hazardous waste

disposal systems; resource recovery systems; airports; port facilities; buildings and capital equipment used in the operations and activities of municipal government and to provide services to the residents of the municipality; convention and tourism facilities; redevelopment projects; and mass transit and other transportation systems, including parking facilities.

LB 224 requests \$15 million be appropriated for the Aid to Municipalities Act. Thanks to Sen. McKinney for introducing this important piece of legislation for municipalities.
