RECOMMENDATION:

That the Board approve the attached resolution authorizing the Superintendent to make an offer to purchase approximately 42 acres of real property located at 407 Patricia Park Court, Seguin, Texas at a price of \$1,971,000.

RATIONALE:

The District intends to use available funds from the 2022 Bond for the acquisition of a 42 acre land tract. A future middle school will be constructed on the site to accomodate anticipated growth in student enrollment. The Public Property Finance Act (Local Government Code Chapter 271, Subchapter A) does not include cash purchases of real property made with moneys from available funds. *Bandera v. Hamilton*, 2 S.W.3d 367 (Tex. App.—San Antonio 1999, pet. denied).

Upon acceptance of the offer and conclusion of an inspection, Dr. Gutierrez shall report the findings of the inspection and offer to the Board of Trustees for final approval of purchase.

IT IS FURTHER RESOLVED, that execution of this Resolution shall be evidence of the Board's approval of this action and of the authority granted herein.
