5.A. Principal Reports

Elementary Principal, Pat Burrow reported that January is School Board Recognition Month, so I would like to extend my appreciation to each one of you and your decisions you make for our school. The Word of the Month for December was Forgiveness. Fourth grade, 5th and 6th Grade Boys Basketball, and First Grade did an excellent job of leading us at Wake-Up Waynoka and Hallway Huddle. In December, 75 elementary students earned a spot in the RAIL Club. December 15 was the Elementary Christmas Program. All the students performed well and Mrs. Hope delivered an exceptional program. Students of the Week for December were Thalia Ibarra, Jackson Ross, Zayla Jones, and August Ashton. 5th and 6th Basketball have 2 games left with Okeene and Timberlake. Tuesday, January 27th, 4th graders Makeia Brune, Caroline Smith, 5th graders, Zenlie Bradley, Katelyn Campbell, Saige Cline, Nivia Levario, Ellisyng Seiger, and 6th graders Addi Himmertzheim and McKenzi Storer will participate in this year's Circle the State With Song Festival and Concert, at Guymon High School. The concert time is TBA. The After-School Program will start back today, January 12th. On four day weeks, we will only have the After-School Program on Mondays, Tuesdays, and Wednesdays. Upcoming events are Elementary Eye Screening on Friday, January 16, Local Livestock Show on January 31 and Stephen Fite Concert on February 3 for PK and K. February 6th, the 5th and 6th grade band members will join the

Junior High and High School Band at Basketball Homecoming, for an event to experience playing in a pep band.

High School Principal, Trey Allen reported On December 12, several Waynoka Band members auditioned for the All Area Honor Band at Kingfisher Upper Elementary. Seventh graders Sawyer Tolson and Cole Wood auditioned on alto saxophone. Eighth graders Carver Kimbro and Cannon Watson auditioned on euphonium, and River Scott auditioned for Percussion I (snare emphasis). Students selected for the Junior High All Area Honor Band include River Scott, who placed 3rd chair Percussion I, and Carver Kimbro, who placed 4th chair Euphonium. Cannon Watson was selected as an alternate. River Scott and Carver Kimbro will participate in the All Area Honor Band clinic with approximately 90 students on January 16 at Hennessey Public School and will perform in the All Area Band Concert on January 17 at Hennessey Public School.

FFA, Oakley Whitaker had an exceptional showing at Cattlemen's Congress earlier this month, earning Reserve Grand Percentage Heifer, Reserve Grand Percentage Bull, and Reserve Champion Showman honors. Students will also participate in the National Western Stock Show in Denver later this month. The FFA Trophy Auction will be held on January 19. The local livestock show is scheduled for January 31.

Academic Teams, The 8th and 9th grade academic team will compete in the OJABA Academic Meet in Medford on January 14. The 7th and 8th grade academic team will host an academic meet on January 15 and will also compete in an OJABA meet on January 28. Robotics, The robotics team competed in a robotics competition in Oklahoma City on January 10.

Athletics, Junior High and High School basketball teams have several games scheduled this month. The High School teams competed in the Burlington Tournament from January 8-10 and will participate in the Buffalo Tournament from January 22-24. The powerlifting team will compete in a meet at Ringwood on January 14.

An Activity Day is scheduled for January 23, and school will not be in session on this day.

5.B. Superintendent Report

Superintendent Scott Cline provided the monthly financial report to the school board, outlining current expenditures, revenue trends and areas that will require continued monitoring as the school year progresses.

According to the report, overall expenditures for the month were down. The superintendent noted that one of the biggest differences compared to previous months was the use of security funds for a playground fence and an intercom system. Revenue for the month was also down by approximately \$500,000. This decrease was largely attributed to a one-time settlement of about \$1 million that was received during the same month last year. In addition, the district

has collected roughly \$250,000 less in ad valorem tax revenue compared to the same time period previously. The superintendent stated this is not an immediate concern, as taxpayers remit payments at different times throughout the year, but said the situation will continue to be monitored. Despite these fluctuations, the superintendent emphasized that the district remains financially stable in its general fund.

Building fund figures showed a similar trend, with expenditures down and revenue also lower for the month, again tied to the absence of the prior settlement funds.

Child nutrition finances were highlighted as an area to watch closely, especially following the decision to provide free breakfast and lunch to all students. Monthly expenditures increased, and year-to-date expenses are up approximately \$9,800. Revenue for child nutrition is down about \$14,000, creating a swing of roughly \$24,000. At this point in the year, the child nutrition program is operating at a deficit of about \$40,000. The superintendent noted that this report reflects four months of a ten-month period, and projected the program could be nearing a \$100,000 deficit by the end of the year if trends continue.

The daycare program showed signs of improvement. While both expenditures and revenue were down, the superintendent reported that losses have decreased and the program is trending much better than earlier in the year, with the gap between expenses and revenue continuing to close.

In closing, the superintendent thanked the board members for their service and leadership, noting that the month's report also served as an opportunity to recognize the board's dedication to the district.
