9. Discussion Items

9.1. Building Committee Meeting

Miles deferred the recap of the Building Committee meeting to Hague, who explained that the committee met at the first part of month to get an update on the construction at the Lincoln site. All projects remain on schedule and Stearns will be here this Wednesday. Stearns is coming twice a month now to monitor the site first hand. Roofers, plumbers and electricians are all busy working at the site. On the west side of the building, one can see what the exterior of the facility will look like (ground face block, stone, brick and white mantle) and the concrete roof will go on soon over the gym. On October 24th the foam spray will be installed on the remainder of the building and then the brick can be laid. The goal is to have the facility boxed in by the end of the month but it really depends upon the weather.

9.2. Facility Committee Meeting

Brunner told the Board that the Facility Committee had met at Northfield Elementary. The committee discussed the 2011-2012 proposed Classified Handbook, held a conversation that focused on bussing options and spoke about the window project at the High School.

Principal Barker led a tour of Northfield and pointed out specific damages received from rain leaks, as well as a broken pipe. Teacher Dawn Sabo provided a brief demonstration on how BenQ's are utilized in the classroom.

9.3. Curriculum Committee Meeting

Doll explained that the Curriculum Committee had met and discussed scheduling and instructional time, which has percolated to the Board level. Doll encouraged both teachers and administrators to work on this issue together. He reiterated that our goal is to make sure we're doing what is best for the kids. Doll encouraged the group to make adjustments and changes to better serve all district children. Doll wants them to discuss their issues and let the Board know what options are best. When comparing block schedules to non-block schedules it is hard to get an accurate picture. Each administrator should deal with their staff to handle scheduling and instructional time.

9.4. Business Committee Meeting

Brunner gave a brief recap of the Business Committee meeting. Topics included a presentation from ACE, discussion of district bills, balances in various funds and the Anderson and Shaw application for payment.

9.5. Personnel Committee Meeting

Miles explained that the Personnel Committee had met and had action items that were dealt with earlier in the agenda.

Hague reminded the Board that the NASB Conference has been scheduled for November 11th, 2011 and asked who was planning to attend. The entire Board, along with Curriculum & Assessment Director Terri Martin will be attending the event in La Vista, NE. Hague encouraged Board members to attend breakout sessions provided by activity associations. Hague asked anyone who finds they are unable to attend to contact Frahm and she will cancel their reservation and registration.

10.2. GNSA Report

Hague let the Board know that the first GNSA meeting is scheduled for November 17th, which is the Thursday after the School Board Convention. Brunner has volunteered to attend. Hague provided future meeting dates of 1/8/12, 2/15/12 and 3/21/12. Hague stated that both Brunner and Winn have attended and that more than one representative is welcome to attend, as it is a short legislative session.

10.3. Lincoln Update

Hague covered the update on the Lincoln construction during his recap of the Building Committee Meeting.

11. Board Comments

Doll let everyone know that the cross country team did well at districts and wished them good luck at State. Winn stated that she had recent opportunity to spend time at the High School and said that taking the seats out of the hallways provided much better traffic flow. The tables and chairs in the commons area

where the lockers once stood also provides a great area for students to do homework.

12. Tentative Committee & Meeting Dates

The Policy Review Committee Meeting was changed to 4:30pm to accommodate Board Member's schedules. The Advisory Committee Meeting was moved to the 9th of November. If the BIST team is available, a work session will be scheduled for November.

STUDENT EXTRACURRICULAR ACTIVITIES

Gering Public Schools strives to provide activities outside of the regular school day to assist in meeting GPS mission and goals and recognizes that value of extracurricular activities in the overall scope of a student's education. Therefore, whenever possible, a wide variety of such activities will be provided, and students will be encouraged to participate.

The addition of activities will be carefully examined for its benefits to students within the resource limitations of the district. The following items will be considered prior to the recommendation to the board for the addition of an interscholastic activity:

- Activity must be a sanctioned NSAA event and culminate in a state contest.
- Interest and numbers must be shown for development of a full varsity team (interest in participation must be expressed by a minimum of two times the number of players on each team).
- Appropriate facilities exist for competition and practice, taking into consideration the needs for supervision, accessibility, safety and scheduling.
- Geographic proximity of contests, comparable school participation and quality of scheduling will be a consideration.
- A qualified coach, who meets NSAA coaching requirements and who will be under the guidance of district personnel policies, will be in charge of the program.
- Budget of activity must come from district, with consideration of outside funds through fund raising. If the proposed activity requires frequent or large expenses for specialized equipment or quantities of consumable items, the long-term availability and reliability of outside funding assistance for new activities should be considered.
- Proposals of new activities must be submitted for review to administration prior to March 1st. The recommendation from administration for the activity must be submitted to the Board by the following December Board meeting. This will allow for proper planning and scheduling for successful initiation of the approved activity the next school year.
- The completed proposal for the initiation of the activity must be approved by the Board of Education by the December Board meeting in the school year preceding the start of the activity. This will allow for proper planning and scheduling for successful initiation of the activity.
- Eligibility requirements as published by the Nebraska School Activities Association (NSAA) shall be observed by all student participants. Additional eligibility requirements for all activities may be imposed by the school district at the board's discretion. All eligibility requirements shall be published in applicable student/parent handbooks prior to the school year.

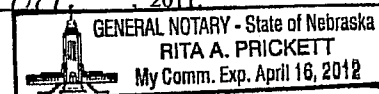

OBJECTIVES FOR EQUAL EDUCATIONAL OPPORTUNITIES FOR STUDENTS

This section of the board policy manual is devoted to the board's goals and objectives for assisting the students of the school district in obtaining an education. Each student shall have an opportunity to obtain an education in compliance with the policies in this series.

It is the goal of the board to develop a healthy social, intellectual, emotional, and physical self-concept in the students enrolled in the school district. Each student attending school will have the opportunity to use it and its education program and services as a means for self-improvement and individual growth. In so doing, the students are expected to conduct themselves in a manner that assures each student the same opportunity.

The board supports the delivery of the education program and services to students free of discrimination on the basis of race, color, sex, marital status, national origin or disability and provides equal access to designated youth groups. This concept of equal educational opportunity serves as a guide for the board and employees in making decisions relating to school district facilities, employment, selection of educational materials, equipment, curriculum, and regulations affecting students.

Board policies, rules and regulations affect students while they are on school district property or on property within the jurisdiction of the school district; while on school owned, operated, or chartered transportation; while attending or engaged in school activities; and while away from school grounds if misconduct will directly affect the good order, efficient management and educational processes of the school district.

This section of the board policy refers to the term "parents" in many of the policies. The term parents for purposes of this policy manual shall mean the legal parents. It shall also mean the legal guardian or custodian of a student and students who have reached the age of majority or are otherwise considered an adult by law.

Inquiries by students regarding compliance with equal educational opportunity laws and policies, including but not limited to complaints of discrimination, shall be directed to the superintendent or his or her designee.

COMPULSORY ATTENDANCE

Any child who will reach six years of age prior to January 1 of the current year and who has not reached eighteen years of age shall meet the requirements of mandatory school attendance. Any such child shall attend the academic program on a regular basis, unless a written request to drop the child from the school rolls is made by the parent, guardian or other person having charge, control or custody of the child.

Any child of mandatory attendance age must by law regularly attend a public, private, denominational, parochial school or a combination of such schools not less than the entire school term of the school(s) which the child attends. This does not apply to a child who has obtained a high school diploma, completed the program of instruction offered by a non-credited or non-approved school, has reached the age of 18, or who is at least 16 years old and whose parent or guardian has signed a notarized release discontinuing the enrollment of the child

Excusal from the "full-time" requirement of the compulsory education law can be granted by the superintendent for a child between 14 and 16 years of age having completed the work of the eighth grade when legal employment due to necessity has been obtained by the student and such a request has been made by a parent/guardian.

Withdrawal To Age 6

The parent/guardian of any child who will not reach six years of age prior to January 1 of the current school year and who is enrolled, may discontinue that enrollment according to procedures provided by the district.

Minimum Age

The district will not admit any child into its kindergarten class unless

1. the child will reach the age of five years on or before October 15 of the current year (on or before July 31 of the current year beginning with the 2012-2013 school year) or
2. The child will reach the age of five years by February 1 of the current year (October 15 of the current year beginning with the 2012-13 school year), and;
 - a) The parent provides an affidavit stating that the child attended kindergarten in another district, or
 - b) The family will be relocating to another district within 60 days to a district that allows early admission into kindergarten within the current year, or
 - c) The child has demonstrated through recognized assessment procedures approved by the board his/her capability of carrying the work of the beginner grade. By January 1, 2012, each school board shall approve and

make available a recognized assessment procedure for determining if a child is capable of carrying the work of kindergarten.

BUS SAFETY PROGRAM

The superintendent or his designee shall direct the preparation of a Safe Pupil Transportation Plan that, at a minimum, shall address weapons, pupil behavior, terroristic threats, severe weather, hazardous materials, medical emergencies, and driver/passenger procedures in the event of mechanical breakdowns of the vehicle.

The superintendent or his designee shall plan and implement a safety-training program for school bus drivers and vehicle passengers. The superintendent or his designee shall monitor the scheduling of inservice and educational opportunities for transportation personnel to improve their awareness and skills regarding school bus safety. School bus drivers shall attend local workshops and all inservice meetings.

Administrative rules and regulations shall be adopted to govern the safe operation of school vehicles. Students violating these regulations may have their riding privileges revoked or suspended. Parents will be responsible for damage done to transportation vehicles or equipment by their children.

The school district shall conduct school bus safe riding practices instruction and emergency safety drills at least twice a year for students who utilize school district transportation. The emergency evacuation drill procedures should be conducted according to guidelines established by the Nebraska Department of Education.

Each school vehicle shall have, in addition to the regular emergency safety drill, a plan for helping those students who require special assistance to safety during an emergency. This shall include, but not be limited to, students with disabilities.

School district vehicle drivers are required to attend each safety drill.

All transportation vehicles shall be acquired and maintained to meet or exceed NDE Minimum Equipment Standards for student transportation vehicles. The superintendent or his designee shall develop a systematic preventive maintenance program including daily, weekly, monthly, and annual schedules to insure vehicle safety and reliability. This will include a record keeping system for maintaining inspection reports along with procedures for filing reports and certifications to meet requirements of the Nebraska Department of Education.

BUS DRIVER SUPERVISION

School vehicle drivers must pass physical examinations and meet other criteria as established by state and federal law and by the Nebraska Department of Education. Bus drivers must have a valid student transportation vehicle operator's permit and shall have it in their possession when transporting students. This does not apply to the operator of a small vehicle being used only for extracurricular activities.

The school district shall obtain a record of satisfactory driving for each student transportation vehicle operator on a semi-annual basis. It is required that a copy of the individual's driving record be on file with the district before employment as a student transportation vehicle operator as defined in NDE rules. The school district shall obtain and keep on file a criminal history record of driver applicants who are not certified Nebraska teachers or administrators through the Nebraska State Patrol and local law enforcement agency before employment as a student transportation vehicle operator.

School vehicle driver selection procedures will be developed by the superintendent or his/her designee to ensure acceptance of drivers whose capabilities are commensurate with job responsibilities, including minimum requirements for a satisfactory driving record. The superintendent or his/her designee will be charged with determining the definition of an acceptable driving record at his/her discretion.

Substitute student transportation vehicle operators shall meet the same driver requirements and qualifications as a regular student transportation vehicle operator. A student transportation vehicle operator shall not have the authority to assign a substitute without the prior approval of any school administrator or person designated by the governing school board.

All school vehicle drivers are required to inform the district immediately of any change in their driving or criminal records that could affect their eligibility to maintain the student transportation vehicle operator's permit.

Student transportation vehicle operators shall document and report to the transportation supervisor the occurrence of any events covered by the Safe Pupil Transportation Plan that involved the student transportation vehicle operated by the driver, or any students transported in it. The superintendent or his/her designee shall develop such reporting procedures.

STUDENT ABSENCES - EXCUSED

Regular attendance by students is essential for students to obtain the maximum opportunities from the education program. Parents and students alike are encouraged to ensure an absence from school is a necessary absence. Students shall attend school unless excused by the principal of their attendance center.

Student absences approved by the principal shall be excused absences. Excused absences including documented illness shall count as non-attendance days for purposes of addressing excessive absenteeism, except for notification of the county attorney in policy 503.04.

Students whose absences are approved shall make up the work missed and receive full credit for the missed school work, within guidelines of the student handbook. It shall be the responsibility of the student to initiate a procedure with the student's teacher to complete the work missed.

Students who wish to participate in school-sponsored activities must adhere to attendance and activity participation rules as outlined in the student handbooks.

It shall be the responsibility of the parent to notify the student's attendance center as soon as the parent knows the student will not be attending school on that day. The principal may request evidence or written verification of the student's reason for absence. This issue is specifically addressed in the student handbook which is approved every year by the Board of Education.

It shall be the responsibility of the superintendent, in conjunction with the principal, to develop administrative regulations regarding this policy.

EXCESSIVE ABSENTEEISM

Regular attendance by the students at school is essential for students to obtain the maximum opportunities from the education program. Parents and students alike are encouraged to ensure an absence from school is a necessary absence. Students shall attend school unless excused by the principal of their attendance center. This policy, developed in collaboration with the county attorney for the district's principal office location, is an attempt to address the problem of excessive absenteeism. This policy shall include a provision indicating how the district and the county attorney will handle cases in which excessive absences are due to documented illness that makes attendance impossible or impracticable.

Excessive absenteeism is the failure to attend school for the hourly equivalent of five or more days per quarter as specified by district policy. ~~minimum number of days established in the school calendar by the board, with or without a reasonable cause.~~

The superintendent shall designate an attendance officer. The attendance officer will investigate the report of any child who may be in violation of the state's compulsory attendance statutes.

If any student has accumulated a total of five excused and/or unexcused absences per quarter or the hourly equivalent of five days of absences, the school shall render all services in its power to compel the student's attendance. These services shall include the following:

1. A meeting or meetings between the school attendance officer, school social worker (or school principal or a member of the school administrative staff, if the school has no social worker), the student's parent/guardian and the student (if necessary) to solve the excessive absenteeism problem.
2. Educational counseling to explore curriculum changes such as alternative educational programs to solve the excessive absenteeism problem.
3. Educational evaluation to assist in determining the specific condition(s) contributing to the excessive absenteeism problem, supplemented by specific efforts by the school to help remedy any condition diagnosed.
4. Investigation of the problem by a school social worker (or principal or administrative staff member) to identify conditions contributing to the excessive absenteeism problem. If services for the student and student's family are determined to be needed,

the investigator shall meet with the parent/guardian and child to discuss any referral to appropriate agencies to remedy the conditions.

If the student is absent more than twenty days per year, or the hourly equivalent, the attendance officer shall file a report with the county attorney of the county in which such person resides.

Students are subject to disciplinary action for excessive absenteeism including suspension and expulsion. It shall be within the discretion of the principal to determine, in light of the circumstances, whether a student may make up work missed because of excessive absenteeism. Disciplinary action for students receiving special education services will be assigned in accordance with the goals and objectives of the student's Individualized Education Program.

The superintendent shall report on a monthly basis to the Commissioner of Education as directed by the commissioner regarding the number of and reason for any long-term suspension, expulsion, or excessive absenteeism of a student; referral of a student to the office of the county attorney for excessive absenteeism; or contacting of law enforcement officials other than school resource officers by the district relative to a student enrolled in the district. The superintendent shall report annually to the Commissioner of the required data for the number of students who have dropped out of school.

It shall be the responsibility of the superintendent to implement this policy. The implementation may include regulations indicating the disciplinary action to be taken for excessive absenteeism.

1. BIST Conference Travel

Discussion:

3. 2010-2011 District Report Card

Discussion:

Three documents regarding assessment data in the district were shared with the Curriculum Committee: NeSA Assessment Annual Yearly Progress Summary, District Report Card for 2010-2011, NeSA Comparison.

Gering Public Schools had a 16.6% increase in enrollment over the last 10 years and currently have a free/reduced population of 46.61%. NeSA Reading had an overall scale score of 97 and NeSA Math had an overall scale score of 99. AYP State Goals for 2010-2011 are as listed below:

NeSA Reading: Elementary - 67%; Middle Schools - 70%; High School - 68%
NeSA Math: Elementary - 51%; Middle School - 50%; High School - 41%

Our high school graduation rate is 87.21%. Explanation of the new method of measuring graduation rate was given.

A work session with all Board of Education members will be scheduled for either December or January.

2. Anderson & Shaw Application for Payment

Anderson & Shaw's application for payment has been reviewed and approved by Sweeney in October. Hague informed the committee that Sweeney will submit his billing invoice to the district soon.

3. Hewgley & Assoc. Statement

The statement from Hewgley & Associates has been reviewed and approved by Sweeney.

4. After-School Program 1st Quarterly Report

Smith provided an After-School Program quarterly report to the committee and provided insight and behind the scenes info about the program's grant. The grant was originally written by Pam Barker and Smith. The grant is for a period of 5 years and will need to be resubmitted if the district wishes to obtain it again. The district is in its 3rd year of the grant. This year's grant is for \$50,000. The grant requires extensive paperwork. There are 27 deadlines involved with this grant, including evaluations, parent surveys, community partnership surveys, student input, teacher surveys, etc. The Continuous Improvement Report is where all of the collected data is summarized. This report will show if the district meets state standards and compares several years of info. The district then writes an action plan and submits it to the state for approval. Smith provided a detailed explanation of daily work attendance reports from each school, monthly snack reports, employee physicals, background checks, references, and proof of service and ratio balances.

Brunner asked what the state is specifically looking for in deficiencies and Smith displayed an example of the surveys. Specific areas of interest include, but are not limited to: academics, parental involvement, family partnerships, safety issues, percentile of surveys returned, records of student attendance data and proportionism. Brunner confirmed that the grant provides a diminishing amount each year. The program's budget includes salaries, materials and field trip related costs, such as bussing. All information is submitted by June 15th of each year. The committee feels that Smith runs a very good program and Smith invited the committee to visit the building during the program so see how strong each site coordinator is. A child cannot attend the program if payment is not received on time, and families are notified ahead of time if payments are not arriving. A payment plan is also available. The committee asked Smith to determine if it is feasible to keep the program running under the current grant when the time arrives to resubmit. The committee feels that this service is

needed, but wonders if the district may be able to run it locally instead of with a grant. There are two years left on the current grant.

5. Review Bills

Hague stated that one of the old air conditioners in the library at Geil needed repair and was not covered under the maintenance agreement for the new recently installed units. He also confirmed that winter covers will not be needed for the new units and they can even be used to run fresh air throughout the building during the off season. The maintenance and custodial staff will be trained in March on maintenance of the units.

The demand charge from the City of Gering was unknown at the time of the meeting but Meisner will check on it prior to the Board Meeting. Tires were purchased for one of the Suburban's. The purchase of helmets will be checked on as well. Copsey asked what the \$15,000 charge to Scottsbluff Screen Printing was and was told that it was for camp shirts and shorts, etc. Meisner will provide a breakdown of that charge, which was out of the activities account and will see if it is reimbursable. Meisner continues to work with the Booster Club to separate their finances from the district. He indicated that they were going to speak with an attorney and get the paperwork rolling.

2. Administrative Salaries

The committee discussed various salary options for the district's Administrative staff, including flat salaries, adjustments, midpoints, comparisons and percentages. 3. Training

4. Tennis Proposal

Program costs are expected to run \$15,000 to \$20,000. If all committees are interested, the program will be included on the November agenda for approval. Hague urged the committee to approve the program no later than December 2011 if they wish to enact it next school year per district policy.

The Personnel Committee feels that this is an activity that kids would benefit from since it is a lifetime sport; however Miles has concerns about coaching selections and the athletic budget. The program would offer a boys and girls program, with one program offered in the fall and one offered in the spring. The search for a coach will begin with the internal application process prior to it being opened to the public.

The committee urged Pauli to attend the November Board meeting and lead a discussion on the proposed program.

5. Superintendent's Administrative Leave

Hague distributed copies of his November and December calendars to the committee and briefly discussed his schedule. He then encouraged the committee members to work on the Superintendent's evaluation before the December Board meeting. Hague indicated interest in meeting every 9 weeks so he can address concerns and

issues in a timelier manner. The committee briefly discussed past evaluation processes, including the mid-year and state of school reports.

The committee determined that there would be an Executive Session during the December Board Meeting to discuss the Superintendent's Evaluation.
