Guiding Principle I: Infrastructure and Shared Leadership

Objective: Establish a vision for achieving educational equity through core beliefs and norms, team structures and routines, clarity of roles and data-based decision-making process, professional learning, and system alignment.

I have started formal evaluations on the elementary teachers for the 2024-2025 school year. Besides the evaluations, walkthroughs will continue to happen during the year.

During Professional Development time, the science teachers met with Kellon Conroy, from ESU 1, to work with him on getting more familiar with our new science curriculum. Kellon will be working with the teachers during a few of our Professional Development sessions.

The science teachers will be meeting with *Inspire* curriculum support on Wednesday, October 16th, so they can ask any questions they may have and be able to learn more about the curriculum.

Guiding Principle II: Layered Continuum of Supports

Objective: Provide tiered supports to meet the social, emotional, behavioral, physical, environmental, and academic needs of the whole child to ensure student growth.

Guiding Principle III: Data-Based Decision-Making

Objective: Community, caregivers, district, school, collaborative and student support teams use a variety of data points to identify student needs and support planning. This includes a balanced assessment system to generate data, data-based decision-making to reinforce student support, and data-based decision-making to support continuous improvement of systems.

I have received the results from the NSCAS Test from the Spring 2024. The results are as follows:

By using this data, teachers will be able to make decisions about individual students as well as overall class curriculum decisions.

Student success and engagement rely on positive partnerships and relationships to fundamentally improve the outcomes for each student, school, district, and community.

Our goal is to have a 100% rate at our conferences. If parent(s) and teacher did not meet on Wednesday or Thursday, teachers will work with parents to find a time to communicate with parents.

4. Cell Phone Policy is still going well. Only one student to this point has a 3rd Offense that led to an ISS.

5. Drug Prevention/Education Presentation is set for 7-12 students on Friday, October 25, 2024 from 2:30-3:40 with Carol Wolfe as the presenter. Also, we are looking at a Safe Relationships Presentation by the Haven House possibly on November 22, 2024.

6. The East Husker VB Tournament has been seeded. Here is the link for that information. [x 2024 EHC VB Bracket-Initial.xlsx](#)

7. Fall Sports seasons are starting to wind down. I will be completing the following coaching evaluations for the Fall: JH FB, JH VB, HS FB and HS VB.

8. Mr. Hassler turned in his resignation letter for high school football.

9. Teacher evaluations began in late September and classroom walkthroughs have as well. I am trying to complete 10-15 walkthroughs a week and I generally have two evaluations a week until Christmas Break.

Guiding Principle I: Infrastructure and Shared Leadership

Objective: Establish a vision for achieving educational equity through core beliefs and norms, team structures and routines, clarity of roles and data-based decision-making process, professional learning, and system alignment.

- The District Leadership Team met during the September in-service. In partners and groups of 3, members of the DLT facilitated conversations with staff to gain feedback on the proposed action steps for our first priority goal. Teachers rotated through topic rooms with the opportunity of 15 minutes to give feedback. Members of the DLT recorded staff responses. Staff responses were later organized into common themes for each action step. In October, the DLT will refine the action steps for priority goal 1. *(By Spring 2026, 38.9% of students in grades 1-11 will meet their growth targets from Spring 24-to-Spring 25 as evidenced by MAP Growth Reading.*
- *District Baseline: 50.2% (Spring 22 to Spring 23)*
 - *33.7% (Spring 23 to Spring 24)*

By the 2030-2031 SY, 70% of students in grades 3-11 met their growth targets from Spring 30-to-Spring 31 as evidenced by MAP Growth Reading.)

- Five DLT members, plus Mr. Farup and I attended the 2024 NeMTSS Summit. This was by far the best summit yet. Ali Hearn and Katie Novak were the keynote speakers, addressing the topic of restorative practices and universal design for learning. The overall theme for this year's summit was systems for success. Breakout session topics were around building and sustaining systems within the MTSS framework.
- Call to Greatness PD—We had a first collective care PD activity. Eleven teacher teams were created, led by facilitators who teachers recognized through an anonymous survey as colleagues who embody exemplary leadership skills. Each facilitator chose a team through a “draft” process. Teams then designated roles, norms, and a team name. Each team participated in an activity called “What Do You Meme?” All teams were given a phrase in which they had to create a matching meme. Pictures were taken of the memes then hung in each work room. A secret judge chose the best meme each day for 5 days. The winning team won a daily prize. Many staff commented on how much they enjoyed the activity and appreciated the time to have fun together.
- Explicit Instruction PD—Staff gathered in their groups to view a small segment of the NeMTSS explicit instruction webinar. The webinar chunk focused on content of instruction and ways to structure content. Staff answered a reflective question as a forum discussion. The remainder of this PD time (approximately 45 minutes) was devoted to collaborative learning and planning. Teachers recorded on a Google doc who they would be collaborating with and the focus of the collaboration time. All teachers had the autonomy to decide how to use the collaborative time.
- I attended the state special education monthly webinar with the NASES Region 3 meeting immediately following the webinar.
- I attended the Indicator 13 workshop at ESU1. This workshop focused on guidance for the upcoming Indicator 13 data collection.
- The mentor/mentee group met to discuss the Survival Phase time of the school year. This phase focuses on classroom management, displaying controlled objectivity, noticing when students are not engaged, and mindfulness practices for self care. The

mentor/mentee group also works together during the “Call to Greatness” PD times.

Guiding Principle II: Layered Continuum of Supports

Objective: Provide tiered supports to meet the social, emotional, behavioral, physical, environmental, and academic needs of the whole child to ensure student growth.

- I provided coaching to our elementary grade level problem solving teams. This was a refresher of the guidance document and process of identifying students who need targeted support. I intend to provide a second coaching session to the elementary staff so we can apply the process to an actual student case.
- October 7-10, I attended Mandt instructor training in Omaha. I am now certified to train our teachers to use de-escalation and relational strategies as well physical techniques to support a student in crisis. This certification is valid for 2 years. There is the opportunity to create revenue by offering training to people outside of our school district.

Guiding Principle III: Data-Based Decision-Making

Objective: Community, caregivers, district, school, collaborative and student support teams use a variety of data points to identify student needs and support planning. This includes a balanced assessment system to generate data, data-based decision-making to reinforce student support, and data-based decision-making to support continuous improvement of systems.

- During the September DLT meeting, an ad hoc team was created to collaborate on our NE Counts determinations action plan. Those who volunteered to serve on this team are Logan McPhillips, Brittany Vinchattle, and Ann Knust. A requirement of this action plan was to identify a technical assistance resource. We chose NeMTSS Region 3 Team. Using root cause analysis and our district problem-solving model, we will be reviewing our historical determinations data to create the required action plan.

Guiding Principle IV: Communication and Collaboration

Objective: Enhance student, family, and community engagement with learning experiences that are culturally inclusive and relevant for each student. Student success and engagement rely on positive partnerships and relationships to fundamentally improve the outcomes for each student, school, district, and community.

- SEBL screener parent letters were mailed. Screening began last week for all K-12 students. Screeners were administered by Brittany Vinchattle, Meg Rose, with Allie Rosener (School Psychologist Intern) assisting.

Safety Committees:

There are two sets of regulations that guide your safety committees. We recommend that your safety committees have separate agendas for each meeting.

- (1) The Nebraska Department of Education Rule 10 requires school districts to have a “Safety and Security Committee.” This committee is composed of administrators, teachers, staff, parents, and students. The committee is required to meet at least once a year. The focus of this committee is to develop a “Safety and Security Plan” for their school district to properly respond to a crisis or emergency. Rule 10 also requires a school district to bring in an outside person to conduct an annual safety review and submit a written report to the superintendent. Keep documentation of the meetings of the meetings for at least seven years.
- (2) The state and federal worker safety laws are codified in Nebraska Statute 48-443. This law requires school districts to have a “Workplace Safety Committee” that has representation from each work department and meets quarterly. The focus of this committee is on the day-to-day safety of the workers and students. Keep documentation of the meetings for at least three years.

Safety Trainings:

We recommend utilizing the “SafeSchools” online safety training videos from ALICAP. We recommend including “Slips, Trips, and Falls” and “Lifting: Back and Shoulder Injuries” to your rotation of safety

trainings. We also recommend the 8 new trainings on “Cyber Security.” The “Phishing Training” is especially beneficial for schools.

Monthly ‘Risk Alerts’ from ALICAP are forwarded to all school employees.

All school employees that have contact with students have taken the Nebraska Department of Education required suicide awareness/prevention training. (The SafeSchools online safety training now meets this requirement.)

Each certificated school employee participates in a minimum of one hour of self-study review of seizure disorder materials at least once every two years. (The Safeschools online safety training meets this requirement.)

Employee and student orientation efforts address sexual abuse, sexual harassment, and appropriate communication via social media for staff and students.

All coaches and extra-duty sponsors have taken the ‘concussion protocol’ and ‘heat acclimation’ training prior to the start of the fall sports season.

Job descriptions are reviewed annually and define ‘lifting requirements’ where appropriate.

The school district conducts and documents all required drills:

- (1) Fire drills are conducted once a month with one additional drill the first 30 days of school;
- (2) Tornado drills are conducted during the first two weeks of school and once in March; and
- (3) Bus evacuation drills are conducted once during the first month of school and once in January.

The school building fire alarm system is not connected to the local fire department.

Local law enforcement and fire department are familiar with the school building(s).

The school district has adopted the “I Love You Guys” standard response protocol recommended by the Nebraska Department of Education.

We recommend that school personnel conduct WEEKLY inspections of the playground(s) and document each inspection. In particular, maintain the manufacturer’s recommended depth of surface material under the playground equipment. Document each inspection.

We recommend that school administrators and maintenance personnel conduct regular monthly inspections of the buildings and grounds. Document each inspection.

We recommend that all coaches and extra-duty sponsors know where the main water shut-off valve is.

Cables and belts supporting the basketball baskets in the gym should be inspected every year. (The warranty is probably guaranteed for 10 years.)

Does your district still utilize MSDS Sheets? If you do, are they placed in a common known location, assessable in an emergency situation and organized in a manner which allows for quick reference? Has your district considered the ‘Safety Data Sheets’ program, where these previous MSDS documents can be housed online? It is FREE to all ALICAP members. If interested, call Megan Boldt at 1-800-422-4572.

Is your school district participating in 'High Risk Activities?'

Exterior Grounds:

(1) Football Field/Athletic Field

- a. The football field/athletic field appears in good condition.
- b. Metal frame bleachers appear in good condition.
- c. Press box appears in good condition.

(2) Playground(s)

- a. The playground equipment appears in good condition
- b. The concrete pad (for basketball) appears in good condition
- c. The fencing around the playground appears in good condition
- d. No hazards were noted in the play area
- e. A program for weekly inspection of the playground site should be in place
- f. Maintain the manufacturer's recommended depth of surface material (wood chips)
- g. The square rubber pads under the playground equipment are starting to show their age. The corners are starting to turn up (tripping hazards)

(3) Sidewalks

- a. The concrete sidewalks appear in good condition – no heaving or break-ups that would be a tripping hazard.
- b. We recommend that each year you replace portions of sidewalks that are deteriorating in order to stay ahead of any problem areas.

General Interior of the School Building:

The school building has a controlled entry system (buzz-in with camera ID).

The school building has multiple surveillance cameras and recording equipment.

The fire alarm system is inspected twice a year.

All fire extinguishers are inspected annually by a qualified person and monthly operational checks are performed by in-house personnel (tags are initialed and dated).

All exit lights appear to be in working condition.

Emergency lights appear to be in working condition and should be tested monthly (fire code).

The classrooms are well-organized. Some classrooms in the elementary have furniture (bookcases) next to the doorway that partially block the doorway and would impede an easy exit (Room #103 is an example).

Fire routes and the route to the tornado shelter(s) are posted in the classrooms and offices.

Tornado shelters are identified with proper signage.

There were no electrical cords on the classroom floors or in the offices that would be considered a tripping hazard.

The exits and hallways were not blocked or obstructed.

Art classroom – The kiln is in a separate room and properly vented (fire code).

Gym -- OK

Band/Vocal Music room – OK. Materials and instruments were stored in shelves.

Family and Consumer Science – OK.

In the high school Science classroom, there is an eye-wash station, fire extinguisher, fire blanket, and first aid kit. There is an easily located gas shut-off valve. The electrical outlets are properly grounded. The corrosive acids are stored in an approved lockable composite material cabinet and identified with proper signage. Flammable chemicals are stored in a lockable metal cabinet and identified with proper signage.

In the Woods/Metals work area, the power tools are properly grounded, the electrical cords are not frayed, and the manufacturer's guards are in place. The ventilation system for the welders is in working condition. There is a fire extinguisher and eye-wash bottle. There are no 'home-made' power tools being used by students/staff.

Mechanical/Storage/Kitchen:

The boiler system has been inspected and the current inspection certificate is posted in the boiler room. There is a fire extinguisher in the boiler room. There is no emergency lighting.

Most of the storage rooms are well organized. The exception is the storage room with the main electrical shut-off panels. There are prom decorations and One-Act Play items that don't belong in that room. Try to add more 'shelving' whenever possible to keep things off the floor. Items on the floor become tripping hazards.

The kitchen is a large, well-organized area. There is an approved hood system and hood extinguishing system that is inspected annually. I did not see any standing water or tripping hazards. The food storage area is well-organized.

Recommendations:

1. Your school district has a full-time SRO at your school building. Excellent!!
2. Your district has achieved 'Qualified' status for cyber security renewal. Good job!! Keep working to achieve the 'Five Critical Controls.'
3. If your district still utilizes the MSDS sheets, you should consider the 'Safety Data Sheets' program, where these previous MSDS documents can be housed online. It is FREE to all ALICAP members. If interested, call Megan Boldt at 1-800-422-4572.
4. Good job with the "SafeSchools" online safety training videos. We recommend including "Slips, Trips, and Falls" and "Lifting: Back and Shoulder Injuries" to your rotation of safety trainings for the entire staff. We also recommend the new training videos on cyber security.

5. We recommend that all coaches and extra-duty sponsors know where the main water shut-off valve is located. If they detect a water leak, they will know how to stop it and save a lot of damage from happening.
6. The rubber square pads under the playground equipment are showing their age. They are drying out and the corners are starting to curl up. These will become tripping hazards.
7. The mechanical room with the main electrical shut-off panels should not be used for storage of prom decorations and One-Act Play items.
8. There are no emergency lights in the boiler room – something to consider.
9. In the cafeteria, students eat on the stage. I recommend installing a rail along the edge of the stage.
10. We recommend that each year you replace deteriorating concrete sidewalks – stay ahead of any problems.
11. We recommend that you add shelving to your storage areas whenever possible to keep things off the floor. Items on the floor become tripping hazards.

Reminders:

- (1) ALICAP’s website/portal/platform has your district’s Coverage Memo, Auto ID Cards, SafeSchools Training Status, Claims counts/dollars all in one site.
- (2) ALICAP is providing a Work Comp Claims Nurse’s Line. If any employee gets hurt at work, he or she (along with their supervisor) can call the nurse’s line for assistance. The phone number is 1-855-364-9865.
- (3) Homeland Security offers FREE cyber screening, vulnerability assessments, and penetration testing for schools. If you are interested, you can contact Nic Brand at nicholas.brand@cisa.dhs.gov.

NRCSA's annual membership drive is nearing its end. Notices were sent out in time for your July Board meetings, but members were welcome to pay their dues in the 2024-25 budget year. As a result of this move, new scholarship opportunities were created for paras who are in a "para to teacher program" and for transitional educators. NRCSA will provide three \$1,000 scholarships for the fall semester and three \$1,000 scholarships for the spring semester for the 2024-25 school year. Applicants for the scholarships must be current employees of a NRCSA-member district or ESU. Applicants must be enrolled for that semester in one of two types of programs: (1) in a recognized "para to teacher" program such as is offered by the three State Colleges (Chadron State, Peru State, or Wayne State), or (2) a transition to teaching program in which a person with a minimum of a bachelor's degree who is employed to teach in a member school while working through a transitional program, such as offered by the University of Nebraska-Kearney. The applicant could currently be teaching under a transitional certificate. Application materials were distributed to member Superintendents and ESU Administrators, who were then asked to share with potential candidates in their buildings. The Fall applications were received and the NRCSA Scholarship and Recognitions Committee selected the three scholarship winners.

The Special Session of the Unicameral adjourned on August 20. The special session of the Nebraska Legislature was called by Governor Jim Pillen with the goal of reducing property tax levels. There were three days of bill introductions and a week's worth of bill hearings.

LB 1, introduced by Sen. Linehan, contained the Governor's plan for property tax relief. In part, this bill would have had the effect of the state taking over the funding of public schools. The plan had many issues from many different individual Senators and did not move forward. LB 9, introduced by Sen. Hughes, contained a plan that was more beneficial for NRCSA-member districts. This bill was taken over by the Revenue Committee as the vehicle to move the Governor's plan forward. As amended, it also did not gain traction.

LB 34 ended up being the next vehicle by which the Unicameral's Revenue Committee attempted to move forward with concepts in the Governor's plan. After much debate, the amended LB 34 was again amended. In the end, property tax relief that was originally provided through income tax credits in LB 1107 from a few years ago will now be "front-loaded". In the past these income tax credits for property taxes paid had to be claimed when property owners filed their income taxes. It is estimated that between 40% and 50% of property owners did not file for these credits. With LB 34, property owners will now automatically receive the reductions without having to file for them.

The cost of the new credit is \$750 million in FY25, then increasing 3% every year after that. The state will reimburse school districts for the cost of the new credit. The bill also changes growth in property tax levy authority for cities and counties. LB 2 and 3, referred to the Appropriations Committee, change provisions relating to appropriations and funds to lapse unexpended funds from FY2023-24, reduce General Fund appropriations in the current fiscal year, to provide for transfers of cash funds to the General Fund, and to provide for the crediting of investment earnings from certain cash and revolving funds to the General Fund. LB 2 and LB 3 provide the additional funding for LB 34.

The 2024 regular session of the Unicameral ended in April. Below you will find a link to NRCSA's summary of bills that were passed. A few bills that did not pass are also listed. Bills signed by Governor Pillen

become effective three calendar months after adjournment (July 18, 2024), unless the bill has a specific operative date or was adopted with an emergency clause. Bills adopted with an emergency clause take effect the day after being signed. All bills not enacted at the conclusion of this year's session are indefinitely postponed and will not carry over to the next Nebraska Legislature. They may, however, be re-introduced by a Senator as a new bill.

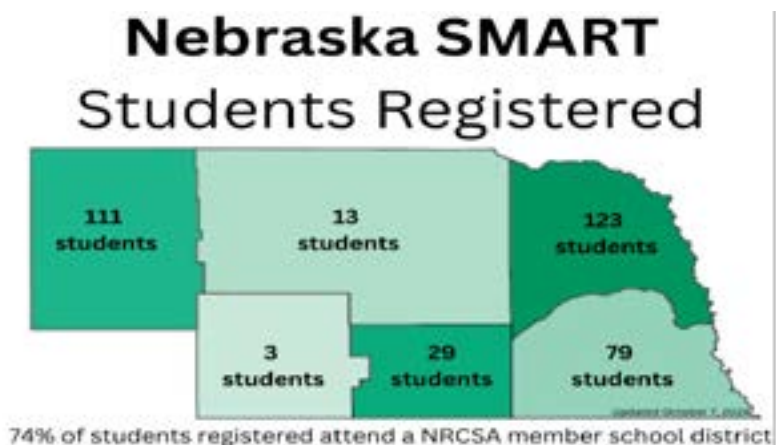

Nebraska SMART Free Online Tutoring for K-12 Students

I am excited to report that after the first month of tutoring (September 3 – October 3), we have matched the number of completed sessions from the entire three months of the spring 2024 semester, totaling 214 sessions. Our Tutors have spent over 118 hours this semester in tutoring sessions with students across rural Nebraska.

Since the end of the Spring 2024 Semester, we've registered over 215 new students, totaling 358 students registered, 74% of which are students attending NRCSA member school districts.

The American Heart Association is committed to partnering with schools in rural Nebraska to improve the health of their communities. A few of these opportunities include:

Tobacco Free Schools. Unfortunately, recent data reveals the ongoing challenges of youth tobacco use. The 2021 National Youth Tobacco Survey showed that: Approximately 2 million MS/HS students reported using e-cigarettes during the pandemic; nearly 85% of them used flavored tobacco products. More than 4 in 10 HS students and nearly 2 in 10 MS students who used e-cigarettes did so 2 out of 3 days and youth showed a strong brand preference.

Many schools have struggled to keep up with the continued innovation of the tobacco industry. To help address that, the American Heart Association created our Tobacco Free Schools Toolkit. The toolkit is designed to help schools update their policies so that now – and in the future – they will cover all products, people, and places while providing mechanisms that support students who are battling tobacco addiction. More information/resources are here.

Improving Cardiac Response in Schools. Did you know that the odds of surviving a cardiac arrest in rural areas is only about half of that in an urban area? In the aftermath of a cardiac emergency - minutes matter. The Chain of Survival starts with those who are present and requires everyone to do their part. The American Heart Association is committed to building a Nation of Lifesavers to and to helping school districts and other entities develop **Cardiac Emergency Response Plans**. These plans consider: access to functioning AED's, a strong base of CPR knowledge and training, as well as the identification of a response team and the annual practice of

A note from Mr. Nikolai:

*For those I have not met previously, I am the **American Heart Association's** lead for rural health in the Midwest Region, inclusive of your states. My role allows me to work collaboratively with all manner of organizations that are in a position to impact health in their communities – and schools are certainly near the top of that list.*

There are many ways our organization has worked to collaborate with schools – supporting access to nutritious, affordable food, helping to address the ongoing challenges of vaping/tobacco use, and more. Today, though I'm focusing primarily on our resources to assist with cardiac readiness / cardiac emergency response planning.

*Much of the country was watching – or has followed since – the **collapse of Buffalo Bills' safety, Damar Hamlin, on Monday Night Football**. Fortunately, Damar's story had a happy ending. Our goal is to maximize the opportunity for everyone to have a similar outcome should they experience a Sudden Cardiac Arrest. Most organizations will not have the resources that the NFL does to ensure player safety, but there is much that can be done, especially with proper planning.*

*Some data suggests that **nearly 1% of schools will be the site for an out of hospital cardiac arrest annually**. For a variety of reasons, rural areas are disproportionately impacted by both rates of cardiac arrest and poor outcomes. We know that prepared and equipped schools mean better outcomes for staff, students, visitors, and the communities that so often gather in school spaces.*

We have recently built out/updated a variety of tools to assist schools – and other organizations – with their cardiac readiness. These include:

- *Sample Cardiac Emergency Response Guidelines and Plans.*
- *A toolkit to maximize the impact of AED placement and implementation.*
- *Training and awareness tools to help with Hands-Only CPR knowledge for staff and students.*
- *A revamped, training site search feature, for coaches, nurses, and others who need CPR certification.*
- *In some cases, we may have – or be able to help secure – financial resources to help schools with purchasing/maintaining AEDs, CPR mannequins, etc. Hearing the scope of that need can help us secure additional resources, so please let us know!*

Please let me know if you see an opportunity or need to dialogue about these resources further or share them with your member districts. I'm happy to assist with newsletter copy, join or host webinars, or other ideas that fit your standard means of communication.

Finally, at the risk of sharing too much – a few other notes I wanted to highlight.

- *I've attached an invitation for our **Fall Educator Series**. Administrators/Educators from all districts are welcome to attend the sessions they are interested in. You'll see the one in November is on Cardiac Emergency Response Planning.*
- *Last year some 1300+ rural schools in the Midwest participated in our Kids Heart Challenge program. They raised life-saving money for our mission, earned PE equipment for their schools, and helped improve health knowledge in their community. Last year, tens of thousands of families learned Hands-Only CPR through the program.*
- *Thanks to the **Missouri Rural Health Association** for sharing our HeartCorps program on their home page. That opportunity exists for IA, KS, KY, MN, MO, NE, OH, and WI. Happy to chat more!*

Farm to School Network Takes Root in Nebraska

The Nebraska Department of Education, Center for Rural Affairs, Nebraska Extension, Buy Fresh Buy Local, and No More Empty Pots are pleased to announce the establishment of the Farm to School Network in Nebraska. The network aims to increase access to fresh and nutritious foods in Nebraska schools and strengthen connections between local farmers, educators, and communities.

To build this network, a Network Development Committee and Advisory Committee will lead the process and guide stakeholders to create a strategic, collective action plan that will move farm to school forward in Nebraska. The Network Committees are made up of representatives from key organizations and institutions across the state and are focused on breaking down barriers standing in the way of implementing farm to school initiatives.

The Network Committees will begin the network building process with mapping community assets, phase one of the Nebraska Farm to School Network Timeline. Through this phase, they will collect information on existing farm to school activities in the state and establish a vision for the network.

All stakeholders interested in building a stronger and healthier food system in Nebraska may participate in upcoming virtual and in-person listening sessions. These listening sessions will take place from October 10th to 18th and provide a platform for sharing information about current farm to school activities and discussing the future vision for the network.

“Pillars to farm to school success in a state include partnerships, policies, and supportive programming. A network will support development of these initiatives,” said Sarah Smith, Nebraska Department of Education Farm to School Specialist and Project Director.

We urge you to consider participation in the NRCSA Partner OneCard program as a tool for you in managing school expenditures, both large and small. Certainly, the card can help reduce/eliminate any issues relative to unverified cash expenditures. You decide who uses it, can get cards for each of those users, keep all cards wherever you wish, determine the amount to load on each individual card, and how long the time frame

of use is. It is a terrific management tool and clearly identifies each expenditure/name/date/amount. Whether small purchases or very large purchases, the card is a terrific tool. NRCSA owns the state contract, so liability for misuse falls to NRCSA, not the district user. We have only had three circumstances of fraud and all three have been the theft of the card number information, not any district employee misuse. For 2023-24, 98 districts/ESUs participated in the program. We have received interest from several districts already this year, so we believe we will end up with over 100 entities using the program. Great job by all participating districts in protecting the card and program! Don't forget, the NRCSA rebate from the transaction fee paid by businesses that choose to accept plastic is used for scholarship, awards, and special needs. For 2023-24, the rebate was over \$30,000 to NRCSA, showing that use is increasing, and large purchases are being included. WIN, WIN, WIN! 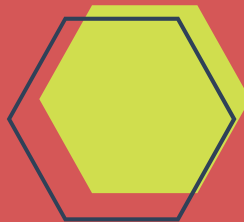

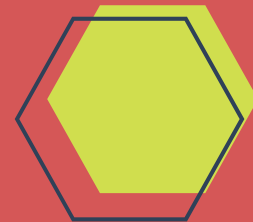

* Southern Valley Elementary and West Point Elementary were recognized by the U.S. Department of Education as National Blue Ribbon Schools. Only four schools in Nebraska were recognized and only 356 schools in the country received the award.

* Four students from NRCSA member schools have been named National Merit Scholarship semi-finalists. They are Kit Brooks (Central City), Austin Schmidt (Heartland), Michael Tophog (Ogallala), and Norah Armstrong (Wayne).

* Two alumni of NRCSA-member schools were recently inducted into the Nebraska Football Hall of Fame: Chris Kelsay (Auburn) and Jared Crick (Cozad).

* Jordan Hooper (graduate of Alliance) and Virginia Stahr (graduate of Centennial) were inducted into the University of Nebraska Hall of Fame recently. VIRGINIA STAHR JORDAN HOOPER



The National Rural Education Advocacy Consortium (of which NRCSA is a member) continues to represent rural education on the Federal level. NREAC is an extension of the National Rural Education Association. NRCSA Executive Director Jack Moles and NRCSA Legislative Committee Co-Chair Bryce Jorgenson (Supt. at Southern Valley) attended the NREAC Federal Legislative Summit in Washington DC on April 28-30.

Bryce and Jack met with the offices of each of Nebraska’s contingency in Congress. They specifically shared three points of emphasis with them:

- Copies of NREA’s publication, “Why Rural Matters” was presented to each of the offices.
- Full funding of IDEA was stressed. This would bring about \$171 million more to Nebraska public schools in support of Special Education services.
- Passage of the Secure Rural Schools Reauthorization Act of 2023. This would bring about \$180,000 to school districts surrounded by tax-exempt public lands.

A brief description of the six NREAC legislative priorities are as follows:

- 1) EDUCATION FUNDING: NREAC seeks preservation of critical federal funding for rural schools.
- 2) REAP FUNDING: NREAC urges Congress to increase funding to Title V, Part B of ESSA, the Rural Education Achievement Program, with a specific increase to the Rural Low-Income School Program.
- 3) INFRASTRUCTURE: NREAC supports efforts to ensure any infrastructure proposal in Congress must include funding for modernizing or maintaining rural school facilities.
- 4) FOOD AND NUTRITION: NREAC supports any effort to streamline processes and reduce the administrative burdens related to school meal programs.
- 5) SCHOOL SAFETY: NREAC supports flexible federal formula funding streams that channel resources to rural school districts for school safety that recognizes the geographic and economic challenges in rural communities.
- 6) BROADBAND AND CONNECTIVITY: NREAC believes access to high-speed internet is critical for providing equitable access to learning for students in rural schools. As such, NREAC strongly supports maintaining E-Rate as an element of the Universal Service Fund in its current funding structure.

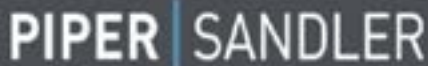

Programs

Program 1. Video Production. New to the Adams Central High School Curriculum in 2023 is a class geared to teach students how to design and run a video board. The class is tasked with making sure everything runs smoothly for home athletic events. The addition of video boards at Adams Central has happened over the course of the last few years. This class runs the scoreboard, music and lights at home football games and the scoreboard at home indoor athletic events.



Program 2. Goal Setting. Over the past two years, Adams Central Elementary has placed a strong emphasis on student growth. Using NSCAS (Nebraska Student-Centered Assessment System) scores from fall, winter, and spring, teachers work with students to track progress and set personalized goals. After one-on-one conversations with their teachers, each student establishes a growth target to work towards.

To motivate students, the school organizes class competitions to see which group shows the most improvement. The winning class is rewarded with a pizza party and a traveling trophy. In addition, students who demonstrate growth are invited to an ice cream party as a special celebration of their hard work.

This approach has not only created a positive environment for students to celebrate their achievements, but it has also drawn attention from state education leaders.. The staff at Adams Central Elementary have had the opportunity to share their successes with both the state school board and the Commissioner of Education, showcasing their commitment to fostering student development.

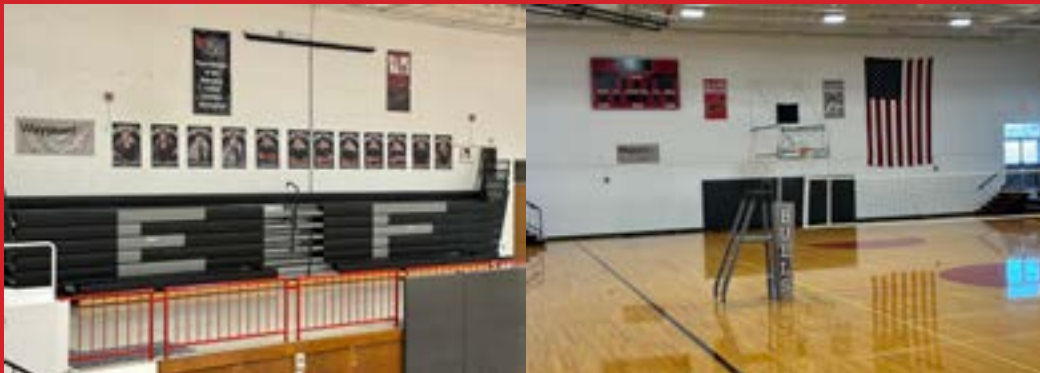

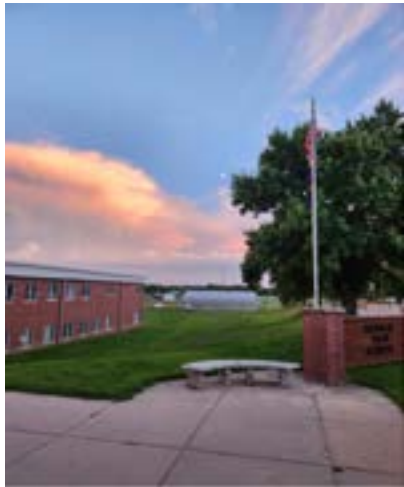

Deshler CTE Programs: Through the reVISION Grant award of \$100,000, Deshler Public Schools looked very closely at what we are currently offering and where we wanted to expand in our Career & Technical Educational. The following are areas which we have expanded.

Agriculture, Food and Natural Resources. We have close to 80 FFA members, and it was apparent that the expansion of this program, particularly in the area of livestock, needed to be met, with several students interested in ag as a career, and many of our local families raising both crops and livestock. We recently completed a large-scale greenhouse that will be in operation in the Spring of 2025. We also identified the need for our students to learn about genetics in breeding programs and breeding techniques. We were able to purchase an artificial insemination (AI) simulator that can teach our students the necessary skills of breeding livestock to be used on their own livestock operations, several of which are supervised agricultural experience projects.



Health Sciences. Thayer County Health Services helped us to identify areas of need through our partnership with them. We were able to purchase a suture kit, sports nutrition kit, and an EMT package worth \$25,999 to help work towards EMT certification for our students in the upcoming years. Several students have graduated with 30 credits or more in the healthcare sciences field, as well as being CNA certified and have their general education coursework completed as they head into their career field or two- or four-year colleges.



Skilled & Technical Sciences. Deshler Public Schools has had an elite CTE program for well over a decade. We have a very strong and long-standing partnership with Reinke Manufacturing. Through this partnership, Reinke Manufacturing has furnished a welding shop, including robotic welders, as well as providing us with a commercial level robotic arm and metal CNC lathe. In addition to equipment, they have also sent staff to teach our welding courses and coach a robotics team for us (which had the opportunity to go to nationals AND we are working to restart a robotics program in Thayer County now!). Many of our students have graduated with multiple levels of welding certifications, making them both career- and college-ready.

We are fortunate that Reinke Manufacturing sends their techs over to teach both student and adult welding classes in our facility, and that we have teachers who have stepped in (outside of their certification areas) to learn the trade as well. In our work with Reinke Manufacturing, there was a need to expand our programming. We are now teaching SolidWorks, as well as hands-on Irrigation and Electrical exploratory classes to our junior high students, and recently introduced a small engines class.

The reVISION grant allowed us to purchase \$69,729 worth of equipment for this program. We were able to purchase a CNC plasma table and an Epilogue laser so that our students would be able to expand their knowledge in the area of metal fabrication. We are hoping that these purchases help to expose our students to entrepreneurship as well as building a school-based enterprise.



I would encourage districts to consider participating in the Academic Decathlon competition.

Academic Decathlon is an activity that is dependent on students of different ability levels. A team is made up of students who are in the Honors (A average), Scholastic (B average), and Varsity (C average) levels. Students may move up, but they may not move down. The combined scores of the students in all 10 competition events are counted, thus each team member is very important. There is a defined course of study in each subject area each year. Subject areas are commonly Math, Language & Literature, Science, Social Science, Economics, Art, and Music which are covered in the Regional competition each year. At the State Competition, Speech, Interview, and Essay are added. There is a “theme” each year that many of the subject areas cover. The theme for 2022-23 was the American Revolution. The theme for 2023-24 will be “Technology and Humanity”. Regional competition takes place in January and State competition takes place in February. The school can decide how to prepare for the competitions. Some schools have teams that have practices in the evenings or after school. Some simply provide the students with materials to study prior to competitions. Other schools offer a class to prepare.

Quiz Bowls are wonderful and fun activities, but they do not have a defined course of study like the Academic Decathlon. I find the Decathlon to be the best academic competition that I have experienced. To me, it is based on true study and learning.

This year as I worked the State Academic Decathlon Championships, I had an opportunity to connect with great kids from NRCSA-member districts Adams Central, Johnson County Central, and Lexington.

On a personal note, three of my four kids participated in Academic Decathlon through high school and between them they won thousands of dollars in scholarships as they were on teams that had success. I currently serve on the Nebraska Academic Decathlon Board of Directors. I have been very involved with this activity for many years and highly encourage you to consider adding it to your school. A new school can have its enrollment fee waived the first year and may receive free study materials.

Led by the UNL Department of Educational Administration, the *Growth-Oriented Leadership Development (GOLD) Project* is a collaboration across NCSA, NRCSA, ESUCC, and NDE. Goals include:

- Strengthening School Leadership
- Improving Principal and Teacher Retention

GOLD Highlights:

- A focus on local, building/district level context, not a top-down, one-size-fits-all approach

- Use of existing professional development structures led by credible leaders and coaches
- No additional costs or duties to ESUs or districts

- Regular, large group professional development for the principal and 2-3 teacher leaders per building

Chadron State College Special Education Para-to-Teacher Program Initiative.

Purpose: This “Grow Your Own” Special Education Teacher program is designed to provide school districts with the opportunity to cultivate and participate in the training of their para-professionals who wish to continue their education to become special education teachers.

Who: Any individual who holds a minimum of an Associate's Degree (or equivalent credit hours) from an accredited higher education institution, and who is employed as a para-professional within a school district.

What: Chadron State will provide required course work and enrichment activities via online, face-to-face (via Zoom), and on the job experiential learning, leading to a Bachelor's in Education Degree, and a Nebraska Teaching Certificate with an endorsement in Special Education (grades PK-12). With administrator input, program course work will be tailored to best fit your district practices and expectations. Each course will be offered in an 8-week format, with 12-13 credit hours to be completed each 16 week semester.

How: Program participants will be advised, monitored, and supported by CSC faculty/staff, and a CSC Education Program liaison is specifically assigned to facilitate their progress. District para-professionals may enter the program at any time in the academic year.

When: once participants reach their senior academic year they will embark on completing their capstone course work, via online and Zoom class sessions. This course work has been pared down considerably with the understanding and assumption that these student teachers will be learning “on-the-job”. For example, one section covers classroom management practices. Clearly, one can argue and attest that these student teacher interns are learning more about managing a classroom from being mentored by veteran teachers within your school, and observing them in action. This is the belief and learning approach embraced during this senior year. However, to ensure and assess concept learning, Chadron State faculty will be meeting with your student teacher cohort twice per week for 1.5 hours, via Zoom conferencing technology.

Graduation: At the completion of this program students/candidates graduate from Chadron State College, and apply for teaching licensure resulting in a valid initial teaching certificate with and endorsement in PK-12 Special Education. Chadron State's education program is nationally and State accredited. As such, interstate certification reciprocity is not a problem.

Things for your consideration:

- 1) To qualify for this program participants must hold at least an Associate's Degree or the equivalent in college credit hours. (CSC will work with those applicants to provide them with the needed coursework leading up to program entry).
- 2) Districts must agree to maintain para-professional employment throughout the course of the program—including during the student teaching experience.

The UNL Department of Educational Psychology has received a grant from the Swanson Foundation which allows them to offer mental health services to rural schools.

From Dr. Michael Scheel, Chair of the UNL Department of Educational Psychology:

The UNL Department of Educational Psychology would like to offer counseling and psychological services, as well as consultation services to the schools and communities of Southeast Nebraska. We run a mental health counseling and therapy clinic and we are offering counseling and consultation services to teachers, administrators, students, and community members of Southeast Nebraska. Services will be provided through remote and confidential means (i.e., Zoom conferencing). We are hoping that schools, families, and individuals contact us to schedule an appointment for a telehealth counseling or consultation session.

We have recently learned that a donor will support our work with individuals living in rural Southeast NE by paying all fees for services. Thus, whoever seeks out our services will simply have to indicate they live in Southeast Nebraska, and any services we provide will be paid for through the UNL Foundation. Individual, couple, and family counseling will be provided without financial expense. Additionally, we can provide teachers, school administrators, school counselors, and school social workers consultation services for students of their schools without charge.

We are very excited to enter a partnership with schools and communities of SE Nebraska to promote mental health and well-being. We are aware of the mental health counseling disparities that exist in Nebraska

rural areas, and our department, our College of Education and Human Sciences, and UNL are highly interested in offering our expertise and resources with the goal of enhancing the well-being of SE Nebraska individuals, schools, and communities. We are a group comprised of licensed psychologists and psychology graduate students who regularly provide services through our clinic to the Lincoln community. We are seeking to reach beyond Lincoln to connect more with surrounding rural areas. We also are acutely aware of the importance of addressing mental health concerns right now as we all are experiencing the stress of going through the COVID-19 pandemic.

The Counseling and School Psychology Clinic is a training clinic in which graduate students in counseling and school psychology work with clients under the supervision of licensed psychologists. Services are available to all on a sliding scale. For clients from SE Nebraska communities, services will be paid for through UNL Foundation funds supplied by a donor who cares deeply about the welfare of schools and communities in SE Nebraska. Counseling services are offered to improve well-being, improve academic and behavioral issues, stabilize mood, manage stress, and improve life-adjustment issues.

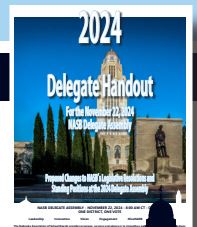

The board of education shall conduct its meetings in accordance with the Nebraska Open Meetings Act. The board shall make reasonable efforts to accommodate the public's right to speak on agenda items. The board may make and enforce reasonable rules and regulations regarding the conduct of persons attending, speaking at, videotaping, photographing, or recording its meetings.

The board shall not require members of the public to identify themselves as a condition for admission to the meeting, nor shall such body require that the name of any member of the public be placed on the agenda prior to such meeting in order to speak about items on the agenda. However, the board may require members of the public desiring to address the board to identify themselves.

Speakers will be permitted to address the Board in a manner consistent with free speech rights. However, offensive language, defamatory remarks, and hostile conduct will not be tolerated.

There were no comments from the public.

Discussion and Action Items

Discuss and take appropriate action on the 2024-2025 budget, with consideration of the following funds: General, Depreciation, Employee Benefits, Contingency, Activities, Special Building, Bond, School Lunch, Qualified Capital Purchase, Cooperative and Student Fee Funds.

Mr. Farup and the board held a discussing addressing questions that were asked during the Tax Request hearing. Some of the information that was shared is as follows:

- There is an outstanding balance on the stadium of \$207,000. We currently have those funds in the Special Building Fund.
- There was a misunderstanding regarding the law/statute prohibiting a budget/tax request increase if valuations increase. The statute states that if the tax levy exceeds the prior years tax request, the board is required to hold public hearings regarding the increase. Two hearings were held prior to this

meeting, plus the Wayne County Joint Hearing last week, so the requirements of the law have been met to increase the levy. This was confirmed with the Chief Financial Officer of Nebraska.

- When we received ESSER money in 2020, we did not receive a lump sum payment. We received a “promissory note”. We had until September 30, 2024 to spend those funds. Any items over \$5,000 had to have prior approval by the State, which we did for two items. We were able to spend the money according to what was allowed. Once the money is spent, we file for reimbursement. The funds were not always spent and reimbursed in the same fiscal year.
- Last year’s tax request went down 13%. This year the tax request increased by 18% largely due to the decrease in state aid.
- It has been suggested to eliminate pre-school. Pre-school allows kids two years to prepare for kindergarten. We have a lot of students with challenges. If we didn’t have those two years to prepare them, it would take a lot of time in kindergarten to get students where the State wants their learning to be in Kindergarten. It is always something we can look at, but feel that it is very beneficial for our students.
- At last week’s meeting, the possibility of borrowing money to pay bills was mentioned. This would only happen because of cash flow issues. We receive the majority of our tax payments in October, January and May. The payment we receive in October is based off of last year’s tax request. We would eventually have enough revenue to pay that bridge loan off, we just have to wait until the tax money comes in.
- The proposed tax request is a 18% increase over last year. However, it is only a 2.5% increase over the 2022-2023 tax request.
- During the July board meeting, the Board approved a resolution allowing the district’s base growth percentage by up to 6% for the 2024-2025 budget year. The taxing authority base growth percentage was set by the state at 7.48%, which would be a maximum of \$5,986,388 tax asking. LB 243 allowed the Board to approve an extra 6%, adding an additional \$497,899 to our maximum taxing authority, bringing it to \$6,484,287. This was the number given to Wayne County for the pink postcards. The Board did not intend to use all the funds, but needed the ability to budget a portion of it, similar to the previous year. The Board quickly and strongly heard from the community that that tax request was not acceptable, therefore the proposed tax request was dropped to \$5,500,000.
- Mr. Farup had a conversation with Lee Will, Chief Financial Officer of the Nebraska Department of Revenue on September 23 regarding LB 34 which was passed during the special session. According to Mr. Will, the state will pay up to 30% of the school tax request. So, when patrons receive their property tax statement in December for 2025, they will be responsible for 70% of the school tax request. The press release from the Department of Revenue states that on average all state property tax will go down by 20% depending on increased assessed value. Mr. Farup stated he was unsure how personal income taxes would be affected by the change in frontloading the credit in the provision of LB 34.
- The Depreciation fund is a type of “savings account.” This account can only be used to replace depreciable items such as vehicles, desk, chairs, equipment. It cannot be used for staff expenses. The account balanced is budgeted as a possible expense, because if you don’t budget it, you can’t spend it without amending the budget and going through the hearing process.
- The Special Building Fund is used for capital improvement such as land or building purchases, portable classroom lease payments, stadium lease purchase payments, sidewalk repairs.
- Mrs. Zach is the EL/SPED and School Improvement Director. 80% of her salary and benefits are paid with Special Education funding. We receive 80% of those expenses back as reimbursement the following year. If you have a Superintendent, Teacher or Principal as the Special Education Director, those salaries and benefits are not reimbursable.
- Every board member serves on three committees made up of three board members. Not every detail of what the board votes on is discussed at the board meeting because the details were hashed out by the committee, and then the committees made recommendations to the board.

Elementary Principal Report

- Total elementary enrollment is currently 349.
- Starting September 16, a new homework policy is being implemented in the 5th and 6th grades. 5th and 6th grade is a pivotal time in education for students. The 5th-6th grade teachers and I feel this policy will bring some consistency for those grades. Expectations have been laid out for both students and parents.
 - If a student has a late assignment during the school day, the student is required to go to the Middle School Achievement Center (MAC) to complete the assignment(s). If the student has a conflict that can't be resolved, they will stay the following day after school
 - If the student skips out, the student will make up two days and still complete the assignment. The student will stay with the principal until 4:05 p.m.
 - Students will get a grade on the quality of the work of the assignment. There will be no deduction for late assignments.
 - Students will receive one "oops" per **semester**. This does not mean one per subject. With the "oops", they do not have to stay after, but they need to get the assignment turned in by the next day.
 - Teachers will contact the administration when a student has a late assignment. The administration will contact the parent(s) regarding the late assignment and let the parents know the student will be staying after school.
 - Students will report to the after-school study hall at the Middle School Achievement Center.
 - Students will stay until 4:05 p.m. regardless if they have their late work finished. They will hand the finished late work to the teacher in charge. If they get done before 4:05 p.m., they can use the extra time to complete other homework assignments.
 - Excessive late homework may result in a meeting between the teacher, student, and parent.
- ELPA21 screening for Kindergarteners have been completed.

- AimsWeb testing has been completed
- MAP testing will take place this week and next week.
- The data from testing will be used to determine how we can best help the students. Based on the Aimsweb data, goals will be made which will determine how often individual students will need to be progress monitored.
- The Positivity Project (P2) program has started to be implemented.
- There have been some changes with pick up and drop off this year. Parents can no longer park on the street between Johnson and Main. Preschool parents can drive up and a para will relay to the teacher which student is ready to be picked up.

Secondary Principal/AD Report

- Current 7-12 enrollment is 235
- The no cell phone policy that was implemented in August has been going well.
- One-Act team has been auditioning. Donna Johnson and Victoria Nelson are the coaches.
- Still looking for a junior high boys basketball coach for this year.
- Dr. Jon Cerny and Matt Brenn presented at the East Husker Conference AD Meeting to the Competitive Equity Committee.
- MAP testing has been completed in the high school.

District Program Director Report

- The EL Department presented the K-12 newcomer programs, student monitoring, teaching strategies and classroom accommodations for EL students to all staff. They did an activity with all staff simulating what it would look, sound and feel like being a second language learner.
- We received our NE Counts determinations. We were identified as “needs assistance” for a second year in a row. We were not high risk in the same areas as last year. Our preschool areas have improved. In our current report, we were identified as high risk for secondary transition and Targeted Improvement Plan. Only one ESU1 school was not identified as “needs assistance”. NDE has prescribed a plan of action in which we had to identify a technical assistance resource. We have chosen NeMTSS as our TA resource and will continue to work with Brooke Gebers, our regional lead. We already have feedback and data from HDE that we have improved our Targeted Improvement Plan because we have changed the process for developing, monitoring and reporting the TIP.
- The middle grade achievement center is up and running (referred to as the “MAC”). It is available for students before and after school as well as during the day who need extra help with homework.
- During Meet and Greet, the EL department prepared an orientation presentation for families new to our school system. We did not have any families attend the presentation, but families did come to receive help with enrollment paperwork. We will find an optional, more inviting time to do an orientation presentation for our new families.

Superintendent Report

- The Strategic Planning Committee met to review our Strategic Plan and Mission, Vision and Belief statements. Many of the items on the strategic plan have been focused on and accomplished. The district will have our five-year accreditation visit in the spring of 2026, and we will get a detailed report from the visitation team on our progress on the strategic plan and our school improvement process.
- Dashboards that have perceptual and financial survey data have been created. The dashboards will be linked to the school website for public view: Perpetual Data Dashboard Spring 2024 and Financial Dashboard Spring 2024

6043 Sharing Mapping Data

This policy shall provide for the sharing of information to public safety agencies in order to implement effective emergency response protocols.

Definition. Mapping data means maps relating to the school buildings or school property with data for an efficient emergency response.

Sharing of Mapping Data. Mapping data shall be shared in an electronic or printable format with public safety agencies that provide emergency services to district property to assist those agencies in responding to an emergency on district property.

Requirements Related to Mapping Data. Mapping data shared with public safety agencies pursuant to this policy shall meet the following requirements:

- The mapping data shall be compatible with and able to be integrated into software platforms used by public safety that provide emergency services to the specific school for which the data is provided without requiring:
 - The purchase of additional software by such public safety agencies; or
 - The integration of third-party software to view the data;
- The mapping data shall be a finished map product in a file format easily accessible using a standard or open-source file reader, depending on the needs of the school and the public safety agency;
- The mapping data shall be provided in a printable format;
- The mapping data shall be verified for accuracy, during production and annually, through a walk-through of the school campus;
- The mapping data shall give an indication of what direction is true north;
- The mapping data shall include accurate floor plans overlaid on accurate, verified aerial imagery of the school campus;
- The mapping data shall contain site-specific labeling that matches the structure of school buildings, including room labels, hallway names, external door or stairwell numbers, locations of hazards, key utility locations, key boxes, automated external defibrillators, and trauma kits using standard labeling rules set by the State Department of Education;
- The mapping data shall contain site-specific labeling that matches the school grounds, including parking areas, athletic fields, surrounding roads, and neighboring properties using standard labeling rules set by the State Department of Education; and
- The mapping data shall be overlaid with a grid and coordinates.

Annual Certification or Updates. The district shall annually:

- Certify to the appropriate public safety agencies that the mapping data provided pursuant to this policy is accurate; or
- If such information has changed, provide the appropriate public safety agencies with updated mapping data.

Reimbursement. The Superintendent shall apply to the State Department of Education in the manner prescribed by the Commissioner of Education for a grant to cover the costs of providing payment to vendors on behalf of the school district to facilitate the implementation of mapping data in accordance with this policy. Such application shall include a copy of this school policy, an estimate from a vendor on the cost of providing such mapping data that meets the requirements of this policy, and any other information the department may require. Alternatively, the Superintendent may apply to and contract with the district's educational service unit in the manner prescribed by the educational service unit for purposes of covering the costs of facilitating mapping data in accordance with this policy.

<p><u>DISTRICT MEETINGS</u> Each fall NRCSA conducts a meeting in each of the six membership districts. 2012: Board Code of Ethics

The board recognizes that collectively and individually, all members of the board must adhere to an accepted code of ethics in order to improve public education. Board members must conduct themselves professionally and in a manner fitting of their position.

Each board member shall:

1. Attend all regularly scheduled board meetings insofar as possible, and become informed concerning the issues to be considered at those meetings;
2. Endeavor to make policy decisions only after full discussion at publicly held board meetings;
3. Render all decisions based on the available facts and his or her independent judgment, and refuse to surrender that judgment to individuals or special interest groups;
4. Encourage the free expression of opinion by all board members, and seek systematic communication between the board and students, staff and all elements of the community;
5. Work with other board members to establish effective board policies and to delegate authority to the superintendent to administer the school district;
6. Communicate expressions of public reaction to the board policies and school program to other board members and the superintendent;
7. Learn about current educational issues by individual study and through participation in seminars and programs, such as those sponsored by the state and national school board associations;
8. Support the employment of those persons best qualified to serve as school staff, and insist on a regular and impartial evaluation of all staff;
9. Avoid being placed in a position of conflict of interest, and refrain from using the board member's position on the board for personal or political gain;
10. Refrain from discussing the confidential business of the board in any setting except a board meeting;
11. Refrain from micro-managing the affairs of the school district;
12. Recognize the superintendent as the executive officer of the board;
13. Work constructively and collegially with the other members of the board, students, staff and patrons.
14. Refer complaints to the superintendent or building principal, as appropriate;
15. Remember that a board member's first and greatest concern must be the educational welfare of the students attending this district's schools.
