6. This contract may be renegotiated by mutual agreement.

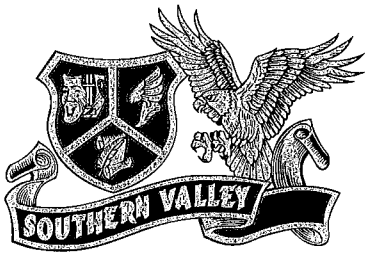
