This Amendment to the Addendum entered into as of the 1st day of July 2024 is, by and between Independent School District No. 29 of Cleveland County Oklahoma (District), the Office of Juvenile Affairs (OJA), and Oklahoma Court Services, Inc (OCS). The parties have decided to continue Preventing Recidivism through Opportunities, Mentoring, Interventions, Support, and Education (PROMISE) – a program for offering education opportunities for youth within OJA through the vehicle of a collaborative approach to the individual needs of the students within the OJA control.

OJA will provide a classroom within the geographic boundaries of the District and will ensure that appropriate security is available at all instructional times consistent with the primary agreement between the District and OJA. The District will supply a classroom teacher and education related materials and instructional supplies normally provided to students attending District schools. Transportation will also be provided by or paid for by the District. In addition, pursuant to a general order of the Cleveland County District Court, the District shall provide individual student information consistent with the Court's Order and subject to the Family Educational Rights and Privacy Act (FERPA).

OCS will provide a support person for the purpose of providing security in the classroom setting.

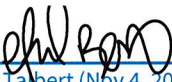

## SPEECH LANGUAGE SERVICES AGREEMENT

This Speech/Language Pathology Services Agreement (the "Agreement") dated as of the 11th day of November 2024 is between Independent School District No. 29, Cleveland County, Oklahoma, a/k/a "Norman Public Schools" ("NPS") with a notice address of 131 South Flood Avenue, Norman, Oklahoma 73069, and Angela Smith ("Smith"), with a notice address of 1320 Buffalo Trail, Noble, Oklahoma 73068.

In consideration of the mutual terms, covenants and conditions specified in this Agreement, Norman Schools and Smith agree as follows:

- 1. Speech/Language Pathology Services.** Smith agrees to provide licensed speech/language pathology services (the "Services") and/or licensed speech/language assistant services (SLPA) to the designated students of NPS as requested during the term of this Agreement.
- 2. Certification and Licensure.** Smith represents and warrants that she is a certified speech/language pathologist licensed by the State of Oklahoma and that she has been awarded a Certificate of Clinical Competence in Speech-Language Pathology by the American Speech-Language-Hearing Association. Smith shall notify NPS immediately if, for any reason, her Oklahoma license is suspended or if her certification is not renewed upon expiration.
- 3. Confidentiality.** Smith agrees to adhere to all state and federal laws regarding the confidentiality and privacy of the education records and patient healthcare records of students and students with disabilities. Smith specifically agrees to comply with the provisions of the Family Educational Rights and Privacy Act (FERPA), and the Health Insurance Portability and Accountability Act (HIPAA), as well as all applicable laws and regulations related to privacy and security. Smith acknowledges that she may have or obtain access to confidential "education records", as defined by FERPA, and agrees that she will not disclose any such education records except to perform her duties under this Agreement or as required by law.
- 4. Insurance.** Smith represents and warrants that Smith is insured under a general and professional liability policy in a minimum amount of \$1,000,000.00. Smith agrees to maintain each of the foregoing insurance policies at all times while this Agreement is in effect and agrees to notify NPS immediately should either of the foregoing policies be canceled. Smith will provide NPS with a certificate evidencing such policies.
- 5. Indemnification.** In addition to the requirement of paragraph 4 and not in lieu thereof, Smith agrees to indemnify and hold NPS and its agents, employees and officers harmless (including defense costs) against any claim, demand or action against NPS arising from Services provided by Smith.


6. **Worker's Compensation.** Smith represents and warrants that Smith is not covered by Worker's Compensation Insurance and shall in no event be entitled to such coverage from NPS.
7. **Prior Criminal Convictions.** Smith hereby certifies that Smith is not currently registered or required to be registered under the provisions of the Oklahoma Sex Offenders' Registration Act or the Mary Rippy Violent Offender Registration Act.
8. **Compensation.** NPS agrees to pay Smith at the rate of \$70.00 per hour for the Services provided by Smith for the remainder of the 2024-25 school year, ending May 31, 2025. Smith agrees and acknowledges that all invoices and applicable required documentation and time logs shall be submitted to NPS no later than the 6th business day of the month following the month in which the Services were provided and that NPS has no obligation to forward payment to Smith until NPS has been provided with such. NPS shall have no obligation to Smith as an employer for withholding and remitting taxes, insurance, FICA, etc. Smith, and not NPS, shall be responsible for the payment of any business expenses, such as transportation costs incurred by Smith in the provision of Services hereunder. This agreement does not apply to extended school year services provided to NPS by Smith. Such extended school year services shall be set forth in a separate agreement between the parties, if applicable.
9. **Term and Termination.** This Agreement is effective as of November 11<sup>th</sup> 2024 and shall continue in effect through May 31st, 2025, unless terminated earlier as provided herein. Either party may terminate this Agreement upon thirty (30) days' written notice with or without cause. The specific starting date for the delivery of Services will be mutually determined by Smith and NPS.
10. **Independent Contractor Status.** Smith is acting as an independent contractor and neither Smith nor any employee or subcontractor of Smith shall be deemed to be an employee of NPS. Neither party undertakes by this Agreement or otherwise, to perform any obligation of the other party, whether regulatory or contractual, or to assume any responsibility for the other party's actions, business or operations. Smith shall not have the authority to bind, commit or incur any liability on behalf of NPS or to otherwise act in any way as an agent or representative of NPS. In no event will Smith be entitled to employee benefits from NPS.
11. **Force Majeure.** Neither party shall be responsible for any failure or delay in the performance of any obligations due to any cause beyond its reasonable control, including, but not limited to, any such delay or failure arising from third party labor disputes, third party strikes, other third party labor or industrial disturbances, acts of God, floods, lightning, earthquakes, shortages of materials, rationing, utility or communication failures, fire, casualty, war, acts of public enemy, riots, insurrections, embargoes, blockages, actions, restrictions, and new or changed regulations or orders of any governmental authority; provided that the party claiming force majeure event has given the other party reasonably prompt notice of the event.

**12. Notices.** All notices given hereunder shall be in writing and shall be given or sent by (i) certified, first class, U.S. mail to the parties at the addresses herein or at such other addresses of which either party may give notice; (ii) confirmed facsimile; or (iii) nationally recognized courier service to the parties at the addresses herein or at such other addresses of which either party may give notice.

**13. Miscellaneous.** This agreement embodies the entire agreement and understanding between NPS and Smith relating to the subject matter of this Agreement, and supersedes all previous communications, representations, understandings, and agreements, whether oral or written. This Agreement is to be governed by and construed in accordance with the laws, excluding the conflicts laws, of the State of Oklahoma. This Agreement may be amended only in a writing signed by both parties. If any provision of this Agreement is held by a court of competent jurisdiction to be invalid or unenforceable, then that provision will be severed from this Agreement and any remaining provisions will continue in full force and effect. This Agreement shall be binding upon and inure to the benefit of and be enforceable by the parties to this Agreement and their respective successors and permitted assigns. This Agreement may not be assigned by either party without the prior written consent of the other party. No waiver by either party hereto of any breach of any provision herein shall constitute waiver of any other provision nor shall such waiver constitute consent that the breach may continue or that any other breach will be waived. In the event of any suits or actions or other proceedings to enforce the terms of this Agreement, the prevailing party shall be entitled to recover its reasonable attorney fees and other costs and expenses incurred therein. The confidentiality provisions of this Agreement shall survive the termination of this Agreement.

## **EightTwenty Solar Purchase Agreement**

THIS AGREEMENT is made on September 24, 2024 by and between EightTwenty Oklahoma, LLC (DBA EightTwenty), hereinafter referred to as the Contractor, and Norman Public Schools, hereinafter referred to as the Owner.

### **Article 1. Scope of Work**

The Contractor shall furnish all materials and perform all work shown on the drawings and/or described in the specifications entitled Exhibit A, as annexed hereto as it pertains to work to be performed on property located at 125 Vicksburg Avenue Norman, Oklahoma 73071.

### **Article 2. Time of Completion**

Contractor will commence with project pre-construction activities upon 1) receipt of signed contract and 2) receipt of initial deposit OR approval from a Preferred Financing Partner of EightTwenty. Dates of work and completion date are contingent on weather and availability of materials and labor.

### **Article 3. The Contract Price**

The Owner shall pay a Contract Price of \$14,980 for the materials and labor to be performed to install their solar solution. This Contract Price is subject to additions and deductions pursuant to authorized change orders.

### **Article 4. Progress Payments**

#### *Contract Progress Payments*

The Contract Price shall be paid in the manner following:

- \$1,498 (10% of Contract Price) initial payment due upon contract signing.
- \$5,992 (40% of Contract Price) due upon procurement of solar materials.
- \$5,992 (40% of Contract Price) due once the solar system has been installed.
- \$1,498 (10% of Contract Price) due once final inspections have been completed and power turn on (PTO) has been approved by the utility.

**Article 5. Additional Items**

1. 5-Year Limited Workmanship and Installation Warranty. Contractor warrants that the System will be constructed and installed in a good workmanlike manner according to the standards of care and diligence generally practiced by solar engineering, construction, and installation companies when installing photovoltaic solar power systems of a similar size and type as the System in the geographic region where Your Property is located, and pursuant to good engineering design practices, (ii) manufacturer's instructions, (iii) applicable law (including local codes and standards), (iv) required governmental approvals and permits, and (v) applicable requirements of the local utility. This 5-Year Limited Workmanship and Installation Warranty will extend for a period of five (5) years from the date installation of the System is completed by EightTwenty Oklahoma LLC.
2. 5-Year Limited Roofing Penetration Warranty. Contractor warrants Owner roof against damage and water infiltration at each roofing penetration made by Contractor in connection with the installation of the System and the surrounding area of each such penetration (collectively, the "Covered Roof Areas"). The Contractor does not warrant or guarantee the condition of the roof prior to installation of the system. Contractor will repair damage to Owner roof and repair or compensate Owner for actual physical damage to Owner property resulting from any water infiltration in the event of failure or defects in the Covered Roof Areas.
3. Production Guarantee: Contractor guarantees system production in the following manner: If the 4.36 kW DC STC solar panel system produces less than 7,332 kilowatt-hours (kWh) in year one, the contractor will install additional solar panel(s) to bring the total solar production to at least 7,332 kilowatt-hours (kWh). This amount is equal to 90% of the expected performance of the system.
4. If space is not available for a system expansion, the Contractor will refund the Owner. The refund would equal the percentage of the production shortfall (amount beyond 90%) multiplied by the Contract Price. (e.g. if the system performed at 89%, Owner would receive a 1% refund).
5. The Production guarantee does not include loss of kWh production due to force majeure events including but not limited to power outages or snow. Force Majeure Event is an available event such as a hurricane, government forced shut down of commercial operations or order to shelter in place, or labor strike that is outside the control of the Contractor or Owner that prevents performance of obligations. Additionally, the system must be connected to the monitoring software at all times during the first year to allow Contractor to monitor kWh production.

**Article 6. General Provisions**

1. Contractor may at its discretion engage subcontractors to perform work hereunder, provided Contractor shall fully pay said subcontractor and in all instances remain responsible for the proper completion of this Contract.
2. If trenching is done for buried conduit, then backfill will be done by Contractor or subcontractor with existing spoils only to a mound one time. Seed, hay, and/or sod is not included. Contractor is not responsible for damage, if any, to tree roots, flowers or plants.
3. If a boom lift or scissor lift is used, Contractor is not responsible for tire marks or ruts in the Owner yard/field or the Owner surrounding property.
4. Contractor shall furnish Owner appropriate releases or waivers of lien for all work performed or materials provided at the time that the next periodic payment shall be due.
5. All change orders shall be in writing and signed by both the Owner and Contractor.
6. Contractor agrees to remove all debris and leave the premises in broom clean condition.

7. Owner acknowledges that any grant money received is taxable.
8. Operational maintenance, such as panel cleaning, not covered by the above warranty is not included in this contract and may be purchased and billed separately.
9. In the event Owner shall fail to pay any periodic or installment payment due hereunder, the Contractor may cease work without breach pending payment or resolution of any dispute.
10. Owner has 3 business days to cancel from the signed date on this Contract. Cancellation requests are to be sent via email to support@eighttwenty.com.
11. If discovered that Homeowner Association or Historic Preservation Restrictive Covenants prohibit the installation as specified prior to interconnection, Owner may work with Contractor to amend this agreement to mutual satisfaction or cancel this agreement if an amendment can not adequately be made.
12. All disputes hereunder shall be resolved by binding arbitration in accordance with the American Arbitration Association.
13. Contractor shall not be liable for any delay due to circumstances beyond its control including the availability of specialty labor or materials or weather.
14. Owner agrees to indemnify, defend and hold Contractor, its respective affiliates, officers, directors, employees, shareholders and agents harmless from and against any and all liabilities, claims, costs, losses, damages, and other expenses that Contractor may incur, become responsible for, or pay out as a result of or in connection with bodily injury (including death) to any person, damage to any property, contamination of or adverse effects on the environment, or any violation of applicable laws or regulations, in connection with or arising out of any and all acts or omissions of Owner, Owner's agents, representatives, or employees under or in connection with this Contract or system, including but not limited to the Owner's breach of any provision or warranty contained herein.
15. This Agreement shall be governed by the laws of the State of Oklahoma.
16. This Agreement represents the entire understanding between the Parties with respect to the subject matter of this Agreement and supersedes any or all previous agreements or arrangements (whether oral or written) between the Parties.
17. Contractor reserves the right to photograph and take video footage of the project site for future marketing purposes.
18. This Proposal is valid for 14 days from Date of Agreement.
19. EightTwenty is a Licensed Contractor in the following jurisdictions: Arkansas (0424630423), Indiana (by County), Kentucky (CE65963), Missouri (2021047158), Oklahoma (OK095963), Texas (37191)
20. Contract is contingent upon below-grade site survey results, including but not limited to, existing utilities and soil conditions. Should results alter project scope, contractor to present a revised contract.
