WHEREAS, public notice was given at least four days in advance of a Special Hearing called for the purpose of discussing and approving or modifying the District's Tax Request for the 2021-2022 school fiscal year for the General Fund, Bond Fund, and Special Building Fund of Franklin County School District 31-0506; and,

WHEREAS, such Special Public Hearing was held before the Board of Education (hereinafter "the Board") of Franklin County School District 31-0506 (hereinafter "the District") at the time, date, and place announced in the notice published in a newspaper of general circulation, a copy of which notice and proof of publication of which is attached hereto as Exhibit A, all as required by law; and,

WHEREAS, the Board provided an opportunity to receive comment, information and evidence from persons in attendance at such Special Hearing; and,

WHEREAS, the total assessed value of the property differs from last year's total assessed value by 0.17%; the tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be \$0.989731 per \$100 of assessed value; the Franklin Public Schools proposes to adopt a property tax request that will cause its tax rate to be \$1.000096 per \$100 of assessed value; and,

WHEREAS, based on the proposed property tax request and changes in other revenue, the total operating budget of Franklin Public Schools will exceed last year's by 12.16 percent; and,

WHEREAS, the Board, after having reviewed the District's Tax Requests for each said fund, and after public consideration of the matter, has determined that the Final Tax Requests as listed below are necessary in order to carry out the functions of the District, as determined by the Board for the 2021-2022 school fiscal year; and,

NOW BE IT THEREFORE RESOLVED that (1) the Tax Request for the General Fund should be, and hereby is set at \$4,279,719.80; (2) the Tax Request for the Special Building Fund should be, and hereby is set at \$167,677.00 for the 2021-2022 school fiscal year.

1. This years Wellness Committee Members were shared with the committee with attendance taken.
2. The staff's EHA Wellness Elevate status was shared with the group with 18 out of a necessary 20 needed showing completed for the Elevate program. If we get to 20 we will once again receive the \$5,000 grant for this coming school year. The committee then discussed what we would like to do with this money for this year. In the past the money has been used for a bonus by buying a box of FFA Fruit and a \$50 Rightway Gift Card to all who completed Elevate in the Previous Year.
