The Cognia accreditation team of Dan Leikvold, Laurie Hanna, and Micki Charf met with the Leadership team of Mrs. C Nagel and Dr. Crossman for the Cognia debrief. Mr. Leikvold will be writing up a report within the next 30 days and will send that off to Cognia. We do not get to see that report. Cognia will let us know at a later date of our status - may not be till May or June. We did not have any infractions to be concerned with.

The Cognia evaluators thanked the Cognia team for having all documentation in place and well written. They stated it made their jobs so much easier. They appreciated the hard work that was put into this in the last three months as this is a six year process.

The team acknowledged we have a Priority Plan to work off of which eventually should be our School Improvement Plan and to always have that in place. So they were pleased we have a process in place to continue to have a plan to follow.

Items Isanti is doing well

All data from surveys and interviews with staff, students, and stakeholders indicated we have a safe and welcoming environment at the school.

The PLC in place in the elementary school is very strong. This brings professional growth for teachers centered around student learning. This needs to continue.

Emphasis on SEL (Social Emotional Learning) - this needs to continue to be provided to meet students needs so they can be ready to learn.

Commitment to the Dakota Culture - having this as a content and not just as a special brings stability to making sure culture continues.

Early Intervention and emphasis on Early Childhood programs is a great movement to establish a strong foundation. Kindergarten readiness and emphasis on school readiness will help the academic gap in early grades.

The Graduation Coach - awesome job, never get rid of this position. Working with Guidance counselor has made a true impact on student graduation.

Exposure to other activities, students have exposure to many events and activities outside the academic day. LNI was mentioned as students were leaving for that.

Areas for improvement

Extend PLC work to the middle school and secondary level, staff are asking for professional development and support in these areas. It started then stopped when the HS principal was changed.

Build up CTE or programs students are interested in with stakeholder and student input to improve rigor and engagement of learning.

Communication to all - staff, stakeholders, and students needs to be better and transparent. Change in District Leadership makes gaps and lack of communication.

Consistent discipline model - follow handbook and communication around the model for all involved - students unsure of expectations, unclear to staff and stakeholders.

SEL - needs a deeper dive and understanding, more support is needed in the school for staff and students to overcome barriers of learning.

Retention of high quality staff - Standard 9 and 11 - strengthen structures in place so they do not go away or change with administrators.

- Standard 9 - increase effective individual and collective leadership roles among stakeholders.
- Standard 11 - maintain instructional structures that support learners and staff in both stable and changing environments

Bring back the WIT team format so all staff are involved in the school and committed to the vision and mission statements. Students want a voice with the student council back in place.

Utilize our collective commitments and cardinal virtues - they are very good, we need to have these be more intentional and visible to all.

The information from our Cognia Accreditation should be used in creating our action steps within Priority plans. The process and resources available through Cognia should be ongoing throughout the years, not just during the event.
