in Conference Room B at the high school to accommodate social distancing due to the  
coronavirus pandemic.

1. Call to Order

Board President Tom Bredvick called the September 14, 2020 MPS Board of Education  
meeting to order at 6:30 p.m. Roll call with the following members being present: Dennis  
Berry, Tom Bredvick, Loretta Hauxwell, Brad Hays, Mike Langan, and Teresa Thomas;  
Absent: None.

Mr. Bredvick reminded those present of the Open Meetings Law on the entryway table  
and asked all to stand and join him in reciting the Pledge of Allegiance.

2. Reports, Communications & Public Participation

Alec Langan proved the Student Council Report. He stated they have been working  
hard on the Teens in the Driver Seat Program stressing wearing seatbelts. The 10  
student council members also decorated for Homecoming Week.

Jeff Gross presented information on the Washington Trip. After much research and  
discussion with travel agents the trip will be cancelled due to the pandemic.

4. Reports from Staff Members and Committees

Brad Hays reported for the Activities Committee. They met on Sept 22 and discussed the current status of activities relating to the Covid19 Pandemic. The main focus is keeping students healthy and safe. There have been some changes to arrangements and scheduling. Athletes are wearing masks so they don't lose the opportunity to compete. All clubs are meeting now and practicing social distancing.

The activities manual and coach's manuals have been updated.

Homecoming week activities include, dress up days, bonfire (which was postponed due to high winds). There will be no Homecoming dance, and royalty will be crowned after the football game.

Other items include, no haunted house this year, Choir and Band concerts will be separated to allow for social distancing, and there are no team meals. We need to follow MCC rules with activities at their location.

5. Board and Administrative Comments

Mr. Norgaard reported on how Covid19 is impacting schools. There is a Covid tracker on the District Website. The numbers can cause us to get a bit anxious; however, to date, we have yet to have a quarantined case turn into Covid19.

Of the active cases, none have come from school. They have all come from community and family social gatherings. The safety of our students and maintaining in person learning is our focus. We are keeping a close watch on where the cases are coming from.

We do have some students quarantined. It would have been much worse if not for mask wearing. We space the kids the best we can. We know that lunch time is an issue.

All of the administrators and staff are working to make the best decisions. As community numbers rise, so do those of the District. We continue to remind all students and staff to wear masks so they can stay in the game and stay in school.

Last week when we went to Orange it triggered the mask mandate. The mask mandate will be for all indoor games and will expand into winter activities. We can require spectators to wear masks per our school attorney. We are trying to keep kids safe and in school.

Tom Bredvick added that the NASB conference is coming up. You can participate virtually or in person. Contact Heather if you would like to attend. All Board Members are signed up for virtual but can attend in person if desired.

Mr. Berry signed up for the local area meetings. Because one board member signed up the rest can watch for no charge.

Mr. Brazell commented it is a busy time in the business office. The Annual Financial Report, the Audit, and the Special Education Final Financial Report are all due by the end of October.

The High School suffered some damage from the wind Sunday night. A fresh air intake was blown off the roof causing some roof damage. We are still assessing the damage and the cost to repair.

Board Comments:

Loretta stated that the Fees Policy was added as an appendix at the end of the online board agenda.

Mike commented that people are becoming more aware of Covid19. He stated that the staff are doing a fantastic job of managing and leading by example.

Teresa noted that it is negotiations time again. We will need to meet with the teacher representatives at least once prior to November 1. The committee is Tom, Teresa and Dennis.

Tom stated that he already discussed the NASB training opportunities.

Brad did not have a comment.

Dennis talked about having a group watch of the NASB trainings.

Alec Langan stated that his brother is in medical training in Omaha and has shared his concerns about the coronavirus and that we need to take this seriously.

## 7. Positive Comments

Alec Langan commented on how well everyone is wearing masks. He also stated that kids want to be in school. MPS is a place kids want to be. It is a fun learning environment. They would rather be here than quarantined at home.

Mr. Brazell is glad that we are still in session. With the growing Covid cases it is a testament of students and staff working hard to do the right thing. Free meals started on September 21 and those are going well.

Mrs. Thomas stated that parent teacher conferences went well. Principal reports show a high percentage of attendance. Parents wore masks and had an opportunity to get in the classrooms and to see the safety measures in place.

Mr. Berry commented on the Central Elementary Book Fair. The reports show a high percentage of attendance at Parent Teacher Conferences. Also, congratulations to the tennis team for winning the GNAC conference title for the third year in a row.

Mr. Hays provided congratulations to Savannah Schafer, MPS Ag instructor, for being one of 18 across the state to receive a grant from Farm Bureau. He also congratulated the tennis team.

Mr. Langan stated that the administrative team has made everything work. We have hit a balance that is just right concerning the pandemic. Kids want to be in school.

Mrs. Hauxwell reported that this is a tough time to lead kids. There is just a lot of strain and stress to do the right thing. It is also great to see teachers engaging with kids on Saturday and leading positively. The Band competed in Ogallala and it was great to see our kids supporting students from other schools.

Mr. Bredvick commented that there is a lot of teamwork going on. I think we are communicating better and are more cognizant of what is important and what is impacting classroom safety and learning. People are observing, watching and learning. They are also leading by example and holding each other accountable.

Mr. Norgaard thanked Tom Bredvick, Teresa Thomas, and Brad Hays for agreeing to run for school board again. They are leaders in our community and are willing to step forth and provide guidance and leadership for MPS.

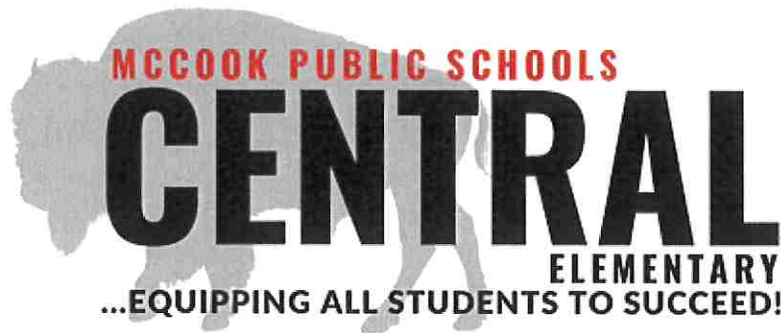

**McCook School Board Report**  
**November 9, 2020**  
**Special Education Dept., John Hanson, Director**

- 1) The SPED Teachers are doing a great job of getting done with all of the associated paperwork and meetings required for regular annual IEPs and those situations where paperwork is required for children who have missed significant amounts of time due to a school issued quarantine or a parent based decision to not send the child to school.
- 2) Thank you to Rachelle Kotschwar who filled in admirably for DLC Teacher Samantha Shiers who was out on maternity leave.
- 3) Thank you to Ismael (don't know last name) who has filled in admirably for regular SPED bus route driver Rod Peters who has been out the last two or three weeks.
- 4) Two manifestation determination hearings/meetings were held at the Junior High a couple weeks ago. Those meetings are required when a child with a disability has been proposed to have been suspended or expelled for more than 10 school days. The team consisting of parent(s), regular classroom teacher(s), special education teacher, and an administrator needs to determine whether the incident that lead to the disciplinary action was a manifestation of the child's disability or not. If it is not, the proposed consequence is upheld. If it is a manifestation, an alternative consequence must be chosen, or the child's IEP/program must be changed to meet the child's more unique needs. In both of these two recent cases, the team decided it was not a manifestation of the child's disability, so the proposed consequence of suspension was upheld.
- 5) Usually every other year I attend the annual Tri State (NE, IA, & KS) SPED Law conference. I am not attending it this year for two reasons: 1) I just attended it last year, and 2) It's over zoom, and I am not a huge fan of attending 8 hours in one day of zoom sessions and then 4 hours the next day of zoom sessions, and the conference costs the same amount of money to register this year than the live in person conferences.
- 6) We are utilizing help from two ESU 15 school psychologists to ease the load off our newly hired McCook school psychologist Kirstie Koch, who is doing a wonderful job in her first year with McCook. Tonya Olsen from ESU 15 covers St. Patrick's School, and Jessica Werkmeister from ESU 15 covers Central, while Kirstie covers the other district buildings. The arrangement is working out well and kids are getting the evaluations and services they need as a result of this cooperation.

**RESOLUTION AUTHORIZING THE ISSUANCE, SALE AND DELIVERY OF GENERAL OBLIGATION REFUNDING BONDS IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$1,875,000; PRESCRIBING THE FORM OF THE BONDS; FIXING IN PART AND PROVIDING FOR THE FIXING IN PART OF THE TERMS OF THE BONDS; PROVIDING FOR THE LEVY AND COLLECTION OF TAXES TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS; AND RELATED MATTERS.**

BE IT RESOLVED BY THE BOARD OF EDUCATION OF RED WILLOW COUNTY SCHOOL DISTRICT 0017, IN THE STATE OF NEBRASKA, as follows:

Section 1. The Board of Education (the “**Board**”) of Red Willow County School District 0017 (McCook Public Schools) in the State of Nebraska (the “**District**”), hereby finds and determines:

(a) The District is duly organized as a Class III School District under Sections 79-102 and 79-407, Reissue Revised Statutes of Nebraska, as amended, maintaining both elementary and high school grades under the direction of a single Board of Education, the District embracing territory having more than one thousand and less than one hundred fifty thousand inhabitants.

(b) The District has heretofore issued and there are now outstanding and unpaid the following valid interest-bearing obligations of the District:

General Obligation Refunding Bonds, Series 2012, date of original issue - December 6, 2012 in the outstanding principal amount of \$2,015,000, (the “**Outstanding Bonds**”), which mature and bear interest as follows:

such Outstanding Bonds being all of the \$4,555,000 original principal amount of General Obligation Refunding Bonds, Series 2012 issued pursuant to a resolution of the Board, and such Outstanding Bonds are redeemable at the option of the District at any time on or after December 6, 2017, at a redemption price equal to the principal amount thereof plus accrued interest to the date fixed for redemption.

(c) (i) All of the Outstanding Bonds are valid, interest-bearing obligations of the District; (ii) since the issuance of the Outstanding Bonds, the rates of interest available in the markets have declined so that the District can effect a savings in interest costs by providing for payment and

redemption of all or a portion of the Outstanding Bonds through the issuance of general obligation refunding bonds of the District; (iii) all or a portion of the Outstanding Bonds (as called for redemption, the “**Refunded Bonds**”) are herein authorized to be called for redemption; (iv) for the purpose of providing, along with other available District funds, for the payment and redemption of the Refunded Bonds as above set out and to pay costs of issuance thereof, it is in the best interest of the District to issue general obligation refunding bonds of the District, in the aggregate stated principal amount of not to exceed \$1,875,000; and (v) except as set forth herein, the District has no bond sinking funds on hand for the retirement of the Refunded Bonds not required for the timely payment of principal and interest due on the Redemption Date (as defined in **Section 2** hereof).

(d) Upon satisfaction of the terms and conditions set forth in **Section 2** hereof, it is necessary, desirable and advisable that the District issue its general obligation refunding bonds, for the purpose of providing funds which, together with other funds of the District legally available for such purposes, shall be sufficient for the payment and redemption of the Refunded Bonds on the Redemption Date.

(e) All conditions, acts and things required by law to exist or to be done precedent to the issuance of general obligation refunding bonds of the District in the principal amount of not to exceed \$1,875,000, for such purposes do exist and have been done in due form and time as required by law.

Section 2. (a) For the purpose of refunding the Refunded Bonds and paying the costs of issuing bonds as described herein, the issuance, sale and delivery of general obligation refunding bonds of the District is hereby authorized and directed in an aggregate stated principal amount not to exceed \$1,875,000 (the “**Bonds**”). The Bonds shall be sold pursuant to a negotiated sale with an underwriter (the “**Purchaser**”) as determined by an Authorized Officer (defined herein). The Bonds shall be issued in fully registered form in the denomination of \$5,000 or any integral multiple thereof, not exceeding the amount maturing in any one year, and shall be numbered from R-1 upward in the order of their issuance.

(b) The Superintendent or the Business Manager of the District or the President or Secretary of the Board of Education of the District (each, an “**Authorized Officer**”) is each individually hereby authorized and directed, in the exercise of his or her independent judgment and absolute discretion, to hereafter, from time to time, specify, set, designate, determine, establish and appoint, as the case may be, and in each case in accordance with and subject to the provisions of this Resolution, (1) the date of original issue of the Bonds, (2) the aggregate stated principal amount of Bonds to be issued (which shall not exceed \$1,875,000 in the aggregate, provided, however, in the event the Bonds are sold with a net original issue discount such aggregate principal amount may be increased in an amount necessary to compensate for any such net original issue discount), (3) any original issue premium or original issue discount properly allocable to each maturity of the Bonds, (4) the principal payment dates for the Bonds and the principal amount of Bonds to mature on each of such dates, (5) the date of final maturity of the Bonds, which shall in no event be later than December 31, 2025 (6) the date or dates upon which the Bonds shall be sold, (7) the rate or rates of interest to be carried by each maturity of the Bonds, provided the true interest cost of the bonds shall not exceed 1.75%, (8) the method by which such rate or rates of interest shall be calculated and the interest payment dates and record date for the Bonds, (9) whether or not the Bonds shall be subject to redemption prior to their stated maturity and, if subject to such prior redemption, (A) the provisions and procedures governing such prior redemption, (B) the nature of any notice to be given

in the event of any such prior redemption, (C) the redemption price or prices payable upon such redemption (not to exceed 104%) and (D) the respective periods in which each redemption price shall be payable, (10) the amount and due date of each sinking fund installment for Bonds that are term Bonds, (11) the Paying Agent and Registrar for the Bonds, (12) the underwriting discount, not to exceed 1.00% of the stated principal amount of the Bonds, and the price at which the Bonds shall be sold to the Purchaser and, (13) the form, contents, terms and provisions of the Bond Purchase Agreement and the Paying Agent and Registrar Agreement (each as hereinafter defined), (14) the form and contents of any closing and other documentation executed and delivered by the District in connection with the authorization, issuance, sale and delivery of the Bonds, (15) any transfer restrictions relating to the Bonds, and (16) all of the other terms of the Bonds not otherwise determined or fixed by the provisions of this Resolution.

(c) The Authorized Officers, or each individually, are hereby authorized to irrevocably call any or all of the Outstanding Bonds for redemption on such date he or she determines appropriate, which date or dates shall be the “**Redemption Date**” hereunder. The Authorized Officers, or each individually, are hereby authorized to designate, approve, execute and deliver, as the case may be, the form, content, terms and provisions of any published and/or mailed notice of redemption with respect to the payment and redemption of the Refunded Bonds, and direct the application of such proceeds and any investment income to the payment of all of the principal of and interest on the Refunded Bonds maturing on or before each respective Redemption Date and the application of the balance of such proceeds and any investment income thereof to the redemption and retirement of the Refunded Bonds on the Redemption Date.

(d) The Bonds shall be issued in fully registered form in the denomination of \$5,000 or any integral multiple thereof. The date of original issue for the Bonds shall be Date of Delivery. Interest on the Bonds, at the respective rates for each maturity, shall bear interest at the rates calculated on the basis of a 360-day year consisting of twelve 30-day months and shall be payable on such dates as shall be determined in the Designation (each an “**Interest Payment Date**”) and the Bonds shall bear such interest from the date of original issue or the most recent Interest Payment Date, whichever is later. The interest due on each Interest Payment Date shall be payable to the registered owners of record as of the fifteenth day immediately preceding the Interest Payment Date (the “**Record Date**”), subject to the provisions of Section 4 hereof. The Bonds shall be numbered from 1 upwards in the order of their issuance. No Bond shall be issued originally or upon transfer or partial redemption having more than one principal maturity. The initial bond numbering and principal amounts for each of the Bonds issued shall be as directed by the initial purchaser thereof. Payments of interest due on the Bonds prior to maturity shall be made by the Paying Agent and Registrar, as designated pursuant to Section 3 hereof, by mailing on each Interest Payment Date a check or draft in the amount due for such interest to the registered owner of each Bond, as of the Record Date for such Interest Payment Date, to such owner’s registered address as shown on the books of registration as required to be maintained in Section 3 hereof. Payments of principal and interest due at maturity or at any date fixed for redemption prior to maturity shall be made by said Paying Agent and Registrar to the registered owners upon presentation and surrender of the Bonds to said Paying Agent and Registrar. The District and said Paying Agent and Registrar may treat the registered owner of any Bond as the absolute owner of such Bond for the purpose of making payments thereon and for all other purposes and neither the District nor the Paying Agent and Registrar shall be affected by any notice or knowledge to the contrary, whether such Bond or any installment of interest due thereon shall be overdue or not. All payments on account of interest or principal made to the registered owner of any Bond in accordance with the terms of this resolution shall be valid and effectual and shall be a discharge of the District and said Paying Agent and Registrar, in respect of the liability upon the Bonds or claims for interest to the extent of the sum or sums so paid.

Section 3. The Authorized Officers, or one or more of them, shall designate the Treasurer of the District or a bank or trust company to serve as Paying Agent and Registrar for the Bonds. If a bank or trust company is designated as Paying Agent and Registrar for the Bonds, such entity shall serve in such capacities under the terms of an agreement entitled "Paying Agent and Registrar's Agreement" between the District and the Paying Agent, in a form which shall be approved by an Authorized Officer. The Paying Agent and Registrar shall keep and maintain for the District books for the registration and transfer of the Bonds at its office. The names and registered addresses of the registered owner or owners of the Bonds shall at all times be recorded in such books. Any Bond may be transferred pursuant to its provisions at the principal office of said Paying Agent and Registrar by surrender of such Bond for cancellation, accompanied by a written instrument of transfer, in form satisfactory to said Paying Agent and Registrar, duly executed by the registered owner in person or by such owner's duly authorized agent. In every case of transfer of a Bond, the surrendered Bond shall be canceled and destroyed. The District and said Paying Agent and Registrar shall not be required to transfer any Bond during any period from any Record Date until its immediately following Interest Payment Date or to transfer any Bond called for redemption for a period of 30 days next preceding the date fixed for redemption.

Section 4. In the event that payments of interest due on the Bonds on an Interest Payment Date are not timely made, such interest shall cease to be payable to the registered owners as of the Record Date for such Interest Payment Date and shall be payable to the registered owners of the Bonds as of a special date of record for payment of such defaulted interest as shall be designated by the Paying Agent and Registrar whenever monies for the purpose of paying such defaulted interest become available.

Section 5. The Bonds shall be subject to redemption, in whole or in part, prior to maturity at any time on or after the date determined in the Designation, at par plus the interest accrued on the principal amount being redeemed to the date fixed for redemption. In case of any Bond partially redeemed, such notice shall specify the portion of the principal amount of such Bond to be redeemed. No defect in the mailing of notice for any Bond shall affect the sufficiency of the proceedings of the District designating the Bonds called for redemption or the effectiveness of such call for Bonds for which notice by mail has been properly given and the District shall have the right to direct further notice of redemption for any such Bond for which defective notice has been given. In the event term maturities and mandatory redemption amounts are determined in the Designation, the provisions of this Section 5 shall apply generally to mandatory redemptions. Any such mandatory redemptions shall be at the principal amount redeemed plus accrued interest to the date set for redemption. The Paying Agent and Registrar shall select the term bonds to be redeemed in any maturity using any random method of selection deemed appropriate, subject to the provisions of Section 8 of this resolution.

Section 6. If the date for payment of the principal of or interest on the Bonds shall be a Saturday, Sunday, legal holiday or a day on which banking institutions in the Board of Education where the office of the Paying Agent and Registrar is located are authorized by law or executive order to close, then the date for such payment shall be the next succeeding day which is not a Saturday, Sunday, legal holiday or a day on which such banking institutions are authorized to close, and payment on such day shall have the same force and effect as if made on the nominal date of payment.

Section 8. Each of the Bonds shall be executed on behalf of the District with the manual or facsimile signatures of the President and Secretary of the Board of Education. The Bonds shall be issued initially as “book-entry-only” bonds using the services of The Depository Trust Company (the “**Depository**”), with one typewritten bond per maturity being issued to the Depository. In such connection said officers are authorized to execute and deliver a letter of representations (the “**Letter of Representations**”) in the form required by the Depository (including any blanket letter previously executed and delivered), for and on behalf of the District, which shall thereafter govern matters with respect to registration, transfer, payment and redemption of the Bonds. Upon the issuance of the Bonds as “book-entry-only” bonds, the following provisions shall apply:

(a) The District and the Paying Agent and Registrar shall have no responsibility or obligation to any broker-dealer, bank or other financial institution for which the Depository holds Bonds as securities depository (each, a “**Bond Participant**”) or to any person who is an actual purchaser of a Bond from a Bond Participant while the Bonds are in book-entry form (each, a “**Beneficial Owner**”) with respect to the following:

(i) the accuracy of the records of the Depository, any nominees of the Depository or any Bond Participant with respect to any ownership interest in the Bonds,

(ii) the delivery to any Bond Participant, any Beneficial Owner or any other person, other than the Depository, of any notice with respect to the Bonds, including any notice of redemption, or

(iii) the payment to any Bond Participant, any Beneficial Owner or any other person, other than the Depository, of any amount with respect to the Bonds. The Paying Agent and Registrar shall make payments with respect to the Bonds only to or upon the order of the Depository or its nominee, and all such payments shall be valid and effective fully to satisfy and discharge the obligations with respect to such Bonds to the extent of the sum or sums so paid. (b) Upon receipt by the Paying Agent and Registrar of written notice from the Depository to the effect that the Depository is unable or unwilling to discharge its responsibilities, the Paying Agent and Registrar shall issue, transfer and exchange Bonds requested by the Depository in appropriate amounts. Whenever the Depository requests the Paying Agent and Registrar to do so, the Paying Agent and Registrar will cooperate with the Depository in taking appropriate action after reasonable notice (i) to arrange, with the prior written consent of the District, for a substitute depository willing and able upon reasonable and customary terms to maintain custody of the Bonds or (ii) to make available Bonds registered in whatever name or names the Beneficial Owners transferring or exchanging such Bonds shall designate.

The District hereby covenants with the purchasers and holders of the Bonds herein authorized that it will make no use of the proceeds of said issue, including monies held in any sinking fund for the payment of principal and interest on said Bonds, which would cause said Bonds to be arbitrage bonds within the meaning of Sections 103 and 148 and other related sections of the Internal Revenue Code of 1986, as amended, (the "Code") and further covenants to comply with said Sections 103 and 148 and related sections and all applicable regulations thereunder throughout the term of said issue. The District hereby covenants and agrees to take all actions necessary under the Code to maintain the tax exempt status (as to taxpayers generally) of interest payable on the Bonds herein authorized, including execution of a Federal Tax Certificate to be dated the date of issuance of the Bonds.

Section 13. The District reserves the right to issue refunding bonds and provide for the investment of the proceeds thereof for purposes of providing for the payment of principal and interest on the Bonds in such manner as may be prescribed by law from time to time.

Section 14. The District's obligations under this resolution shall be fully discharged and satisfied as to the Bonds authorized and issued hereunder, and said Bonds shall no longer be deemed outstanding hereunder when payment of the principal thereof plus interest thereon to the date of maturity or redemption thereof (a) shall have been made or caused to have been made in accordance with the terms thereof and hereof, or (b) shall have been provided for by depositing with the Paying Agent and Registrar, or in escrow with a national or state bank having trust powers in trust solely for such payment (i) sufficient moneys to make such payment and/or (ii) direct general obligations of, or obligations the principal and interest of which are unconditionally guaranteed by, the United States of America, or obligations of any agency of the United States of America (herein referred to as "**Government Obligations**"), in such amount and with such maturities as to principal and interest as will insure the availability of sufficient moneys to make such payment, and thereupon such Bonds shall cease to draw interest from the date of their redemption or maturity and, except for the purposes of such payment, shall no longer be entitled to the benefits of this resolution; provided that, with respect to any Bonds called or to be called for redemption prior to the stated maturity thereof, notice of redemption shall have been duly given or provided for. Without in any way limiting the power, authority or discretion elsewhere herein granted or delegated, the Board hereby (a) authorizes and directs each Authorized Officer and all other officers, officials, employees and agents of the District to carry out or cause to be carried out, and to perform such obligations of the District and such other actions as they, or any of them, in consultation with bond counsel, the Purchaser of the Bonds and its or their counsel, shall consider necessary, advisable, desirable or appropriate in connection with this Resolution, any Preliminary Official Statement and any Official Statement and other offering materials of the District used in connection with issuance, sale and delivery of the Bonds, including without limitation and whenever appropriate the execution and delivery thereof and of all other related documents, instruments, certifications and opinions, and (b) delegates, authorizes and directs each Authorized Officer the right, power and authority to exercise her or his independent judgment and absolute discretion in (1) determining and finalizing all other terms and provisions to be carried by the Bonds not specifically set forth in this Resolution and (2) the taking of all actions and the making of all arrangements necessary, proper, appropriate, advisable or desirable in order to effectuate the issuance, sale and delivery of the Bonds. The execution and delivery by an Authorized Officer or by any such other officers, officials, employees or agents of the District of any such documents, instruments, certifications and opinions, or the

doing by them of any act in connection with any of the matters which are the subject of this Resolution, shall constitute conclusive evidence of both the District's and their approval of the terms, provisions and contents thereof and of all changes, modifications, amendments, revisions and alterations made therein and shall conclusively establish their absolute, unconditional and irrevocable authority with respect thereto from the District and the authorization, approval and ratification by the District of the documents, instruments, certifications and opinions so executed and the actions so taken.

Section 16. The District hereby (a) authorizes and directs that an Authorized Officer execute and deliver, on the date of issue of the Bonds, a continuing disclosure undertaking (the "**Continuing Disclosure Undertaking**") in such form as shall be satisfactory to the District and in compliance with Rule 15c2-12 of the Securities and Exchange Commission, and (b) covenants and agrees that it will comply with and carry out all of the provisions of the Continuing Disclosure Undertaking. Notwithstanding any other provision of this resolution, failure of the District to comply with the Continuing Disclosure Undertaking shall not be considered an event of default hereunder; however, any Participating Underwriter (as such term is defined in the Continuing Disclosure Undertaking) or any Beneficial Owner or any Registered Owner of a Bond (as such terms are defined in the Continuing Disclosure Undertaking) may take such actions as may be necessary and appropriate, including seeking mandamus or specific performance by court order, to cause the District to comply with its obligations under this section.

Section 17. The officers of the District, or any one or more of them, including, but not limited to the Authorized Officers, are hereby authorized to execute and deliver any and all certificates and documents and to take any and all actions determined appropriate in connection with the issuance and sale of the Bonds. All actions heretofore taken by an Authorized Officer and all other officers, officials, employees and agents of the District, including without limitation the expenditure of funds and the selection, appointment and employment of bond counsel and financial advisors and agents, in connection with issuance and sale of the Bonds, together with all other actions taken in connection with any of the matters which are the subject hereof, are in all respects authorized, adopted, specified, accepted, ratified, approved and confirmed.

Section 18. This resolution shall be in full force and effect from and after its adoption as provided by law.
